Opinion

We have audited the financial statements of American Federal Bank Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of American Federal Bank Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of American Federal Bank Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Note 1 - Description of Plan

The following brief description of the American Federal Bank Employee Stock Ownership Plan (“Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan operates as an employee stock ownership plan and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue code of 1986 (IRC), as amended and subject to the applicable provision of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees of American Federal Corporation (“Company”). The Plan is administered by ESOP Trustee Committee.

Eligibility

Employees are eligible to participate in the Plan if they have completed one year of service and are 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Union employees, leased employees and non-resident aliens are not eligible to participate in the Plan.

Entry Date

Employees may enter the Plan on the first day of January or July coinciding with or following the date they satisfy the Plan’s eligibility requirements.

Contributions

Contributions to the Plan are made annually by the Company at the discretion of its board of directors and are subject to certain Internal Revenue Code (“IRC”) limitations. Employees must have worked 1,000 hours during the Plan year and must be employed on the last day of the Plan year to be eligible to receive an allocation of contributions. Employee contributions are not allowed. In 2024, no discretionary contributions were made by the Company.

Participant Accounts

Each participant’s account is credited with allocations of the Company’s contributions, Plan earnings, and forfeitures of terminated participants’ non-vested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s earnings, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participant accounts are invested primarily in the common stock of American Federal Corporation. Participants are not allowed to direct how accounts are invested.

Terminated employees whose age plus years of participation in the Plan are equal to or greater than 65 may elect to have their accounts remain invested in common stock for three years after their termination.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Vesting

Vesting is based on years of continuous service. Participants follow graded vesting, in which they are 100% vested after six years of credited service.

Forfeitures

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. During the year ended December 31, 2024, forfeited non-vested accounts totaling \$3,533 were allocated to eligible participants.

Notes Receivable from Participants

The Plan does not allow participants to borrow from their fund accounts.

Payment of Benefits

Participants may elect to receive a lump-sum amount equal to the value of their vested interest as defined in the plan document upon retirement, termination of employment, death or disability. If a participant's termination of service is for a reason other than death, disability or retirement, distribution of the participant's balance shall be made no later than the sixth fiscal year following the Plan year in which the participant's employment is terminated. Participants with account balances less than \$1,000 may be paid out as soon as administratively feasible upon termination. A terminated participant with a balance between \$1,000 and \$5,000 may be automatically paid out by transferring the balance to a qualified Individual Retirement Account.

Distributions can be made in a single lump sum payment or in substantially equal annual installments over five years if the vested account balance is equal to or less than \$1,380,000. For vested balances over \$1,380,000, the Company may extend the payment out for an additional year over the five years for every \$275,000 over the \$1,380,000.

Distributions can be made in a single lump sum payment or in substantially equal annual installments over five years if the vested account balance is equal to or more than \$20,000. For vested balances below \$20,000, distributions can be made in a single lump sum payment.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants is not readily tradeable on an established market or is subject to trading limitations and includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the market value of the stock.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments which are more diversified. Participants who are at least age 55 with 10 years of participation in the plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify have the option to receive a cash distribution or rollover their balance into another qualified plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan Sponsor determined the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid by the Plan as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan sponsor has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market deposit accounts – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Common stock of American Federal Corporation – Valued at estimated fair value based on independent appraisal. The appraisal considers several factors including the financial condition, earning capacity, and dividend paying capacity of American Federal Corporation, as well as the general economic outlook and that of the banking industry. The appraisal also considers the market price of stocks of banks and savings banks similar to the Company that are actively traded on the open market.

As of December 31, 2024 and 2023, all of the 300,179 shares of the company stock are 100% allocated and the cost of the shares is \$381,185.

For the years ended December 31, 2024 and 2023, there were no purchases or sales in Level 3, nor any transfers in or out of Level 3.

Note 4 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated May 30, 2014, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to this issuance of the determination letter, the Plan was amended. However, the Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of common stock of American Federal Corporation and a money market account held at American Federal Bank, the Plan sponsor as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are related party and exempt party-in-interest transactions under ERISA.

Note 6 - Risks and Uncertainties

The Plan invests in the common stock of American Federal Corporation which is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with this stock, it is at least reasonably possible that changes in the values of the stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 - Right of First Refusal

Company stock that has been distributed to a participant and not immediately repurchased by the Company or Trust, may be subject to a right of first refusal if so determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company and then, if refused by the Company, to the Trust at fair market value as determined by an independent appraiser appointed by the ESOP Committee.

Note 8 - Dividends

Dividends paid during 2024 on the common stock of American Federal Corporation held by the Plan was \$259,279. Participants are not allowed to take a distribution of dividends from the Plan.
