Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DiamondBack Automotive Accessories, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of DiamondBack Automotive Accessories, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) plan covering all eligible employees of DiamondBack Automotive Accessories, Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees must have completed three months of service to be eligible to participate in the Plan. The Plan has no age requirements for employees to participate. Participants are able to enroll in the plan immediately upon meeting service requirement. Newly eligible participants are enrolled automatically at a deferral rate of 3% unless they opt-out or elect a different amount. Effective January 1, 2024, the Plan document was amended to adjust the determination period used to determine safe harbor matching contributions from each pay period to the plan year.

Contributions: Participants may elect to defer a portion of their eligible compensation, as defined by the Plan, up to the maximum dollar limit prescribed by the Internal Revenue Code (IRC). Amounts contributed to the Roth 401(k) will be subject to Federal income tax when made, but any earnings thereon will generally not be taxed upon distribution provided funds are not withdrawn within five years and other conditions are met. Participants age 50 or older may elect to defer additional "catch-up" amounts. Participants that do not opt-out or make an affirmative election are automatically enrolled at a deferral rate of 3% of eligible compensation, which will auto-escalate by 1% each plan year up to a maximum deferral of 6%.

Employer profit-sharing contributions are discretionary and determined annually by the Board of Directors. The Company makes a minimum safe harbor contribution equal to 100% of employee deferrals up to 3%, then 50% match up to 5% of employee deferrals. The Plan allows rollover contributions from other qualified plans. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain annual limitations as determined by the Internal Revenue Code.

Participant Investment Options: Participants direct the investment of their individual account balances into a variety of investment fund options. Participants may change their investment options as often as they like.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) employer matching contributions, (b) other discretionary employer contributions and (c) an allocation of Plan earnings or losses and charged with an allocation of administrative expenses. Participants must be employed on the last day of the Plan year to share in any annual employer discretionary contribution. The Plan's earnings or losses are allocated according to the participant's relative account balance in the various investment options. The benefit to which a participant is entitled is the vested benefit in the participant's account.

Participant Loans: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum loan equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan permits only one loan to be authorized at a time per participant. Effective July 31, 2023, loan terms may not exceed five years, previously four and a half years, unless taken out for the purchase of a primary residence. Interest rates on loans are fixed for the duration of the loan based on prime interest rate plus 1-percentage point. Loans must be repaid via payroll withholdings. Loans are secured by the vested balance in the participant's account.

Vesting: Participants are immediately vested in their account upon their effective date of participation.

Payment of Benefits: On termination of service, death, disability, or upon attaining age 59½, a participant may elect to receive their vested benefits, generally as a lump sum distribution. Distributions may be delayed until benefits are requested or age 72, at which date required minimum distributions must be paid to the participant. Vested account balances less than \$5,000 at the distribution date will be automatically rolled over to an IRA selected by the Plan Administrator unless the participant consents to a lump sum distribution or other distribution. Hardship withdrawals based on demonstrated need are also permitted on a limited basis.

Administrative Expenses: Expenses incurred for the administration of the Plan are paid either by the Plan or by the Plan Sponsor.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent loans are treated as distributions.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Current and Former Custodians

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary Schedule H, Item 4i, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Principal Trust Company (the Custodian of the Plan).

Note 4. Investments and Fair Value Measurements

The Plan measures, on a recurring basis, its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, which are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Cash: Interest bearing cash is valued daily based on the balance of funds held in the bank deposit account at closing, as reported by the financial institution. Interest earned is deposited as additional cash.

Collective Investment Trust: The Plan invests in Principal Life-Time Hybrid collective investment trust funds offered by Principal Global Investors Trust Company. The collective investment trust funds are valued based upon the net asset value (NAV) of units of the Trusts as reported to the Plan by the trusts. Units of the trusts are published daily and used as the basis for current transactions. The units of the CIT are valued daily based on closing market prices of the underlying investments. The daily unit value is computed by dividing the total assets of the trusts, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trusts and included in the determination of unit values. The collective investment trust funds provide for daily redemptions by the Plan at reported NAV, with no advance notice requirements.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

Note 5. Related Party and Party-in-Interest Transactions

Plan investments held at December 31, 2024 and 2023, include investments managed by Principal Trust Company. Principal Trust Company is the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

Effective July 31, 2023, the Plan a non-standardized pre-approved plan sponsored by Dunbar Bender & Zapf Inc. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the pre-approved plan as then designed, was in compliance with the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended subsequently, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
