Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Limestone University Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1—Description of the Plan

The following brief description of the Limestone University Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a combined plan, consisting of a defined contribution retirement plan and a tax deferred annuity plan, established by Limestone University (the “University”) on September 1, 1963, and was last amended effective March 14, 2023 for a change in matching contributions. The Plan covers all employees of the University, except students enrolled and attending classes offered by the University, nonresident aliens receiving no earned income from within the United States, and employees who normally work fewer than 20 hours per week. The Plan provides employer matching to all employees covered by the Plan over the age of 18, except adjunct professors and members of a collective bargaining unit that have negotiated exclusion from coverage as part of the negotiated agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the University, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The University has designated certain employees to administer the Plan.

Contributions – Participants may contribute pre-tax annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. Once eligible, participants may also contribute amounts representing distributions from other qualified retirement plans, 403(b) tax sheltered annuity plans, government 457(b) plans, and traditional IRAs. Unless the employee is part of an excluded class of employees noted above, employees must complete one day of service with the University before the employee is eligible to receive contributions made by the University. For the year ended December 31, 2024, the University contributed an amount equal to 100% of the participant’s contribution up to 4% of the participant’s salary. Mandatory employee contributions are not required as defined by the Plan.

There is no year of service requirement for an employee to defer a portion of their compensation as a pre-tax deferral. The day of service requirement listed above, however, will apply to pre-tax deferrals only if the participant can defer pre-tax or Roth deferrals into another plan maintained by the University that does not have age or service requirements. Participants direct the investments of their contributions into various investment options offered by the Plan.

Catch-Up Contributions – If a participant is eligible to make deferrals and turns 50 before the end of any calendar year, the participant may defer an additional \$7,500 into the Plan as a pre-tax contribution subject to certain IRC limitations. If a participant has worked at least 15 years for the University, the participant may make a special catch-up contribution equal to the smallest of the three amounts listed: 1) \$3,000; 2) \$15,000 minus the amount of special catch-up contributions made in the prior years; and 3) \$5,000 times the number of years the participant has worked for the University minus the total amount of deferrals made while the participant worked for the University. Catch-up contributions are eligible for matching contributions made by the University. If a participant qualifies for both types of catch-up deferrals, the contributions will be allocated first as special catch-up contributions.

Participant Accounts – Each participant’s account is credited with the participant contributions, University contributions, an allocation of Plan earnings and charged with an allocation of Plan losses, and an allocation of administrative and investment expenses not paid by the University. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting Requirements – Participants are immediately fully vested in their voluntary contributions, including catch-up and special catch-up contributions, rollover contributions from other plans, University contributions, and earnings thereon.

Note 1—Description of the Plan (continued)

Investment Options – Upon enrollment in the Plan, a participant may direct 100% of their allocation of contributions with the College Retirement Equities Fund (“CREF”) and Teachers Insurance and Annuity Association of America (“TIAA”), (the “Qualified Institutions”). Within CREF and TIAA, participants may select between several investment options. Participants may transfer balances periodically based on the applicable funds as defined in the custodial service agreement.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000. The maximum note receivable allowed under the Plan is equal to 50% of their vested account balance under the Plan or \$50,000, reduced by the excess of the other outstanding balances of notes from the Plan. The notes are permitted for specific purposes as stated in the Plan document and terms range from one to five years unless such loan is used to acquire a dwelling unit which will be used as the principal residence of the participant. The notes are secured by the vested interest in the participant’s account. The notes bear interest of 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions each payroll period.

Plan Loans – Participants may borrow against the funds held by CREF and TIAA a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant’s account, financed through CREF and TIAA, and bear interest rates of 4.22% to 6.20% with maturities through September 2025. As the loans do not reduce the Plan assets, outstanding loan amounts are not included in the statements of net assets available for benefits. Principal and interest are paid through an automatic draft of the participant’s checking account or billed to the participant by the Qualified Institutions. Plan loans outstanding amounted to \$3,335 and \$14,225 as of December 31, 2024 and 2023, respectively.

Benefits Paid to Participants – Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, partial or installment payments, or an annuity. For termination of service for other reasons, distribution of the value of the participant’s vested interest in his or her account will begin as soon as possible after the participant’s request. Participants may take a hardship distribution from the deferrals they have contributed to the Plan for certain qualifying expenses as defined by the Plan document, and within what the Internal Revenue Service (“IRS”) deems an immediate financial need of the participant.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan reports investments at fair value, apart from fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts held by a defined-contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2—Summary of significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect the amounts reported in the statements of net assets available for benefits.

Benefits Paid to Participants – Benefits paid to participants are recorded when paid.

Administration Expenses – Except as discussed in Note 6, Plan administration expenses are paid by the University.

Reclassifications – Certain reclassifications have been made to the December 31, 2023 statement of net assets available for benefits presentation to correspond to the current year's format. Total net assets available for benefits was unchanged due to these reclassifications.

Note 3—Fair value measurements

The Plan follows the *Fair Value Measurements and Disclosures* topic of the Financial Accounting Standards Board Accounting Standards Codification which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 or 2023.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 3—Fair value measurements (continued)

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and, therefore, considered to be readily determinable and classified within Level 1 of the valuation hierarchy.

Pooled Separate Account (“Real Estate Fund” or “REF”) – These assets are not available in an exchange or an active market; however, the fair value is determined based on NAV of the underlying assets as traded in an exchange or active market. The Real Estate Fund generally invests in real estate properties and real estate related investments. The value of the fund is principally derived from the market value of the underlying real estate holdings or other real estate related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional’s opinion. The fund sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day. Although the underlying assets of the REF cannot be quickly sold and converted to liquid assets, TIAA provides the REF with a liquidity guarantee to ensure funds are available to meet participant redemption, transfer, or cash withdrawal requests executed at quoted unit value. Based on this liquidity guarantee, the REF is classified within Level 1 of the valuation hierarchy.

Guaranteed Investment Contract (Non-Fully Benefit-Responsive Contract) – This investment is a guaranteed fixed income annuity backed by TIAA’s claims paying ability whereby the annuity guarantees principal and a minimum interest rate, plus opportunity for additional amounts in excess of the guaranteed rate. The annuity contract is not traded and significant other observable inputs are not available. This contract is reported at fair value and is classified within Level 3 of the valuation hierarchy.

** The significant unobservable inputs used in the fair value measurement of the Plan's guaranteed investment contract are prepayment rates, probability of default, and loss severity in the event of default. Significant increases (decreases) in any of those inputs in isolation would result in a significantly lower (higher) fair value measurement. Generally, a change in the assumption used for the probability of default is accompanied by a directionally similar change in the assumption used for the loss severity and a directionally opposite change in the assumption used for prepayment rates.

Note 4—Investment contracts with insurance company

The Plan invests in guaranteed fixed annuity contracts with TIAA. The fully benefit-responsive annuity contract held by the Plan includes the Group Supplemental Retirement Annuity (“GSRA”) account. Non-fully benefit-responsive annuity contracts held by the Plan include the Retirement Annuity account. TIAA maintains the contributions in the TIAA General Account. TIAA groups the premium dollars it receives over defined time periods into vintages, typically composed of one or more contiguous calendar months, for the purpose of determining the crediting rate to participants’ accounts. The crediting rate for each vintage is determined, in part, by the net investment earnings rate of the TIAA assets supporting that vintage, minus a charge for administrative expenses and an amount set aside for contingency reserves. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, which approximates fair value. Guaranteed investment contracts are valued at fair value provided by TIAA which approximates contract value when applicable.

Certain events limit the Plan’s ability to transact at contract value with TIAA. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5—Information prepared and certified by the Qualified Institutions (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Qualified Institutions, at December 31, 2024 and 2023, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, fully benefit-responsive guaranteed investment contract, at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value and contract value of investments, interest and dividend income, other income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 6—Party-in-interest transactions

Plan investments are shares of mutual funds, a pooled separate account, and guaranteed investment contracts managed by CREF and TIAA as of December 31, 2024 and 2023 and for the year ended December 31, 2024; therefore, these investments and transactions qualify as party-in-interest transactions.

Note 6—Party-in-interest transactions (continued)

Fees paid by the Plan for the investment management services of CREF and TIAA, as well as Plan loan fees, amounted to \$154,306 for the year ended December 31, 2024, which are included as part of net appreciation in fair value of investments within the statement of changes in net assets available for benefits. In addition, notes receivable from participants and Plan loans qualify as party-in-interest transactions.

Note 7—Tax status

The Plan adopted a Volume Submitter 403(b) Plan which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on August 7, 2017, which stated that the Plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself. However, the Plan Sponsor believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan qualifies under Section 403(b) and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Plan termination

As described in Note 9, the University voted to cease operations on April 29, 2025, at which point it also ceased all matching contributions in the Plan. As such, the Plan will be discontinued at a future date. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant’s respective account at the effective date of such termination. Distribution of participant account balances will occur as soon as administratively feasible upon termination of the Plan.

Note 9—Subsequent events

The University has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

The University Board of Trustees voted to cease University operations, and thus Plan matching contributions, with an effective date of April 29, 2025. There is no impact to the Plan for the year ended December 31, 2024 as a result of this decision. Through the date of this report, the Plan Administrator continues to work on the final plan termination process, which will follow what is described in Note 8.
