## INDEPENDENT AUDITORS' REPORT

### **Opinion**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### NOTE 1 – DESCRIPTION OF THE PLAN

**General** – The Midstate Bancorp Employee Stock Ownership Plan (the Plan) became effective as of January 1, 2006. The following description provides only general information and participants should refer to the Plan Agreement for more complete information.

The Plan purchased Midstate Bancorp, Inc. (the Company or Sponsor) common shares from the sponsoring company or its stockholders and holds the stock in a trust established under the Plan.

The Plan is a defined contribution plan and is subject of the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is designed to invest primarily in Company stock.

**Eligibility** – The Plan covers full-time employees of the Company. Employees are eligible to participate in the Plan for purposes of employer's contributions, effective the January 1st after they have completed six months of service and have attained age 20.5. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

**Contributions** – The Company will make contributions, on a discretionary basis, to the Plan as defined in the Plan Agreement. During 2024 and 2023, the Company agreed to make contributions of \$360,000. These contributions are allocated directly to the participants' accounts. Contributions from employees are prohibited.

**Investment Allocation** – All gains, earnings, and losses are credited or debited to each participant's account based on the ratio of each participant's beginning of year account balance to all participants beginning of year account balance.

**Participant Accounts** – The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation.

**Vesting** – Vesting in the employer contributions is based on years of continuous service. Vesting begins after 2 years of service and a participant becomes 100% vested in employer contributions upon six years of continued service or upon the participant's death, disability or retirement. The nonvested balance is forfeited upon distribution of the vested balance or five years after termination. Forfeitures may be used to reduce employer contributions in the year following the plan year in which the forfeitures occur.

**Payments of Benefits** – The Plan provides for three payment options associated with the distribution of benefits: 1) lump-sum, 2) transfer of benefits to another qualified retirement plan and 3) periodic installments as defined in the Plan Agreement.

In the case of death, disability or retirement, benefits become payable as soon as administratively feasible. The Plan provides for several distribution requirements for participants who terminate for reasons other than death, disability, or retirement. For those whose vested balances are under \$5,000, a single lump-sum distribution of the entire vested account balance is mandatory.

#### NOTE 1 – DESCRIPTION OF THE PLAN (continued)

**Payments of Benefits (continued)** – If the vested account balance is greater than \$5,000, the participant may choose any combination of the following: single lump sum payment or installment payments over a period of years as allowed under the Internal Revenue Code. Distributions are made in cash or in the form of Company common shares plus cash for any fractional share. Undistributed benefits (not including amounts to be forfeited) to participants who have been terminated but not paid as of each year end were approximately \$487,000 and \$527,000 as of December 31, 2024 and 2023, respectively.

**Voting Right** – The Trustee shall vote all Company common shares held by it as part of the Plan assets at such time that such rights are to be exercised. Notwithstanding the foregoing, if the Sponsor has a registration-type class of securities each participant shall be entitled to direct the Trustee as to the manner in which the Company common shares is entitled to vote and is allocated to the account the participant.

**Put Option** – Under Federal income tax regulations, the Company common shares that are held by the Plan and its participants and are not readily tradable on an established market, or are subject to trading limitations, include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Directed Investment Account** – Participants close to retirement may have the opportunity to move part of the value of their investment in Company common shares into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive cash or a stock distribution subject to the put option described above.

**Forfeitures** – Forfeitures arising from participants with less than a fully vested interest in the Plan may be used to reduce employer contributions in the plan year in which the forfeitures are determined to occur. During 2024 and 2023, forfeitures approximated \$11,300 and \$0, respectively, and may be used to reduce employer contributions in the future. Forfeitures are allocated to participant accounts on the same basis as employer contributions, that is based on the relationship of eligible compensation to total compensation. Included in net assets available for plan benefits as of December 31, 2024 and 2023 is approximately \$9,000 and \$17,400, respectively, of unvested benefits for employees that have terminated employment with the Sponsor.

**Administrative Expenses** – All administrative expenses, which include monthly administrative fees, distribution fees, loan application processing fees, and management fees, are deducted directly from the participant's account.

**Termination of the Plan** – While the Company has not expressed any intent to discontinue the Plan, it may, by action of the Board of Directors, terminate the Plan. In the event the Plan is terminated, the participants become fully vested in their accounts.

#### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America and in accordance with the Plan Agreement. A summary of significant accounting policies applied in the preparation of the accompanying financial statements follows.

**Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.

**Investments** – An independent appraiser evaluates the Plan's Sponsor's financial condition and evaluates the industry the Sponsor operates in. After the evaluation is complete, an estimate is made of the fair market value of the stock held by the Plan as an investment. Because of inherent uncertainties in estimating this value, it is at least reasonably possible that the appraiser's estimate of value will change in the near term. The realization of this asset is contingent on the operating results of the Sponsor, or the sale of the common stock to a third party.

Dividend income is accrued on the ex-dividend date.

**Cash and Cash Equivalents** – The Plan at times has cash in excess of federally insured limits. The Plan's management evaluates the financial condition of the bank and believes that there is no risk associated with its deposit balances.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Income Taxes** – Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021. The Plan's IRS Forms 5500 for 2021 to 2024 are available to be subject to audit by the Internal Revenue Service.

#### NOTE 3 – ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of Sponsor Company common shares, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

#### NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for plan benefits. The following tables present fair value measurement information for certain financial instruments. The carrying values of receivables and cash and cash equivalents included in the accompanying statement of net assets available for plan benefits approximated fair value at December 31, 2024 and 2023 and are thus not included in the following table.

#### NOTE 6 – INCOME TAX STATUS

The Plan obtained its latest determination letter on February 22, 2010, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan was amended and restated effective January 1, 2019 and was submitted to the Internal Revenue Service. The Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### NOTE 7 – PARTIES-IN-INTEREST

Parties-in-interest are defined under the Department of Labor Regulations as any Fiduciary of the Plan, parties rendering services to the Plan, including auditors, the employer and certain others. As such, transactions conducted by the Custodian qualify as party-in-interest transactions. The Plan incurs expenses related to general administration and record keeping. The Plan pays these expenses and certain fees related to the Plan.

The Plan had significant transactions during 2024 and 2023 with parties-in-interest. The transactions are summarized as follows:
