INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
IR Labs DE, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the IR Labs DE, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the IR Labs DE, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of IR Labs DE, LLC (the Company or Plan Administrator) who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Prior to May 15, 2024, the Plan was known as Innovation Refunds 401(k) Plan.

Plan Administration

The Company has contracted with Principal Trust Company and Principal Life Insurance Company (collectively, Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

Contributions

Each year, participants may contribute a percentage of their eligible compensation as defined in the Plan agreement, subject to certain limitations established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company matching contributions are equal to 100% of employee contributions up to 4% of compensation. Contributions are subject to certain IRS limitations.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily. Each participant's account is increased or decreased by the participant's contributions, withdrawals, an allocation of Plan earnings (losses), net of administrative expenses, and an allocation of the Company's contributions. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals and the Company's contributions plus earnings thereon. During 2023 and 2024, the Company had a reduction of workforce greater than 20%. Based on Department of Labor (DOL) regulations, the Plan was considered partially terminated. All impacted participants were fully vested in their account balance at the time of their separation.

NOTE 1 — DESCRIPTION OF THE PLAN (Continued)

Notes Receivable, Participants

Participants are permitted to borrow from their fund accounts a minimum of \$500 up to a maximum of 50% of their account balance or \$50,000, whichever is less. The loans are secured by the balances in the participant's account and bear interest rates commensurate with local prevailing rates. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Participants may withdraw account balances related to their elective contributions, rollover contributions, and Company contributions at any time. A participant may withdraw a portion of his or her vested interest upon attaining age 59 ½ while still employed by the Company. Normal retirement is at age 65. In addition, hardship distributions are permitted if certain criteria are met.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments, other than investments in fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investments held in Principal Fixed Income Guaranteed Option (PFIGO) are reported separately at contract value within net assets available for benefits, as this investment is considered to be fully benefit-responsive (See Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable, Participants

Loans to participants are reported at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Because participant notes receivable are 100% collateralized by the participants' vested account balances, no allowance for credit losses is deemed necessary. Participant notes receivable that are in default, including outstanding balances due upon termination, are taxed to the borrower and accounted for as a deemed distribution.

Contributions

Contributions from the Plan participants and the Company matching contributions are recorded in the year in which the participant contributions are withheld from their compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participants are responsible for certain transaction-related expenses, and administrative service fees. Certain investment-related expenses are included as a reduction of net appreciation in fair value of investments.

NOTE 3 — CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements, Note 4, and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023 and dividends and net appreciation in fair value of investments for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal.

NOTE 4 — FAIR VALUE MEASUREMENTS

GAAP established a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority):

- Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data.
- Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on quoted prices of identical assets in active markets.

Common/collective trusts: Quoted redemption values, also known as net asset value (NAV), are determined by Principal using available market information and appropriate valuation methods, as provided by Principal, and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. This is considered a readily determinable fair value. There are no imposed redemption restrictions on participants.

Pooled separate accounts: The fair value of units held in pooled separate accounts are valued based at NAV as determined by the insurer and are primarily based on quoted market prices for the underlying securities or similar instruments. Pooled separate accounts have readily determinable fair value and, therefore, are included in the fair value table below. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within 30 days.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

PFIGO is a fully benefit-responsive group annuity contract issued by Principal with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract.

Under the terms of the existing contract, the composite crediting rate is currently reset on a semiannual basis. The key factors that influence future interest crediting rates for the investments include the level of market interest rates; the amount and timing of participant contributions, withdrawals, and transfers into or out of the fund; the investment returns generated by the investments; and the duration of the investments.

PFIGO has a guarantee backed by the assets in the general account of Principal. Benefit payments are made at contract value, with no market value adjustments or surrender charge adjustments for Plan benefit events, including retirement, death, disability, termination, loans, withdrawals, or Plan termination. A Company-level liquidation or Company-initiated transfer of the Plan's interest in PFIGO will be subject to either a 12-month irrevocable advance notice or a 5% surrender charge, whichever the Plan would choose at the termination event. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. Plan management believes that the occurrence of an event that would cause the fund to transact at less than contract value is not probable.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units in pooled separate accounts and common collective trusts administered by Principal. Additionally, PFIGO is administered by Principal. In addition, as described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 7 — PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the agreement.

NOTE 8 — INCOME TAX STATUS

The Plan's nonstandardized prototype plan document has received an opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan was acceptable under Section 401(a) of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not applied for a separate determination letter from the IRS; however, the Plan Administrator believes that the Plan is currently designed, and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 — PROHIBITED TRANSACTIONS

During the year ended December 31, 2023, the Company inadvertently failed to deposit participant deferrals and loan payments of \$405,015 within the required timeframe as stated by the DOL. The DOL considers late deposits to be prohibited transactions. The Company intends to make deposits into the Plan for lost earnings attributable to the delinquent contributions and loan payments to fully correct the prohibited transactions.
