We have performed audits of the financial statements of Southern New Hampshire Services, Inc. Employer Sponsored 403(b) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1. Description of the Plan**

The following description of Southern New Hampshire Services, Inc. Employer Sponsored 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established to provide substantially all employees of Southern New Hampshire Services, Inc. (the "Organization") with retirement benefits in accordance with 403(b) of the Internal Revenue Code ("IRC"). The Plan was originally established on June 1, 1979 and was most recently amended and restated effective January 1, 2021. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA"). Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively referred as "Empower") is the trustee of the Plan and serves as Plan custodian.

***Eligibility***

All employees of the Organization (except non-resident aliens, employees who normally work less than 20 hours per week, and student employees, as defined) are eligible to participate in the Plan. There are no minimum age or service requirements to make Salary Deferrals. Enrollment dates are the first day of each month coinciding with or following the date the requirements are met.

***Participant Contributions***

Eligible participants may make voluntary contributions through salary reductions up to 100% of their eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC. Further, participants who are 50 years of age or older as of the end of the year, may contribute an additional "catch up" contribution. The Plan also allows rollover contributions from other qualified plans as defined in the Plan Document. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a fully benefit-responsive investment contract as investment options for participants.

The Plan also allows participants to defer funds into a "Roth deferral". These deferrals are subject to federal income taxes, and the maximum allowable combined contributions of the Roth and pre-tax deferrals up to IRC limit.

***Employer Contributions***

The Plan provides for discretionary matching contributions for all employees who are contributing to the Plan and have completed one year and 1,000 hours of service. For the years ended December 31, 2024 and 2023, the discretionary matching contribution was equal to 10% of eligible compensation of each participant who met the aforementioned criteria.

***Participant Investment Account Options***

Each participant has the option of directing contributions into any of the investment account options selected by the Sponsor and may change the allocation to the extent permitted by the individual agreements.

***Participants' Accounts***

Each participant's account is credited with the participant's contributions, employer discretionary contributions and allocations of Plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses paid by the Plan. Allocations of employer contributions, investment income and administrative expenses are based on participants' account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

***Vesting***

Participants are immediately vested in both their elective contributions and discretionary employer contributions, and actual earnings thereon.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance up to a maximum of \$50,000. The minimum loan amount is \$1,000. Participant loans are subject to approval by the plan administrator at interest rates set at the Prime rate. Loan terms range from one to five years. However, the term may be extended up to 15 years if the loan was made for the purpose of acquiring the primary residence of the participant. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of employment, retirement, death, or disability, a participant or a participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, installments, or as partial withdrawals. Further, withdrawals from the Plan before leaving the Organization are available for special "hardship" reasons (as defined) or after attaining the age of 59 ½. Distributions to participants are recorded when paid. Upon termination of employment, the Plan may distribute the vested portion of the account if it is \$5,000 or less without requiring consent of the participant.

***Other Income***

Certain mutual fund expenses that are charged by the mutual fund companies to the individual participants are recaptured by the Plan and held in a cash reserve account. These funds are then used to pay for expenses of the Plan that benefit the Plan participants, approved by the Internal Revenue Services ("IRS"), Department of Labor ("DOL") and ERISA, such as administration and auditing fees. As of December 31, 2024 and 2023, there were no balances in this account. During the year ended December 31, 2024, \$54,696 was recaptured and utilized to pay for expenses of the Plan. The amount is included as other income in the accompanying statement of changes in net assets available for benefits.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are stated at contract value (see Note 8). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

The Organization may, at its discretion, pay the expenses incident to administering the Plan. In the event that the Organization does not pay Plan expenses, the expenses shall be paid by the Plan.

***Subsequent Events***

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Tax Status**

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and trust document sponsored by Empower. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 6. Parties-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such person.

Certain Plan investments are shares of mutual funds managed by Empower. Empower is the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$153,159 of recordkeeping fees to Empower during the year ended December 31, 2024. The Plan provides certain administrative services at no cost to the Plan.

**Note 7. Risks and Uncertainties**

The Plan provides for various investment options in accounts that invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 8. Fully Benefit-Responsive Investment Contract**

The Plan entered into a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Sponsor or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 9. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.
