**NOTE 1: PLAN DESCRIPTION**

**General** - The Ivar's, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is a defined contribution pension plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers employees of Ivar's, Inc. and KV Holdings, Inc. (collectively, the Employers). This description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Eligibility** - Employees generally become eligible to participate upon completion of eleven months of service and attaining the age of 21.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts plus earnings thereon is based upon years of service as follows:

<u>Years of service completed</u>	<u>Vested percentage</u>
1	25%
2	50
3	75
4	100

**Contributions** - Participants may make voluntary contributions to the Plan of the lesser of a percentage of such participant's compensation for the Plan year as the Administrative Committee determines from time to time or the dollar limit set by law for a contribution period. Participants may direct their contributions into a variety of funds as determined by the Plan and employee contributions are deposited to the Plan with each pay period. Investment allocations may be changed by the participant at any time.

For 2024 and 2023, discretionary employer matching contributions for all active participants employed on the last day of the Plan year equal 50% of the participant's contributions and up to \$1,250. Employer matching contributions are generally funded once per year. Employer profit sharing contributions, if any, are determined at the discretion of the Employers. Employer contributions are allocated to investments at the discretion of the participant.

Each participant's account is credited with the participant's contribution and an allocation of Employers' contributions, Plan earnings, and investment gains or losses. Such allocations are based on participant earnings, account balances, or the ratio that each participant's compensation bears to total eligible compensation as defined in the Plan agreement.

## **NOTE 1: Continued**

**Benefits** - Payments of Plan benefits are made in lump-sum distributions to or on behalf of the participant. Benefits, which are comprised of the vested balance of a participant's account, are generally payable upon termination of employment, death, and permanent disability. Partial in-service withdrawals may be made at the request of the participant at age 59-1/2 or in limited cases of hardship. Participants who terminate during the year may allow their accounts to remain in the Plan, unless the balance is \$5,000 or less, in which case a distribution will be made.

**Plan termination** - Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, each participant's account will be fully vested, nonforfeitable, and distributed to the participant after the effective date of the termination.

**Application of forfeitures** - Any forfeitures that may arise under the Plan shall be applied to reduce employer contributions under the Plan. Total unapplied forfeitures were \$58,762 and \$28,679 at December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, the Plan used no forfeitures to reduce the employer match when it was funded.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Investments** - Investments are stated at fair value based on the closing market prices at year end. Investments in the money market fund and mutual funds are valued at the final published sales price on the last business day of the year. Net unrealized gains and losses are calculated as the net change in fair value of investments from the beginning of the plan year or purchase date (whichever is later) to the end of the Plan year. Realized and unrealized gains and losses are combined and reported as net appreciation or depreciation in the fair value of investments.

**Notes receivable from participants** - Subject to certain restrictions, participants may receive loans from the Plan. Participant loans carry interest at the prime rate in effect at loan inception plus 1%, are secured by the related account balances, and have maturities not to exceed five years, unless the loan is for the purchase of the participant's principal residence, in which case the maturity cannot exceed ten years. Principal and interest are paid ratably through bi-weekly payroll deductions. The notes receivable are presented at the unpaid principal balance. No allowance for credit losses is recorded due to adequate collateral.

**Payment of benefits** - Benefits are recognized when paid.

**Administrative expenses** - Substantially all administrative expenses of the Plan are paid by the Plan and allocated among the participants' accounts accordingly.

**Use of estimates** - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### NOTE 3: FAIR VALUE OF INVESTMENTS

Fair value is a market-based measurement, determined based on assumptions that market participants would use in pricing an asset or liability. Under generally accepted accounting principles, there are three levels of inputs, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The inputs or methodology used for valuing investments is not necessarily an indication of the risk associated with investing in those securities.

As of December 31, 2024 and 2023, the fair value of mutual funds and money market fund was determined using quoted market prices, which are Level 1 inputs.

#### **NOTE 4: UNAUDITED INFORMATION CERTIFIED BY TRUSTEE**

The Plan's management has obtained certification from the Trustee, Fidelity Management Trust Company, that the following information furnished by the trustee and included in the Plan's financial statements and supplemental schedule of Assets (Held at End of Year) is complete and accurate:

1. Fair value of investments as of December 31, 2024 and 2023.
2. Balance of notes receivable from participants as of December 31, 2024 and 2023, and earnings thereon.
3. Investment transactions, including earnings and losses, for the years 2024 and 2023.

#### **NOTE 5: FEDERAL INCOME TAXES**

The Plan trustees adopted a Fidelity Investments prototype plan on January 6, 2022. It is the intent of the prototype plan to be exempt from federal income taxes. A determination letter dated June 30, 2020 from the Internal Revenue Service has been obtained by the prototype plan sponsor. The plan administrator and the Plan's tax counsel believe that the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **NOTE 6: PARTY-IN-INTEREST TRANSACTIONS**

Fidelity Management Trust Company ("FMTC") acts as custodian and trustee for certain investments of the Plan. Therefore, transactions with FMTC qualify as party-in-interest transactions.

#### **NOTE 7: RECONCILIATION TO FORM 5500**

In accordance with U.S. generally accepted accounting principles, the Plan accrues employee and employer contributions receivable, and accrues excess contributions, if any, to be returned to participants, for financial reporting purposes. Department of Labor regulations require a reconciliation of amounts reported on the Form 5500 to the financial statements. The following is a reconciliation of net assets available for benefits and the net increase in net assets available for benefits for the years ended December 31, 2024 and 2023.
