Profit Sharing and 401(k) Plan ("the Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of Plan**

The following description of Koki Holdings America Ltd. Profit Sharing and 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution 401(k) Plan established effective April 1, 1986 by Koki Holdings America Ltd. (the “Company,” “Sponsor,” or “Employer”) to provide retirement benefits to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All employees other than union employees and non-resident aliens may participate in the Plan, as well as employer profit-sharing and discretionary matching contributions on the first day of each calendar quarter after completing three months of service, as defined, with no minimum age requirement. Voya Retirement Insurance and Annuity Company (“Voya”) serves as Plan custodian.

***Contributions***

Each year participants may contribute up to the maximum allowed by law, as defined in the Plan document, subject to Internal Revenue Code (“IRC”) limitations. Participants are automatically enrolled at a deferral percentage of 6% of compensation upon eligibility with a 2% annual increase to a maximum of 14% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

The Company contributes a profit-sharing contribution to the Plan equal to 2% of compensation for all eligible participants. The Company may also contribute an additional discretionary matching contribution of 50% of each participant’s contribution, up to a maximum of 6% of the participant’s compensation contributed to the Plan. Contributions related to profit-sharing and the discretionary match for the year ended December 31, 2024, were approximately \$804,000. Both contributions are included in Employer contributions in the statement of changes in net assets available for benefits. Contributions are subject to certain limitations.

***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds, a common collective trust fund, a guaranteed investment contract (“GIC”), and a money market fund as investment options for participants.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s profit sharing and discretionary matching contributions, and plan earnings, and charged with benefit payments, fees for participant-initiated transactions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts, plus actual earnings thereon, is based on years of service. In the event of death or disability, a participant will become fully vested.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount or partial withdrawal. Annuity payments are not allowed. The Plan does allow for rollover distributions and hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$56,000 and \$34,000, respectively. These accounts will be used to pay Plan expenses or reduce future Company contributions. During 2024, forfeitures of approximately \$93,000 were used to reduce Company contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions from the Employer are recorded in the year in which participant compensation is earned.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

**Note 3. Fair Value Measurements**

Fair value as defined under U.S. GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the fair value valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual funds and money market funds***

Mutual funds and money market funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded. As such, these assets are classified within Level 1 of the valuation hierarchy.

***Guaranteed investment contract***

The fair value of the non-benefit-responsive GIC is estimated by Voya. Disclosure of unobservable inputs to the fair value measurement have not been included for the GIC because quantitative unobservable inputs are not developed by the Plan when measuring fair value and have not been made available to the Plan by Voya. Due to the significant unobservable inputs, the GIC is classified within Level 3 of the valuation hierarchy.

***Common collective trust***

The Plan invests in a collective investment trust for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value ("NAV") provided by the Qualified Institution as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The collective investment trust is not required to be classified within a level on the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments are funds managed by Voya. Voya is the Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Except to the extent paid by the Company in its sole discretion, fees to operate the Plan are charged to participants. Fees paid to the Custodian for administrative expenses were approximately \$26,000 for the year ended December 31, 2024.

**Note 6. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the prototype plan agreement was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer’s general assets, but no later than the 15th business day of the month following the month in which participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$10,686 and \$216,552 were not remitted within the required time period for the years ended December 31, 2024 and 2023.

**Note 9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.
