Basis for Opinion

NOTE 1 – PLAN DESCRIPTION

The following description of the Topel Forman, L.L.C. (the “Firm”) Employees’ Savings Opportunity Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for more complete information.

A. GENERAL

The Plan is a defined contribution and safe harbor 401(k) plan covering eligible employees of the Firm. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Avantax Retirement Plan Services is the Plan’s recordkeeper and Fidelity Personal Trust Company is the Trustee. The Firm is responsible for overseeing and ensuring compliance with the Plan document.

B. ELIGIBILITY

All employees of the Firm over 21 years of age are eligible to participate in the Plan upon completion of one hour of service within 30 days of being employed. Entry is allowed on the first day of each calendar month coinciding with or next following satisfaction of eligibility requirements.

C. PARTICIPANT CONTRIBUTIONS

Pre-tax and after-tax salary deferrals may be made by participating employees up to 100% of the participant’s eligible compensation up to the IRC limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan has an automatic enrollment feature whereby employees who do not make a positive election to waive participation will be automatically enrolled at a 3% deferral rate upon satisfaction of eligibility requirements. Eligible compensation under the Plan is compensation subject to federal income tax (under code section 3401(a) of the IRC).

D. EMPLOYER CONTRIBUTIONS

The Firm provides a discretionary Qualified Nonelection Employer Contribution (“QNEC”) contribution to eligible participants under the Plan. QNEC contributions are automatically 100% vested. No such discretionary contribution of this type was made for the year ended December 31, 2024.

The Firm also provides a discretionary contribution based on allocation group. The total amount of discretionary contributions based on allocation group were approximately \$554,922 for the year ended December 31, 2024.

The Firm also provides a safe harbor contribution of 3% of eligible compensation. This contribution will be made if the Plan is determined to be top-heavy, under safe harbor rules. The safe harbor contribution for the year ended December 31, 2024, amounted to 3% of eligible compensation and totaled \$671,165.

E. PARTICIPANT ACCOUNTS

Each participant account is credited with the participant’s elective contributions, employer contributions, and allocations of plan earnings and administrative expenses. Allocations are based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled, is the participant’s vested account balance.

F. VESTING

Participants are immediately vested in their contributions and the employer contribution portion of their accounts, plus actual earnings thereon.

G. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance (subject to limits as defined by the Plan), or \$50,000. Participants may have one loan outstanding at any time. Loan terms range from one to five years, unless the loan is qualified as a home loan in which the maximum term increases to fifteen years. Participant loans are secured by the balance in the participant's account and bear interest at a fixed rate of interest of 1% above the prime rate. Principal and interest are paid ratably through payroll deductions and are recorded when received.

H. PAYMENT OF BENEFITS

At retirement (normally age 65) or upon termination of service, a participant may receive a lump-sum amount or installments equal to the value of his or her vested account. If a participant's vested balance is less than \$5,000, the balance will be automatically rolled over into an IRA, or a lump-sum distribution can be elected, once the participant becomes eligible for distribution. The Plan also allows for hardship distributions. Participants should refer to the Summary Plan Description for more complete information regarding payment of benefits.

I. TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America ("GAAP"), as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

B. BASIS OF ACCOUNTING

The financial statements of the plan are prepared on the accrual basis of accounting.

C. ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain recorded amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

D. CONTRIBUTIONS

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

E. PLAN EXPENSES

The Firm pays most of the expenses of administering the Plan. Expenses associated with loans and disbursements are paid by the individual participants. Investment-related expenses are charged to participant accounts and are included in net appreciation (depreciation) of fair value of investments.

F. INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

G. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

H. DUE TO BROKER

Amounts due to broker are cash obligations to broker for securities purchased but not yet settled as of December 31, 2024. The Plan recorded the liabilities when the purchase of securities is executed.

I. PAYMENT OF BENEFITS

Benefits are recorded when paid.

J. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

K. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

NOTE 3 – FORFEITURES

According to the Plan document, forfeitures are to be applied to employer matching contributions or Plan expenses. There was no account balance for forfeitures as of December 31, 2024 and 2023. For the year ended December 31, 2024, no forfeitures were used.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan's investments are held in a trust fund administered by Fidelity Personal Trust Company, FSB., the trustee of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the trustee:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income or loss, interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RELATED PARTY TRANSACTIONS

The Plan has a money market fund that is managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. As of December 31, 2024 and 2023, there were investments that qualified as party-in-interest totaling \$1,717,963 and \$134,707, respectively. The Plan also had notes receivable from participants that qualified as party-in-interest transactions. Notes receivable from participants total \$166,361 and \$51,070, as of December 31, 2024 and 2023, respectively.

NOTE 7 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value.

These levels are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies and inputs used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual Funds (Level 1)*: Valued based on the daily closing price as reported by the fund. These securities are open-ended mutual funds held by the Plan are that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Money Market Mutual Fund*: Valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity. These securities are reflected at Level 2 as inputs used to determine fair value are not quoted prices in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
