## **INDEPENDENT AUDITOR'S REPORT**

To the Participants and Administrative Committee of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Distribution Services Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Distribution Services Retirement Plan's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

## **Basis for Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Distribution Services Retirement Plan (the Plan) was adopted effective May, 15, 2017 (restated July 15, 2021) to establish a savings and investment plan for the exclusive benefit of the employees of 1155-55H Partners, LLC (the Company and Plan Sponsor), and affiliated service group members including 1155 Distributor Partners-Houston, LLC, 1155 Distributor Partners-Dallas, and House of Forgings LLC. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting, which is acceptable under the Department of Labor Rules and Regulations. Interest and dividend income is recognized when earned. Purchases and sales of securities are recorded on a trade date basis.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States (GAAP) requires the Company as Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating these investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits.

Participant Loans Receivable - Loans to participants are reported as a receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Federal Income Tax - The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan (the Profit Sharing Plan) with CODA. The Profit Sharing Plan received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Profit Sharing Plan and related trust are designed in accordance with Section 401(a) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of December 31, 2024 and 2023.

NOTE A           BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. No subsequent events occurred which require adjustment or disclosure to the financial statements at December 31, 2024.

NOTE B           PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - An employee is eligible to become a participant in the Plan having attained the age of 18 and completion of one year of service or 1,000 hours of service. Employees may begin participating in the plan once the eligibility requirements have been met. Plan entry dates are on the first day of the plan year and the first day of the seventh month of the plan year. Excluded employees include union employees, leased employees, and non-resident aliens who received no earned income which constitutes income from services performed within the United States.

Contributions - Participants may elect to make pre-tax and after-tax contributions to the Plan. Contributions are made through authorized payroll reductions. These contributions by individual employees are limited to \$23,000 in calendar year 2024. This limitation is adjusted periodically to reflect cost-of-living increases. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024).

The Company makes safe harbor matching contributions equal to 100% of the participant's employee contributions that were not in excess of 3% of the participant's compensation plus 50% of the participant's employee contributions that exceeded 3% but that did not exceed 5% of the participant's compensation.

The Company may make a matching contribution equal to a discretionary amount and percentage of matched employee contributions. The company may also make a discretionary profit sharing contribution to be determined by the Company. The contribution will be allocated using the comparability formula in an amount designated by the company to be allocated to each group. There were no discretionary contributions in 2024.

Vesting - Participants are immediately fully vested in all participant and employer Safe Harbor matching contributions and related earnings. Discretionary matching contributions vest under a 4-year schedule with 25% vesting earned upon completion of one year of service, 50% vesting upon completion of two years of service, 75% vesting upon completion of three years of service and 100% vesting upon completion of four years of service. A year of service means the completion of at least 1,000 hours of service during the Plan year.

Forfeitures - Forfeited balances of terminated participants' nonvested accounts may be used to reduce administrative expenses or to reduce amounts otherwise required to be contributed by the employer, to the Plan. For the year ended December 31, 2024, forfeitures totaling \$1,628 were used to pay administrative expenses and no forfeitures were used to reduce employer contributions. At December 31, 2024, the Plan had \$10,104 in unused forfeitures.

Forms of Benefits - Benefits are recorded when paid. Normal retirement age is 65. If a participant's employment terminates for reasons other than death, disability or early or normal retirement, the participant is entitled to receive only the vested portion of their account balance. If the amount payable to a participant is less than \$5,000, the participant's vested account balance, after notice to the participant, will be directly rolled over as soon as practical into an individual retirement account maintained by an entity selected by the Company. If the amount payable is greater than \$5,000, the participant must give written consent before the distribution can be made in the form of a single lump-sum payment. Partial or installment distributions will be permitted only to satisfy the required minimum distribution rules. A participant may be eligible for in-service distributions if the participant has reached the age of 59 ½. Participants may request an in-service distribution only from the vested portion of their accounts.

Investments - Each participant directs the investment of their account into any of the investment options designated by the Plan Administrator.

Each participant account is credited with the participant's contribution, the Company's contributions, and a pro rata share of the earnings of each fund in which the participant has invested.

Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. The interest rates on loans outstanding at December 31, 2024 range from 5.25% to 10.50%. Principal and interest is paid ratably through monthly payroll deductions.

Administration - Three officers of the Company are trustees for the Plan. The Company, as the Plan Administrator, may, at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Company will be paid by the Plan. During the year ended December 31, 2024, substantially all expenses were paid by the Company.

NOTE B PLAN DESCRIPTION (CONTINUED)

Plan Termination - Although the Company has not made a determination to terminate the Plan, the Company has the right under the Plan to terminate the Plan subject to provisions set forth in ERISA. Upon termination, all participants would become fully vested in their accrued benefits as of the date of termination.

NOTE C INVESTMENTS AND CERTIFIED INFORMATION

Investments are recorded at fair value. The following table summarizes the investments of the Plan, as certified by John Hancock Life Insurance Company (U.S.A.), as of December 31, 2024 and 2023:

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE D FAIR VALUE DISCLOSURES (CONTINUED)

Level 2 – Other significant observable inputs (including quoted prices in active or inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. Pooled separate accounts are valued using Level 2 inputs.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, including instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used during 2024 and 2023.

Pooled separate accounts are valued at fair value by the asset custodian of the funds based upon the net asset value of the underlying investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no significant transfers in and/or out of the fair value categories during 2024 or 2023.

NOTE E PARTY-IN-INTEREST

The Plan invests in various funds managed by John Hancock Life Insurance Company (U.S.A.). These investments are considered party-in-interest transactions because John Hancock Life Insurance Company (U.S.A.) serves as the asset custodian of the Plan. The Plan Administrator has approved of these investment options.
