NOTES TO FINANCIAL STATEMENTS

AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND DECEMBER 31, 2023

1. DESCRIPTION OF THE PLAN

The following description of The Kinetic Group, Inc. 401(k) Plan (formerly the Vista Outdoor Inc 401(k) Plan) (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and is designed to provide employees with additional security for their retirement.

The Plan was established effective February 9, 2015 and amended periodically through December 31, 2022. The Plan was amended effective January 1, 2023 to admit participants from Simms Fishing Products 401(k) Plan (“Simms Plan”) into the Plan. On February 1, 2023, those employees had their assets in the Simms Plan transferred into the Plan. Total assets transferred from the former plan to the Plan were \$7,387,962 for the year ended December 31, 2023. The Plan was amended and restated effective January 1, 2024 to add Fox Head, Inc. as a participating employer at which point employees of Fox Head, Inc. were eligible to participate in the Plan. The Plan was further amended effective November 27, 2024 to acknowledge the spinoff date and remove eligibility of all Revelyst entities and participants as of that date. On December 6, 2024, impacted participants had their assets in the Plan transferred to the Revelyst entities new plan. Total assets transferred out of the Plan were \$96,738,137 for the year ended December 31, 2024. The Plan was most recently amended effective September 1, 2025 to change the legal name of the plan sponsor from Vista Outdoor Inc. to The Kinetic Group, Inc. (collectively, the “Company”) and to change the legal plan name from Vista Outdoor Inc. 401(k) Plan to The Kinetic Group, Inc. 401(k) Plan (the “Plan” as defined above).

Participation — Each employee of the Company classified as regular full time or regular part time, except for a person employed by an excluded business unit that does not provide for participation in the Plan, automatically became eligible to participate on the date of hire by the Company or transfer into the Plan. Temporary/project employees may become eligible to participate in the Plan after a required amount of service has been met. Non-union participants are automatically enrolled in the Plan at a pre-tax contribution rate of 6% and are also subject to a 1% annual contribution increase (up to 10%). Participants may opt out of the automatic enrollment and/or automatic increase.

Contributions — The Company contributes to the Plan on behalf of the participants who elect to contribute a percentage of salary designated as pre-tax and/or Roth 401(k) contributions. The maximum pre-tax and/or Roth 401(k) contribution amount is prescribed by Plan rules in accordance with limitations set forth by Internal Revenue Service (“IRS”) guidelines. For 2024 and 2023 this limitation was \$23,000 and \$22,500, respectively. The Plan also allows the participants to make limited after-tax contributions. Participants age 50 and older who met other Plan contribution limitations were eligible to make catch-up contributions of up to \$7,500 for calendar year 2024 and 2023. Total annual contributions of all types, including employee contributions combined with Company match, are also limited to the lesser of \$69,000 and \$66,000 or 100% of the participant’s salary for calendar year 2024 and 2023.

Participants who are eligible for a distribution from any other plan qualified under Section 401(a) of the Internal Revenue Code (the “Code”) or from an individual retirement plan under Sections 402 and 408 of the Code may roll over all or a part of such distribution to their accounts in the Plan, as provided under the Plan.

Non-union participants who elect to contribute to the Plan are eligible to receive a 100% match on the first 6% of pre-tax and/or Roth 401(k) contributions.

Participant Accounts — Each participant’s account is credited with their contribution, their portion of the Company’s matching contribution, and is charged with their withdrawals. Earnings, losses, and administrative expenses of the individual participant’s investment fund options are reported in the individual participant’s account. Participants are charged an annual administrative expense of \$55 (deducted from their account on a quarterly basis). The Company pays the administrative expense for participants with account balances less than \$250. The Company may also pay certain Plan expenses at its discretion. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - All participants are 100% vested in their individual accounts attributable to their contributions as well as death, disability and the participant attaining normal retirement age as defined by the Plan. The Company match is subject to a one-year cliff vesting period.

Notes Receivable from Participants — Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants cannot have more than two loans outstanding at one time. Note receivable transactions are treated as a transfer to (from) the investment fund and from (to) the loan fund. Note terms

generally range from one to five years, except notes for the purchase of a primary residence, which generally range from one to ten years. The notes are secured by the balance in the participant's account. Interest rates are calculated quarterly and are based on prime rate plus 1%. Principal and interest are paid ratably through periodic payroll deductions.

Forfeitures — When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture, as defined in the Plan document. Forfeitures may, at the Company's discretion, be applied to pay for the Company's matching contribution and administrative expenses of the Plan permitted by ERISA and/or allocated to individual participant accounts. However, if the participant is re-employed with Kinetic and fulfills certain requirements, as defined in the Plan document, the forfeited portion of a participant's account will be restored. For the years ended December 31, 2024, and 2023, \$371,165 and \$352,690 of forfeitures were respectively used to reduce Company matching contributions and pay administrative expenses. On December 31, 2024, and 2023, the balance in the forfeiture account totaled \$90,022 and \$244,742, respectively.

Distributions — Upon termination of employment, a participant may elect to receive a single lump sum distribution or monthly, quarterly, or annual installments payable over a period of up to 240 months. As required by the Department of Labor, the Plan requires rollover to an individual retirement account feature for any participant whose account balance is greater than \$1,000 but less than \$7,000 who has not elected another form of payment. Participants with a balance of \$1,000 or less will be paid in the form of a one-time lump sum distribution. The mandatory 20% IRS federal tax withholding is applied to certain distributions that are not direct rollovers to another qualified plan. If the participant's balance exceeds \$5,000, the participant may elect to receive a lump-sum distribution, net of tax, non-periodic payments or installment payments. Distributions must begin by April 1 of the following year when the participant retires or turns 72, whichever is the earliest. In-service withdrawals from a participant's accounts are available in accordance with the Plan document. Participants who attain age 59 ½ can also make in-service withdrawals. Hardship withdrawals are also available under the Plan.

Investments — Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching contributions are also invested pursuant to participant direction. All investments are participant directed investments. In the event participants, who are automatically enrolled in the Plan, do not direct their contributions within the Plan, their contributions are automatically defaulted into the age-appropriate life cycle investment fund series.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The financial statements of the Plan are presented on the accrual basis of accounting and have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates — The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan utilizes various investment instruments, including mutual funds and collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, which is generally determined by quoted market prices. When quoted market prices are not available, generally these investments have underlying securities that have fair values determined by quoted market prices. Shares in mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Collective trust funds are stated at fair value as determined by the administrator/custodian of the collective trust funds valued at the net asset value based on the fair value of the underlying investments at year end as a practical expedient. Specifically for stable value investments within a collective trust fund, the underlying investments in investment contracts are valued at the contract value of the underlying investments.

Security transactions (purchases and sales of investments) are recorded on the trade date. Dividend income is recorded on

the ex-dividend date. Interest and other income are recorded as earned. The Trustee charges trustee and administrative fees directly against the individual investment balances.

Net appreciation in the fair value of investments — Net appreciation in fair value of investments represents the net realized gains and the net unrealized appreciation of investments. Realized gains are the difference between the proceeds and either the cost of investments sold, determined on an average cost basis, or fair value at the end of the previous year, whichever is applicable. Net unrealized appreciation is the change in the difference between fair market value and the cost of investments or the fair value at the end of the previous year, whichever is applicable.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

Administrative Expenses — Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Payment of Benefits — Benefit payments to participants are recorded when paid.

3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee of the Plan, Vanguard Fiduciary Trust Company (“Vanguard” or “Trustee”) held the Plan’s investment assets and executed transactions for the years ended December 31, 2024, and 2023 certifying that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024, and 2023.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the current period.

Mutual Funds — Valued at the closing price reported on the active market on which the individual securities are traded. Brokeragelink is a self-directed brokerage window available to Plan participants. The participants have the option to choose from over 4,000 mutual funds on the record-keeper’s platform. As all funds within Brokeragelink are mutual funds, they have been deemed to be Level 1 investments.

Collective Trusts — The Plan is invested in twelve collective investment trusts, eleven of which have underlying securities that have fair values determined by quoted market prices. All trusts are valued at net asset value as a practical expedient. The remaining collective trust is the Fidelity Managed Income Portfolio II, Class 3 (the “Fund”), a collective trust vehicle fund sponsored by Fidelity Management Trust Company. The investments are calculated by multiplying the investee company’s net asset value (“NAV”) per share times the number of units or shares owned at the valuation date as determined by the investee company. NAV per share is determined by the investee company’s custodian or fund administrator by deducting from the value of the assets of the investee company all its liabilities, and then the resulting number is divided by the outstanding number of shares or units.

The Fund has no unfunded commitments. The redemption frequency and notice period is daily.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FEDERAL INCOME TAX STATUS

The IRS has determined and informed the Company by letter dated February 2, 2018, that the Plan document was designed and currently being operated in compliance with the Code. The Plan has been amended since receiving the determination letter, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore, believe the Plan is qualified and tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, the individual participants' accounts become distributable to the participants or their beneficiaries in accordance with the provisions of the Plan.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by the trustee or affiliates thereof. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Notes receivable from participants also qualify as party in interest transactions.

The transactions described above are exempt party-in-interest transactions.

8. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events for potential recognition and disclosure through October 08, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements, except already disclosed within Note 1.
