Report of Independent Auditors

To the Administrator of Raytheon Retiree Health Benefits Plan

Opinion

We have audited the accompanying financial statements of Raytheon Retiree Health Benefits Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its plan benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Note 1 - Plan Description

The following description of the Raytheon Retiree Health Benefits Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

General

The Plan is a welfare plan sponsored by Raytheon Company (the "Company") which provides certain medical, dental, vision and other health and welfare benefits to qualified hourly and salaried retirees and eligible dependents. The Company is a wholly-owned subsidiary of RTX Corporation ("RTX").

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan Administrator of the Plan (for purposes of Section 3(16) of ERISA) is RTX and the Plan is administered by the RTX Corporation's Plan Administration and Investment Committee ("PAIC"), which operates pursuant to a vote of the RTX Board of Directors.

All contributions are deposited into the Voluntary Employees Beneficiary Association ("VEBA") accounts that constitute the Raytheon Welfare Benefits Trust (the "Welfare Benefits Trust") and the 401(h) accounts under the RTX Consolidated Pension Plan ("RTX PP") held in the RTX Master Retirement Trust ("Master Trust").

The VEBA accounts and 401(h) accounts were set up to hold assets and pay benefits covered by the Plan. All contributions and related income are used for the exclusive benefit of participating retirees and dependents, as well as the payment of any administrative expenses incurred by the VEBA accounts and the 401(h) accounts. Plan benefits are paid from multiple sources (VEBA accounts, 401(h) accounts and the Company's general assets), some of which may be restricted for the payment of specific plan benefits. In the event of termination of the Welfare Benefits Trust, assets held in the VEBA accounts will not be refunded to the Company.

The Plan is a contributory plan under which the Company and its retirees contribute amounts necessary to pay participant premiums, claims and related administrative fees.

Effective December 31, 2023, the Raytheon Company Plan for Salaried Employees ("RTN Salaried Pension Plan") merged with the RTX PP. The 401(h) assets under the RTN Salaried Pension Plan totaling \$92,902,542 were transferred from the RTN Salaried Pension Plan to the RTX PP on that date. There were no impacts to the provisions of the Plan as a result of this plan merger.

Benefits and Eligibility

Each qualified retiree will be eligible for benefits in accordance with the benefit program by which the qualified retiree was covered as of the date the retiree entered the Plan.

Contributions

The costs of the Plan are shared by the Company and retirees through deductibles, co-payments, coinsurance and participant contributions. Retirees may contribute specified amounts to extend coverage to eligible dependents. Participant contribution levels are based on a variety of factors including but not limited to, the participant's legacy defined benefit or defined contribution plan, date of hire or last rehire, date of termination and date of retirement.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 4 for investment valuation and income recognition policy. Fair value is defined as the price that would be received for an asset or the exit price that would be paid to transfer a liability in the principle or most advantageous market in an orderly transaction between market participants on the measurement date.

Claims and Premiums Paid

Claims and premium payments are recorded when paid. Current medical claims of retired participants and their dependents are managed under a combination of group insurance contracts and self-insured arrangements administered by a variety of insurance companies. In addition, claims payments also include Administrative Services Only fees of \$1,961,191 .

Administrative and Other Expenses

All expenses of the Plan are paid by the Plan and are included in the Statement of Changes in Net Assets Available for Benefits under "Administrative and other expenses."

Postretirement Benefits

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' services rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from existing plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant, to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the December 31, 2024 and 2023 estimates are as follows:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Actuarial Assumption Changes

- The discount rate used to value the post retirement benefit obligation was changed from 5.14% as of December 31, 2023 to 5.59% as of December 31, 2024.

- The rate of increase in per capita cost of covered health care benefits assumption was changed for the fiscal year ended December 31, 2024.

The assumed expected rate of increase in per capita cost of covered health care benefits used to value the post retirement benefit obligation as of December 31, 2024 was 6.5% in 2025 grading down to the ultimate trend rate of 4.5% by 2033 for participants under 65 and 3.5% for all years for participants over 65.

The assumed expected rate of increase in per capita cost of covered health care benefits used to value the post retirement benefit obligation as of December 31, 2023 was 6.0% in 2024 grading down to the ultimate trend rate of 4.5% by 2027 for participants under 65 and 3.5% for all years for participants over 65.

Benefit Obligations

As of December 31, 2024 and 2023, the Plan had post retirement benefit obligations greater than its net assets, the funding of which is not covered through the contribution rate provided by current bargaining agreements, where applicable.

Use of Estimates

The Plan's financial statements have been prepared in conformity with U.S. Generally Accepted Accounting Principles ("GAAP"). This requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of plan benefit obligations and net assets available for benefits at the date of the financial statements, the changes in plan benefit obligations, the changes in net assets available for benefits during the reporting period, the claims payable, the claims incurred but not reported and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Note 3 - 401(h) Accounts

The RTX PP includes health-benefit components in addition to normal retirement benefits. Contributions to the RTX PP fund a portion of the Plan's postretirement obligation in accordance with Section 401(h) of the Internal Revenue Code ("IRC"). A separate account has been established and maintained in the Plan for such contributions. In accordance with IRC Section 401(h), the Plan's investments in the 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. The related obligations for health benefits are not included in the RTX PP's obligation in the statements of accumulated plan benefits but are reported as obligations in the financial statements of the Plan.

The assets of the RTX PP, including the 401(h) accounts, along with the assets of other tax-qualified defined benefit pension plans maintained by the Company are held in and invested through the Master Trust. Accordingly, each of the 401(h) accounts holds an interest in the Master Trust.

Note 4 - Voluntary Employees Beneficiary Association Accounts

Summary Financial Information

The Plan's VEBA assets are held in the Welfare Benefits Trust. The assets of the Welfare Benefits Trust are held by BNY ("Trustee"). The PAIC regularly reviews the asset allocations and performance of the investments in the Welfare Benefits Trust.

Investment securities are exposed to various risks, such as interest rate, market, currency and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Fair Value

The accounting standard for fair value measurements provides a framework for measuring fair value and requires expanded disclosures regarding fair value measurements. Fair value is defined as the price that would be received for an asset or the exit price that would be paid to transfer a liability in the principal or most advantageous market in an orderly transaction between market participants on the measurement date. The accounting standard established a fair value hierarchy which requires an entity to maximize the use of observable inputs, where available. The following summarizes the three levels of inputs required:

- Level 1:** Unadjusted quoted prices in active markets for identical assets or liabilities.
- Level 2:** Observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or have been corroborated by observable market data for substantially the full term of the related assets or liabilities.
- Level 3:** Unobservable inputs supported by little or no market activity that are significant to the fair value of the assets or liabilities.

A financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. See Valuation Policy section for further information.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

As of December 31, 2024 and 2023, the VEBA investments held directly by the Plan were all valued using Level 1 inputs.

Valuation Policy

The Plan's investments are stated at fair value. The Trustee values investments as follows:

Cash and cash equivalents are valued at amortized cost, which approximates fair value.

Investments in registered investment companies are valued at their last reported net asset value.

When current market quotations are not readily available or do not accurately reflect fair value, investments are valued in a manner that is intended to reflect their fair value.

Investment Income (Loss)

Dividends are recorded on the ex-dividend date and interest income is accrued as earned. All security transactions are recorded on the trade date. Gains or losses on sales of securities are based on average cost.

The Plan presents in the Statement of Changes in Net Assets Available for Benefit the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the change in unrealized appreciation (depreciation) on those investments.

Note 5 - Funding Policy

The benefits (and benefit related administrative expenses and insurance premiums) under the Plan will be funded by participant and employer contributions. Refer to Note 1 for further details. The Company, at its discretion based on actuarial determinations under cost accounting standards and other factors, funds the Plan up to the maximum tax deductible amount. Company contributions to the Plan are maintained in separate trusts. Assets of the Plan are maintained in certain segregated and restricted accounts under two separate trusts: the Welfare Benefits Trust which includes several VEBA accounts; and the Master Trust which includes several 401(h) accounts under the RTX PP. The Salaried VEBA account within the Welfare Benefits Trust, and the Salaried 401(h) account within the Master Trust are available for benefits (and benefit related administrative expenses and insurance premiums) of certain salaried participants, and the Hourly VEBA account within the Welfare Benefits Trust and the Hourly 401(h) account within the Master Trust are available for benefits (and benefit related administrative expenses and insurance premiums) of certain hourly participants. The benefits (and benefit related administrative expenses and insurance premiums) of remaining participants are paid directly by the Company. To the extent assets in these accounts are not sufficient to fund benefits under the Plan, such benefits shall be paid from such other funding vehicles as the Company may establish, or in the absence of such other funding vehicles, directly by the Company. For the year ended December 31, 2024, the Company directly paid benefits (and benefit related administrative expenses and insurance premiums) of \$6,680,326 and administrative expenses of \$534,730 related to the Plan out of general assets of the Company. Such amounts are included in "Claims paid" and "Administrative and other expenses", respectively, on the Statement of Change in Net Assets Available for Benefits.

Note 6 - Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Company by letters dated September 23, 2013 that the RTN Salaried Pension Plan and the related Master Trust which contains the 401(h) accounts, are designed in accordance with applicable sections of the IRC. The Plan Administrator and the Company's benefits counsel believe that the RTX PP is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan Administrator, on behalf of the RTX PP, applied to the IRS for a new determination letter on June 23, 2025.

The IRS determined and informed the Company by letter dated February 6, 1997, that, assuming that it operates as stated in its application for tax exemption, the Raytheon Welfare Benefits Trust, known before January 1, 2008 as the E-Systems, Inc. Salaried Retiree Medical Benefits Trust (Salaried 501(c)(9)), was exempt from federal income tax under Code Section 501(a), other than the unrelated business income tax ("UBIT") on unrelated business

income. Effective January 1, 2008, three other VEBA trusts (the "Participating Trusts") were merged into the Welfare Benefits Trust. The Plan Administrator and the Company's benefits counsel believe that the current design and operation of the Welfare Benefits Trust are consistent with its continued tax exemption.

Although the Welfare Benefits Trust is, and the Participating Trusts were, designated exempt from federal income tax, the income generated is subject to UBIT since the VEBAs solely fund retiree medical health benefits. As such, the Welfare Benefits Trust is required to calculate and make estimated tax payments based on the income it generates each year. Any taxes paid are included in "Administrative and other expenses."

The Plan adopted the provisions of uncertain tax positions that provide criteria for the recognition, measurement, presentation and disclosure of uncertain tax positions.

The Plan is subject to examinations by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes the Plan is no longer subject to federal tax examination for years prior to 2021.

Note 8 - Termination Policy

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, discontinue, or terminate the Plan at any time, without prejudice, subject to the provisions set forth in ERISA.

Note 9 - Certain Transactions Involving Related Parties and Parties-in-Interest

BNY is the Trustee and Custodian of the Plan and is therefore a party-in-interest with respect to the Plan. Certain investments within the Welfare Benefits Trust and the Master Trust (in which each 401(h) account has an interest) were advised by or affiliated with BNY. The Plan Sponsor, Raytheon Company, and the Plan Administrator, RTX, are parties-in-interest with respect to the Plan and incur expenses in connection with the administration of the Plan and the Master Trust.

Certain expenses paid to BNY, Raytheon Company and RTX are also included in the "Net decrease in 401(h) account." The Plan also incurs certain administrative expenses paid to parties-in-interest.

All of these transactions either fall outside the scope of, or are exempt from, ERISA's prohibited transaction rules.

Note 10 - Risks and Uncertainties

Contributions to the Plan are made and the actuarial present value of post retirement benefit obligations and the claims incurred but not recorded are reported based on certain assumptions pertaining to interest rates, inflation rates, health care cost trends, employee compensation and demographics. Due to the changing nature of the assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. The investments of the Plan are exposed to various risks, such as interest rate, market and credit risks. See Note 4 for additional information with respect to investment risk.

Note 11 - Subsequent Events

The Plan has evaluated subsequent events and transactions subsequent to December 31, 2024 through the date the Plan's financial statements were available to be issued, October 14, 2025.
