The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information

prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

December 31, 2024

1. Description of the Plan

The following description of the Joint Venture Companies Employees 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan’s provisions.

a. General

The Plan is a defined contribution plan established by EMCOR Facilities Services, Inc. (the “Company”) on May 1, 2000, under the provisions of Section 401(a) of the Internal Revenue Code (the “Code”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the Code, for the benefit of eligible employees of the Company. Substantially all employees of the Company who have completed one hour of service, as defined by the Plan, are eligible to participate once they meet the Plan’s eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Effective February 1, 2006, employees of EJB Facilities Services, Inc. (“EJB”) became eligible to participate in the Plan. Existing employees of EJB were immediately eligible to participate on February 1, 2006. After February 1, 2006, new employees of EJB are eligible to participate on the first month following 90 days of service. There were no active employees of EJB during the 2024 plan year.

T. Rowe Price Trust Company (the “Trustee”) is the trustee and custodian for the Plan. The Trustee holds the Plan assets and is responsible for executing investment transactions.

The Company has evaluated all subsequent events for the Plan through October 13, 2025, the date these financial statements were available to be issued.

b. Contributions

Participants may contribute a portion of their compensation to the Plan subject to the limitations set forth in the Code. Additionally, Plan participants may change the percentage of compensation deferred at any time. Contributions made by Plan participants may be stopped at any time. The Company may also make a discretionary contribution with respect to each Plan year. No such discretionary contributions were made in 2024.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

c. Participant Accounts

Participants are permitted to direct their investments into different investment options in increments of 1% and participants may change their elections at any time. Any new election may apply to future contributions or to existing account balances, as the participant elects. Employer contributions, if any, are invested in the same investment funds and at the same investment percentages elected by participants for their own future contributions. Each participant's account is credited with the participant's contribution, the Company's contribution, if any, and Plan earnings or losses.

d. Vesting

All participants are vested immediately in their contributions plus earnings thereon. All participants are also vested immediately in their employer contributions.

e. Withdrawals and Distributions

Generally, participants may not withdraw funds until after termination of employment or until attaining age 59½, subject to certain limitations. A participant may, however, apply in writing to the administrator of the Plan at any time for an emergency "hardship" withdrawal. Such a withdrawal may only be made for an immediate and severe financial need and may not exceed the amount needed to meet the cost of the hardship.

Upon termination of employment for any reason, other than death, the participant may elect to receive a lump-sum cash payment as soon as practicable after the valuation date following the date of termination. Terminated participants may also elect to leave their investments in the Plan until they either reach the statutory age requiring distribution or they consent to receive payment if the value of the account is greater than \$5,000.

Upon the death of a participant, a single lump-sum distribution will be made to the participant's beneficiary or beneficiaries.

1. Description of the Plan (continued)

f. Participant Loans

Generally, participants may borrow the lesser of 50% of their vested balance or the sum of the participant's rollover and "elective deferral" accounts made under the Plan. Loan amounts can range from a minimum of \$1,000 to a maximum \$50,000. A participant may not have more than one loan outstanding at any time. Loans are repayable through at least quarterly payroll deductions with the term of repayment beginning immediately. The term of the loan cannot exceed five years, unless the loan proceeds are used for the purchase of a principal residence, in which case the loan term can be extended to 15 years. Loans bear interest at the Prime rate on the first business day of the calendar month in which the loan is processed. The interest rate on the existing loan is 4.25%.

g. Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or by the Company, depending on the nature of the expense.

h. Plan Termination

Although the Company has no intention to terminate the Plan, the Company reserves the right to amend, modify, or discontinue the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants are already 100% vested in their accounts.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b. Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (continued)

c. Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

d. Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

e. Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Net appreciation in the fair value of investments includes realized gains and losses on investments sold or disposed of during the year and unrealized gains and losses at year-end.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted market prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than the quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the net asset value, based on quoted market prices in active markets, of shares held by the Plan at year end.

Common/collective trusts – Measured at net asset value (“NAV”), as determined by the asset manager, for shares held by the Plan at year end. Such NAV has a readily determinable fair value.

4. Fair Value Measurements (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

6. Party-in-Interest Transactions

The Plan holds investments in certain assets which are managed by T. Rowe Price, the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

7. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (“IRS”) dated October 1, 2014, stating that the Plan is qualified under the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan as amended is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
