INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Protiviti Inc. 401(k) and Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Protiviti Inc. 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of Protiviti Inc. 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by Protiviti, Inc. (the "Company" or the "Employer"), is intended to qualify under Section 401(a) and related provisions of the Internal Revenue Code ("IRC"), and was established effective December 1, 2002 and restated October 1, 2021 and amended on several occasions thereafter. The Plan is designed to provide participants with a means to defer a portion of their eligible pay for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company is a wholly-owned subsidiary of Robert Half Inc. (formerly named Robert Half International Inc.).

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company, who delegated its responsibility to the Robert Half Benefit Plan Committee, is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. Trustee services are provided by Fidelity Management Trust Company (the "Trustee"), while recordkeeping services are provided by Fidelity Workplace Services, LLC (the "Recordkeeper"), an affiliate of the Trustee (collectively "Fidelity"). The Trustee manages the Plan's investments and executes investment transactions while the Recordkeeper manages participant accounts and participant related transactions.

Eligibility

All employees of the Company are immediately eligible to participate in the Plan, except for residents of Puerto Rico, employees covered by a collective bargaining agreement, leased employees, and individuals not on the W-2 payroll of the Company, and certain other employees, as specified in the Plan document.

Participant contributions

Participants may elect to contribute through payroll deductions amounts up to 60% of their annual eligible pay, as defined in the plan document, on a pre-tax or Roth after-tax basis, up to a maximum amount allowed by the IRC. Participants age 50 or older may also contribute additional catch-up contributions up to 75% of their eligible pay to the Plan as allowed by the IRC. Participants are also allowed to roll over contributions from other qualified retirement plans. Participants may additionally contribute on an after-tax basis contribute up to 60% of their eligible pay, not to exceed the 2024 IRS limit of \$69,000 for the combination of pre-tax, Roth 401(k), after-tax deferrals and any Protiviti matching contributions. After-tax contributions are limited to 8% of eligible pay for highly compensated employees (as defined in the Plan). The combined limit for pre-tax, Roth 401(k), after-tax deferrals and matching contributions received for those participants age 50 or greater was \$76,500 during 2024.

Newly eligible participants are automatically enrolled in the Plan unless they make a contrary election within 30 days of meeting plan eligibility requirements. Automatically enrolled participants have their deferral rate set at a pre-tax rate equal to 4% their of eligible pay and their contributions invested in a qualified default alternative investment unless an alternate investment option is elected by the participant within 30 days of meeting the Plan's eligibility requirements.

Active participants (other than interns and EMSP participants, ad defined in the Plan) who have a deferral contribution of greater than zero and less than 10% will automatically have such contribution increased in increments of 1% each year on July 1st.

Employer contributions

The Plan provides for a discretionary employer matching contribution for certain classes of eligible participants. Participants, except for those who are practice personnel at the level of managing director or above, are immediately eligible for matching contributions, provided that the participant is employed on the last day of the year. For the year ended December 31, 2024, the Company elected to make a matching contribution equal to 50% of the first 6% of each eligible participant's eligible pay, as defined in the plan document. The Company's matching contributions to the Plan for the year ended December 31, 2024 were \$14,689,279, which has been offset by forfeitures of \$1,058,819, for a net contribution and related employer contribution of \$14,689,279. These matching contributions were deposited into the Plan's trust in 2025.

Additionally, the Company may elect to make a discretionary non-elective contribution to the Plan. Participants, except for those who are practice personnel at the level of managing director or above, are eligible to receive the Company's non-elective contributions after attaining two years of service with 1,000 hours per year with the Company. For the year ended December 31, 2024, the Company did not make any non-elective contribution.

Participant accounts

Each participant's account is credited with the participant's contributions, rollovers, allocations of the Company's contributions, if any, and an allocation of investment gains, and charged with an allocation of investment losses and administrative expenses not paid directly by the Company. Participants may direct their account balances into any of the investment options offered under the Plan. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchases and sales. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their pre-tax, Roth, and after-tax contributions, plus actual earnings thereon. Participants are immediately 100% vested in the Company's discretionary non-elective contributions, plus actual earnings thereon. Participants become fully vested in the Company's matching contributions, plus actual earnings thereon after three years of service. In addition, the vesting provisions under the Plan provide for different vesting than identified here under certain circumstances.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,056,594 and \$932,149, respectively. The plan document allows forfeitures to be used to pay administrative expenses of the Plan or to reduce future Company contributions. During the year ended December 31, 2024, forfeitures of \$969,947 were used to reduce the Company's discretionary matching contributions funded during 2024.

Notes receivable from participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid within 5 years unless the loan is for the purchase of a primary residence for which the loan term may be up to but not to exceed 10 years. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus 1%. Loans accrue interest at rates ranging from 4.25% - 9.50% with scheduled maturities through February 2048. The Plan requires the repayment of principal plus interest to be made through payroll deductions. All loans become immediately payable in the event of default, death, disability, or termination of employment.

Payment of benefits

Distributions and withdrawals are payable upon retirement, attainment of age 59 1/2, termination, financial hardship, disability, retirement, or death upon the request of the participant or the participant's designated beneficiary. Distributions are paid in the form of a lump-sum cash payment or a direct rollover into another qualified plan or IRA account. Participant account balances equal to or less than \$1,000 at termination, are distributed immediately in a lump-sum cash payment unless otherwise directed by the participant. Participant account balances over \$1,000 and equal to or less than \$7,000 at termination, will be rolled over to an individual retirement plan designated by the administrator unless otherwise directed by the participant. If the account balance is over \$7,000 at termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents. Participants with an immediate and heavy financial need may be eligible for a hardship withdrawal, subject to certain restrictions as described in the plan document.

Administrative expenses

Administrative expenses are paid primarily from participant accounts. Transaction fees for certain participant initiated activity are individually charged to the specific account of the participant initiating any such transactions. The Plan is not required to reimburse the Company for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions are separated from the participants' eligible pay by the Company, which is generally the pay date. Contributions from the Company are recorded in the year earned to coincide with the year in which the Company records the contributions to its general ledger. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants are recorded based on the date the rollover contributions are deposited into the Trust.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets of liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and,
- inputs that are derived principally from or corroborated by observable market data by correlation of other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset of liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes to the methodology used at December 31, 2024 and 2023.

Mutual funds and money market mutual fund: Valued at the daily closing price as reported on an open exchange. Mutual and money market mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held under the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time for any reason subject to the provisions of ERISA. In the event of Plan termination, each participant's account shall become fully vested and non-forfeitable.

6. PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. We did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management, shareholder services, and sub-transfer agency fees are paid through fund level revenue sharing arrangements. These fees reduce fund earnings, thereby impacting Plan revenue applied to participants' accounts.

The Trustee retains, as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Certain Plan investments are managed by the Trustee or its affiliates, therefore, these investment transactions qualify as exempt party-in-interest transactions.

7. TAX STATUS

The Plan utilized Fidelity's Volume Submitter Defined Contribution Basic Plan Document No. 17. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, stating that the volume submitter plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by plan sponsors. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. TRANSFERS

In 2024, certain participants in the Robert Half Inc. 401(k) Plan and the Robert Half Inc. 401(k) Plan for Contract Talent and Full-Time Engagement Professionals (the "Contract Talent Plan") became eligible to participate in this Plan. During 2024, assets totaling \$1,345,220 were transferred from the Robert Half Inc. 401(k) Plan and the Contract Talent Plan into the Plan.

In 2024, certain Plan participants became eligible to participate in the Robert Half Inc. 401(k) Plan. During 2024, assets totaling \$102,726 were transferred from the Plan into the Robert Half Inc. 401(k) Plan.

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Protiviti Inc. 401(k) and Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Protiviti Inc. 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Protiviti Inc. 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Protiviti Inc. 401(k) and Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of Protiviti Inc. 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by Protiviti, Inc. (the "Company" or the "Employer"), is intended to qualify under Section 401(a) and related provisions of the Internal Revenue Code ("IRC"), and was established effective December 1, 2002 and restated October 1, 2021 and amended on several occasions thereafter. The Plan is designed to provide participants with a means to defer a portion of their eligible pay for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company is a wholly-owned subsidiary of Robert Half Inc. (formerly named Robert Half International Inc.).

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company, who delegated its responsibility to the Robert Half Benefit Plan Committee, is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. Trustee services are provided by Fidelity Management Trust Company (the "Trustee"), while recordkeeping services are provided by Fidelity Workplace Services, LLC (the "Recordkeeper"), an affiliate of the Trustee (collectively "Fidelity"). The Trustee manages the Plan's investments and executes investment transactions while the Recordkeeper manages participant accounts and participant related transactions.

Eligibility

All employees of the Company are immediately eligible to participate in the Plan, except for residents of Puerto Rico, employees covered by a collective bargaining agreement, leased employees, and individuals not on the W-2 payroll of the Company, and certain other employees, as specified in the Plan document.

Participant contributions

Participants may elect to contribute through payroll deductions amounts up to 60% of their annual eligible pay, as defined in the plan document, on a pre-tax or Roth after-tax basis, up to a maximum amount allowed by the IRC. Participants age 50 or older may also contribute additional catch-up contributions up to 75% of their eligible pay to the Plan as allowed by the IRC. Participants are also allowed to roll over contributions from other qualified retirement plans. Participants may additionally contribute on an after-tax basis contribute up to 60% of their eligible pay, not to exceed the 2024 IRS limit of \$69,000 for the combination of pre-tax, Roth 401(k), after-tax deferrals and any Protiviti matching contributions. After-tax contributions are limited to 8% of eligible pay for highly compensated employees (as defined in the Plan). The combined limit for pre-tax, Roth 401(k), after-tax deferrals and matching contributions received for those participants age 50 or greater was \$76,500 during 2024.

Newly eligible participants are automatically enrolled in the Plan unless they make a contrary election within 30 days of meeting plan eligibility requirements. Automatically enrolled participants have their deferral rate set at a pre-tax rate equal to 4% their of eligible pay and their contributions invested in a qualified default alternative investment unless an alternate investment option is elected by the participant within 30 days of meeting the Plan's eligibility requirements.

Active participants (other than interns and EMSP participants, ad defined in the Plan) who have a deferral contribution of greater than zero and less than 10% will automatically have such contribution increased in increments of 1% each year on July 1st.

Employer contributions

The Plan provides for a discretionary employer matching contribution for certain classes of eligible participants. Participants, except for those who are practice personnel at the level of managing director or above, are immediately eligible for matching contributions, provided that the participant is employed on the last day of the year. For the year ended December 31, 2024, the Company elected to make a matching contribution equal to 50% of the first 6% of each eligible participant's eligible pay, as defined in the plan document. The Company's matching contributions to the Plan for the year ended December 31, 2024 were \$14,689,279, which has been offset by forfeitures of \$1,058,819, for a net contribution and related employer contribution of \$14,689,279. These matching contributions were deposited into the Plan's trust in 2025.

Additionally, the Company may elect to make a discretionary non-elective contribution to the Plan. Participants, except for those who are practice personnel at the level of managing director or above, are eligible to receive the Company's non-elective contributions after attaining two years of service with 1,000 hours per year with the Company. For the year ended December 31, 2024, the Company did not make any non-elective contribution.

Participant accounts

Each participant's account is credited with the participant's contributions, rollovers, allocations of the Company's contributions, if any, and an allocation of investment gains, and charged with an allocation of investment losses and administrative expenses not paid directly by the Company. Participants may direct their account balances into any of the investment options offered under the Plan. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchases and sales. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their pre-tax, Roth, and after-tax contributions, plus actual earnings thereon. Participants are immediately 100% vested in the Company's discretionary non-elective contributions, plus actual earnings thereon. Participants become fully vested in the Company's matching contributions, plus actual earnings thereon after three years of service. In addition, the vesting provisions under the Plan provide for different vesting than identified here under certain circumstances.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,056,594 and \$932,149, respectively. The plan document allows forfeitures to be used to pay administrative expenses of the Plan or to reduce future Company contributions. During the year ended December 31, 2024, forfeitures of \$969,947 were used to reduce the Company's discretionary matching contributions funded during 2024.

Notes receivable from participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid within 5 years unless the loan is for the purchase of a primary residence for which the loan term may be up to but not to exceed 10 years. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus 1%. Loans accrue interest at rates ranging from 4.25% - 9.50% with scheduled maturities through February 2048. The Plan requires the repayment of principal plus interest to be made through payroll deductions. All loans become immediately payable in the event of default, death, disability, or termination of employment.

Payment of benefits

Distributions and withdrawals are payable upon retirement, attainment of age 59 1/2, termination, financial hardship, disability, retirement, or death upon the request of the participant or the participant's designated beneficiary. Distributions are paid in the form of a lump-sum cash payment or a direct rollover into another qualified plan or IRA account. Participant account balances equal to or less than \$1,000 at termination, are distributed immediately in a lump-sum cash payment unless otherwise directed by the participant. Participant account balances over \$1,000 and equal to or less than \$7,000 at termination, will be rolled over to an individual retirement plan designated by the administrator unless otherwise directed by the participant. If the account balance is over \$7,000 at termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents. Participants with an immediate and heavy financial need may be eligible for a hardship withdrawal, subject to certain restrictions as described in the plan document.

Administrative expenses

Administrative expenses are paid primarily from participant accounts. Transaction fees for certain participant initiated activity are individually charged to the specific account of the participant initiating any such transactions. The Plan is not required to reimburse the Company for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions are separated from the participants' eligible pay by the Company, which is generally the pay date. Contributions from the Company are recorded in the year earned to coincide with the year in which the Company records the contributions to its general ledger. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants are recorded based on the date the rollover contributions are deposited into the Trust.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets of liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and,
- inputs that are derived principally from or corroborated by observable market data by correlation of other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset of liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds and money market mutual fund: Valued at the daily closing price as reported on an open exchange. Mutual and money market mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held under the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time for any reason subject to the provisions of ERISA. In the event of Plan termination, each participant's account shall become fully vested and non-forfeitable.

6. PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. We did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management, shareholder services, and sub-transfer agency fees are paid through fund level revenue sharing arrangements. These fees reduce fund earnings, thereby impacting Plan revenue applied to participants' accounts.

The Trustee retains, as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Certain Plan investments are managed by the Trustee or its affiliates, therefore, these investment transactions qualify as exempt party-in-interest transactions.

7. TAX STATUS

The Plan utilized Fidelity's Volume Submitter Defined Contribution Basic Plan Document No. 17. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, stating that the volume submitter plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by plan sponsors. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. TRANSFERS

In 2024, certain participants in the Robert Half Inc. 401(k) Plan and the Robert Half Inc. 401(k) Plan for Contract Talent and Full-Time Engagement Professionals (the "Contract Talent Plan") became eligible to participate in this Plan. During 2024, assets totaling \$1,345,220 were transferred from the Robert Half Inc. 401(k) Plan and the Contract Talent Plan into the Plan.

In 2024, certain Plan participants became eligible to participate in the Robert Half Inc. 401(k) Plan. During 2024, assets totaling \$102,726 were transferred from the Plan into the Robert Half Inc. 401(k) Plan.
