### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have audited the financial statements of FISC 401K Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 301(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2023 and 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statement or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of VIDA Fitness 401K Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about FISC 401K Plan and Trust's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted on the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Information***

The supplemental Schedule H, Line 4i – Schedule of Assets Held at End of Year as of December 31, 2024 and 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A – Description of Plan**

The following description of the FISC 401K Plan (the “Plan”) provides general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

Federal Integrated Systems Corporation (the “Sponsor”) established the Plan as of January 1, 2012, covering employees of Federal Integrated Systems Corporation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

Employees having attained the age of 18 are eligible to participate the six months after their date of hire.

Contributions

Participants may elect to defer their compensation up to the maximum extent allowed by law. Employer contributions are discretionary.

Investment Alternatives

Plan participants may direct their account balances in partial percentage increments to any of the various investment options offered by the Plan, via the Plan website. Participants may change their investment options on a daily basis.

Participant Accounts and Allocations

Participant recordkeeping is performed by Wellington Consulting Services, Inc.. Participant investments are in mutual funds that are accounted for on the unit value method. Each participant’s account is credited with the participant’s contributions, employer contributions, and Plan earnings (losses). Distributions are charged to each participant’s account. Allocations of the Plan earnings (losses) are based on participant account balances in relation to the total fund balance.

Vesting and distributions

Participants vest 100% in employer contributions. Participant accounts are distributable, in full or as partial withdrawals, in the form of lump sum payments or substantially equal installments. Participant accounts can be rolled over into an individual retirement account or another qualified defined benefit plan.

**NOTE B - Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”)

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received on the sale of an asset in an orderly transaction between market participants at the measurement date. The Plan presents in the Statements of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sale are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recognized when earned. Investment related expenses are deducted from net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid except for any excess contribution payable to participants, which are recorded as they become payable.

Income Tax Status

The Plan adopted the Plan trustee’s plan document, which received a favorable opinion letter from the Internal Revenue Service, stating that it is qualified under the various requirements of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. Accounting principles generally accepted in the United States of America require a Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken an uncertain position that would likely not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken that would require recognition of a liability.

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**NOTE B - Summary of Significant Accounting Policies (continued)**

Risks and Uncertainties

The Plan provides for various investment options in a combination of different investment securities. The Plan's investments are exposed to various risks, including, but not limited to, interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the reported amounts in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

Subsequent events have been evaluated through October 14, 2024, the date the financial statements were issued.

**NOTE C – Investments**

The Plan's investments are held in trust by Charles Schwab & Co., Inc. The Plan's trust agreement requires the Trustee to invest the Plan's assets into various fund options as directed by each participant. The Plan's investments that exceed 5% of net assets available for benefits as of December 31, 2024 are as follows:

**NOTE D – Fair Value Measurements**

The Plan follows a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and liabilities and have the highest priority. Level 2 is based upon observable inputs other than quoted market prices, and Level 3 is based on unobservable inputs. The Plan’s investments that are measured by fair value are in mutual funds and fixed annuities, categorized as follows:

**NOTE E – Loans**

Under the Plan, participants may take loans from their account balances with repayment due up to five years. Total loans outstanding at December 31, 2024 and 2023, are \$52,880 and \$20,913, respectively.

**NOTE F – Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has a right under the Plan to terminate the Plan, subject to the provisions of ERISA.

**NOTE G – Exempt Party-in-interest Transactions**

Certain Plan investments were managed by Charles Schwab & Co., Inc., the plan custodian. Transactions involving these investments are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**NOTE H – Separated Individuals**

Individuals who are no longer employed by the Plan sponsor have vested balances of \$408,863 and \$365,792 at December 31, 2024 and 2023, respectively.

**NOTE I – Forfeitures**

Employer contributions in which terminated employees have not vested are forfeited to the Plan. Forfeited funds can be used to reduce administrative expenses of the Plan, restore forfeited account balances of rehired employees, or, at the discretion of the Plan Administrator, to reduce employer contributions. There were no forfeitures during 2024 or 2023.
