We have performed audits of the financial statements of the SPINS 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of Plan

The following brief description of the SPINS 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of SPINS, LLC (the Company) who have 60 days of service and are age 21 or older. Eligible employees can enter the Plan on the first day of the month coinciding with or following completion of eligibility requirements. Transamerica Retirement Solutions Corporation (TRS) is responsible for the general administration and operation of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions: Each year, participants may contribute up to the annual additions limitations provided for by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company contributes a matching contribution of 50% of the first 4% of compensation that a participant contributes to the Plan. The Company may also make discretionary profit-sharing contributions to the Plan on behalf of each Participant at the option of the Company's board of directors. During the year ended December 31, 2024, there were no profit sharing contributions made to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of the Company's matching contributions, the Company's profit-sharing contributions, if any, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant investment options: Participants direct the investment of their contributions and the Company's contributions to selected investment options as offered by the Plan. Participants may change their investment options daily.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution matching and profit-sharing portion of their accounts is based on years of continuous service. Benefits vest as follows:

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the excess, if any, of the participant's highest outstanding participant loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan) or 50% of their vested account balance. Participants may have only one loan outstanding at any given time. The loans are secured by the balance in the participant's account. The loan interest rate is set on the date of loan

issuance and is 1% above the prime interest rate as published from time to time in the Wall Street Journal. Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of benefits: On termination of service due to death, a beneficiary may elect to receive either a joint and survivor annuity or a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the participant's total vested account balance exceeds \$5,000, no distribution will be made without consent. If the participant's total vested account balance is \$5,000 or less as of the distribution date, the entire vested account balance will be distributed in a lump sum, even if there is no consent. Hardship and in-service distributions are allowed by the Plan.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,598 and \$0, respectively. Forfeitures may be used to reduce Company's future contributions in the plan year following the plan year in which the forfeiture occurs or pay administrative expenses. During the plan year ended December 31, 2024, \$69,405 of forfeitures were utilized to pay Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be recorded at fair value, except for direct investments in fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to direct investments in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transaction under the terms of the Plan.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits: Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Continued)

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution processing are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

Income tax status: The Plan adopted the Transamerica Retirement Solutions Corporation Volume Submitter 401(k) Profit Sharing Plan as of November 1, 2018. The Company is relying on an advisory letter issued by the IRS as evidence that the Plan is qualified. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2020.

Subsequent events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets

- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units of common collective trusts: Valued based on the NAV of units of the common collective trust. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust, less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfer between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Investment Contract With Insurance Company

As of December 31, 2024 and 2023, the Plan had a balance in an ERISA budget account managed by TRS. The Stable Fund in which the plan is invested is provided under a group annuity contract issued by Transamerica Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a semiannual basis for resetting. There is no required crediting interest rate for the investment contract. At December 31, 2024 and 2023, the interest rate for the investment contract was 1.58% and 1.18%, respectively.

Note 6. Related-Party and Party-in-Interest Transactions

The Plan assets are held and invested by Transamerica, the custodian as defined by the Plan. Transamerica also serves as the Plan's third-party administrator and recordkeeper and, therefore, their transactions qualify as party-in-interest transactions. Total administrative expenses incurred and paid by the Plan to its service provided amounted to \$205,146 for the year ended December 31, 2024.

The Company is the Plan Sponsor and pays certain expenses on behalf of the Plan. In addition, certain employees of the Company are responsible for the administration of the Plan. These employees do not receive compensation for their services. Fees for the plan administrative services rendered during the year and paid by the Company are based on customary and reasonable rates for such services.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.
