Note 1. Description of plan

The following description of the AHA Consulting Engineers, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

AHA Consulting Engineers, Inc., established the AHA Consulting Engineers Employee Stock Ownership Plan (The Plan) effective as of December 31, 2022, and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Act of 1974 (ERISA).

General

The Plan is an employee stock ownership plan covering all employees of AHA Consulting Engineers, Inc. (the Company) who are 21 years of age and have one year of service in which an employee has at least 1,000 hours of service. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are not eligible for an allocation of contributions for such year.

Bargaining employees, nonresident aliens, part-time, temporary or seasonal employee, independent contractors, leased employees, interns and co-operative students are excluded from the Plan.

Voluntary contributions, rollover contributions are not permitted.

Contributions

Discretionary contributions may be made for each Plan year in an amount determined by the employer. Discretionary contributions and forfeitures shall be allocated as of the last day of the plan year. Employer contributions shall be made without regard to current or accumulated net profits. Prior to January 1, 2024, each eligible employee shall be awarded 1 unit for each \$10,000 of Annual Compensation (maximum of 15 such units allowed) and 3 units for each 5 years of credited service (maximum of 12 such units allowed) as of the last day of the plan year. The amount allocated shall be equal to the Discretionary Contributions multiplied by the ratio of such person's units for the plan year to the total units for all such persons for the plan year. Beginning January 1, 2024, the amount allocated shall be equal to the discretionary contributions multiplied by the ratio of such person's annual compensation to the total annual compensation for all such persons.

Withdrawals

Withdrawal benefits are not permitted in the Plan.

Distributions of benefits

Upon retirement or termination of employment, the value of the vested portion of the participant's account will be distributed to the participant in a lump-sum payment or in substantially equal annual installments over a period not to exceed 5 years. The 5-year period may be extended up to 5 years for accounts whose value exceeds \$1,090,000.

Administrative expenses

The Plan administrator has complete control of the administration of the Plan. As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account. When no voting directions have been received from the participant, with respect to matters in which the participant is entitled to vote, such shares will be voted by the Trustee.

Participants' Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants, and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over the period of 5 years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Note 1. Description of plan (continued)

Diversification

Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants above a certain age and certain years of participation in the Plan may elect to diversify a portion of their account.

Forfeitures

Plan forfeitures may be used to pay administrative expenses or to reduce Employer Contributions made after the forfeitures are determined. Forfeitures that have not been used to pay administrative expenses or to reduce employer contributions shall be allocated to participants.

Plan administration.

The Company serves as the Plan administrator.

Loans to participants

Loans to participants are not permitted.

Note 2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

The shares of the Company common stock are reported at fair value.

Payments of benefits

Benefits are recorded when paid.

Note 3. Investments

The Plan's investments, at December 31, 2024 and 2023, are 9,720 shares of AHA Consulting Engineers, Inc. common stock, with an estimated fair value of 3,152,585 and \$2,153,466, respectively (Note 4).

Note 4. Fair value measurement

The Plan has adopted the criteria of FASB Accounting Standards Codification (ASC) 820, "*Fair Value Measurements and Disclosures*". ASC 820 defines fair value, establishes a framework for measuring fair value under generally accepted accounting principles, and expands disclosures about fair value measurements. ASC 820 establishes a fair value hierarchy that prioritizes the inputs and assumptions used to measure fair value:

A financial instrument's level within the framework is based upon the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value framework under ASC 820 are as follows:

Level I: Fair values are based on inputs that reflect quoted prices (unadjusted) in active markets for identical assets and liabilities that the Plan has the ability to access at the measurement date.

Level II: Fair values are based on inputs other than quoted prices that are observable for the asset or liabilities either directly or indirectly, including inputs in markets that are not considered to be active.

Level III: Fair values are based on inputs that are unobservable.

The following demonstrates the level, within the fair value hierarchy, of the Plan's assets at fair value as of December 31, 2024 and 2023:

Changes in fair value of level 2 assets

The Plan distributed 9,720 shares, at \$ 238.81 per share, of the Plan's level 2 assets during the year ended December 31, 2023. As of December 31, 2024, the 9,720 shares are valued at \$324.34 per share.

The AHA Consulting Engineers, Inc common stock held by the Plan is reported at fair value based upon an appraisal. This appraisal was based upon income valuation techniques.

Changes in fair value of level 2 assets (continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax status.

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not been amended since receiving the determination letter. However, the Plan administrator believes that the plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan termination.

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination to the Plan, the Employee Benefit Committee directs the Trustee to pay all liabilities and expenses of the ESOP and sell shares of financed common stock held as collateral to the extent it determines such sales to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code.

Note 7. Risk and uncertainties.

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and the uncertainties inherent in estimates and assumptions, it is at least reasonable possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 8. Related party transactions

The Plan invests in Company's common stock and has any indebtedness guaranteed by the Company. These are related party and party in interest transactions. As described in Note 1, the Company pays all expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.
