NOTE 1: DESCRIPTION OF PLAN

The following description of the Hossley Lighting and Power Solutions 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1978, as a defined contribution plan maintained for the benefit of employees of Hossley Lighting Associates, Inc., who had met the eligibility requirements as defined in the Plan agreement. In July 2020, Hossley Lighting Associates, Inc. was converted to Hossley Lighting Associates, LLC and then merged with Lighting & Power Solutions to create Hossley Lighting and Power Solutions (the Company). The Company is partially owned by Hossley Holdings, Inc. (the Employer, Plan Sponsor and Plan Administrator). Effective January 1, 2020, the Plan was amended to reflect the change in the employer from Hossley Lighting Associates, Inc. to Hossley Holdings, Inc. and reflect the change in the Plan's name from Hossley Lighting Associates, Inc. 401(k) Profit Sharing Plan to Hossley Lighting and Power Solutions 401(k) Profit Sharing Plan. The amended and restated plan is a defined contribution plan maintained for the benefit of employees of Hossley Holdings, Inc. who have met the eligibility requirements as defined in the Plan agreement. Generally, an employee is eligible to participate in the Plan on the later of the first day of the month following the date of hire or attaining age twenty-one.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer utilizes the services of National Benefit Services (NBS), a third-party administrator, to process investment transactions and maintain participant account balances. Nationwide Trust Company, FSB (Nationwide) is the Plan's asset custodian.

The Trustees for the Plan are responsible for the oversight of the Plan and determine the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Directors.

Certain duties related to administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Other expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$43,000 for the year ended December 31, 2024.

Contributions

Participants may contribute a percentage of their annual compensation, as defined in the Plan agreement, not to exceed limitations imposed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Contributions (Continued)

The Employer may make a discretionary profit-sharing match contribution allocated to each eligible participant, as defined in the Plan agreement. The amount of profit-sharing contribution, if any, is determined annually by the Plan Sponsor. Employer contributions are also subject to limitations imposed by the IRS.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's matching contributions and allocations of (a) profit-sharing contributions and (b) Plan earnings, net of certain administrative expenses. Allocations are generally based on participant earnings or participant account balances, as specified in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested at all times in their own contributions plus actual earnings thereon. Vesting in Employer contributions and earning thereon, occurs according to the following schedule.

A participant is one hundred percent vested in Employer contributions upon retirement, permanent disability or death.

Investment Options

Contributions to the Plan are invested as directed by Participants in one or more mutual funds offered by the Plan. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may range from one to five years. The loans are secured by the participant's account and bear interest equal to 1% over the prime interest rate at the time funds are borrowed. Principal and interest are paid through payroll deductions.

Forfeitures

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. Under the terms of the Plan agreement, forfeitures are used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At December 31, 2024 and 2023, the balance of forfeited accounts totaled approximately \$65,700 and \$41,400, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce the Employer's contribution.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant (or designated beneficiary) may elect to receive an amount equal to the value accumulated in his or her account in either a lump-sum amount, a partial payment or in periodic installments over a period to be selected by the participant (or beneficiary) from several options under the Plan.

For terminations of service due to other reasons, a participant may receive the value accumulated in his or her account as a lump-sum distribution or, if the account balance exceeds \$5,000 on the date of termination, may leave the account under the Plan until the participant reaches normal retirement age or dies. In-service distributions after a participant's attainment of age 59 ½ are permitted as specified in the Plan agreement.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for further discussion on the determination of fair value amounts.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes realized and unrealized gains and losses on investments bought and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded in accordance with the Internal Revenue Code.

Payments of Benefits

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that were not yet paid as of December 31, 2024 and 2023.

Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 3: INFORMATION PREPARED AND CERTIFIED BY PLAN CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan's investments and related investment activity reflected in the financial statements and supplemental schedules was certified by the Plan's custodian, Nationwide Trust Company, FSB as of December 31, 2024 and 2023, and for the year ended December 31, 2024. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedules.

The following information included in the accompanying financial statements, related notes and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the Plan's custodian.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5: TAX STATUS

Effective January 1, 2020, the Plan executed an adoption agreement for the National Benefit Services, LLC Defined Contribution Pre-Approved Plan (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

The IRS has determined and informed the Prototype sponsor by a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe the Plan is qualified and the related trust is tax-exempt.

Accounting standards require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

NOTE 6: RISKS AND UNCERTAINTIES

The mutual funds in which the Plan's assets are invested are comprised of investment securities, which are exposed to various risks such as interest rate, market and credit risks. Certain mutual funds may invest in foreign securities. There are certain additional risks involved when investing in foreign securities that are not present with investments in domestic securities.

NOTE 6: RISKS AND UNCERTAINTIES (Continued)

These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

NOTE 7: SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 13, 2025, the date that the financial statements were available to be issued.

Subsequent to year end, the Plan Sponsor elected to change third-party administrator and asset custodian.
