## Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of the Tuolumne Band of Me-Wuk Indians (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan, adopted September 1, 2001, covering substantially all employees of the Tuolumne Band of Me-Wuk Indians and all related divisions (the Tribe). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments. The Tribe is the Plan's sponsor and serves as Plan administrator, which is responsible for establishing Plan benefits, contributions, and other provisions, and for approving all Plan amendments. At December 31, 2024, there were 1,071 total participants, consisting of 891 active participants, and 180 retired or separated participants.

**Eligibility** – Employees who have completed three months of service are eligible to participate in the elective deferral and employer matching portions of the Plan. Eligible employees may begin participating on the first day of the month following completion of the eligibility requirements.

**Administration** – Effective February 1, 2024, USI Consulting Group became the Plan's recordkeeper and Charles Schwab Trust Bank became the Plan's custodian.

### Contributions

*Participant contributions* - Each year, participants may contribute between 1% and 100% of pre-tax, eligible compensation to the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

*Employer safe harbor match and discretionary contributions* - The Company makes safe harbor employer matching contributions equal to 100% of each participant's elective deferral up to 3% of the participant's compensation and 50% of each participant's elective deferral above 3% up to a maximum match of 5% of the participant's compensation. Participants are 100% vested in all safe harbor employer contributions. The Tribe can elect to make discretionary matching contributions to the Plan. There were no discretionary contributions during 2024.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contribution, and allocations of actual earnings from their investment selections and are charged with an allocation of administrative expenses. Allocations are based on participant contributions, compensation, or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are fully vested in their salary deferrals, safe harbor employer contributions, and actual earnings thereon. Vesting in discretionary matching contributions is based on years of service with increases in increments of 33% per year until fully vested after three years.

## Tuolumne Me-Wuk Tribal Council Retirement 401(k) Plan Notes to Financial Statements

---

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the balance of the participant's account and bear fixed, reasonable rates of interest, as determined by the Plan administrator. The maximum loan term is five years unless the loan term qualifies as a home loan, in which case the term of the loan is not to exceed 30 years. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the interest rates on outstanding loans ranged from 4.25% to 9.50%, with various maturities through September 2038.

**Payment of benefits** – On termination of service due to death, disability, or retirement, participants will receive their benefit in a lump-sum amount equal to the value of the participant's account balance. For termination of service for other reasons, or for participants whose account balance is under \$5,000, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution.

**Hardship withdrawals** – Participants, under certain conditions, are permitted to withdraw the employee contribution portion of their account balance. These conditions involve unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, to prevent eviction or foreclosure from the participant's principal residence, payments for burial or funeral expenses, or expenses for repair of principal residence.

**Forfeitures** – Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and are used to pay Plan administrative expenses or reduce nonelective and matching contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$46,308 and \$67,993, respectively. For the year ended December 31, 2024, \$13,150 was used for payment of Plan expenses.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America as applied to governmental units, using the accrual method of accounting. The Governmental Accounting Standards Board (GASB) is the accepted standard setting body for establishing governmental accounting and financial reporting principles.

**Use of estimates** – The preparation of financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – Investments are stated at fair value as certified by the Plan's former trustee, Capital Bank and Trust Company, and the Plan's current trustee, Charles Schwab Trust Bank. Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments consists of both the realized gains or losses, and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the related participant compensation is earned.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued, but unpaid interest, and are classified as notes receivable. Delinquent notes receivable from participants are recorded as distributions upon the occurrence of a distributable event based on the terms of the Plan agreement.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Administrative expenses are paid by the Tribe. Certain transaction fees are paid by participants directly from their accounts.

### Note 3 – Investments

Investment securities are exposed to various risks that can affect the value of the Plan's investments such as custodial credit risk, interest rate risk, credit risk, concentration risk, and foreign currency risk. The Plan invests in registered investment companies (mutual funds). Mutual fund holdings in equity securities respond to such factors as economic conditions, individual company earnings performance, and market liquidity, while holdings in debt securities are particularly sensitive to credit risk and change in interest rates.

**Custodial credit risk** – Custodial credit risk is the risk that in the event of a failure by the counterparty, the Plan will not be able to recover the value of its investments that are in the possession of an outside party. The Plan's policies do not specifically address custodial credit risk, but all the Plan's investments are insured or registered, or held by the Plan or its agent in the Plan's name.

**Interest rate risk** – Interest rate risk arises from the likelihood that interest rates will rise or fall during the holding period of a fixed rate security and adversely affect the selling price of the security prior to maturity. The price of a debt security typically moves in the opposite direction of the change in interest rates.

**Foreign currency risk** – Foreign currency risk is the risk that changes in exchange rates will adversely impact the fair value of an investment denominated in a foreign currency. The Plan’s foreign currency risk exposure resides within the international mutual fund holdings. The Plan does not hold any direct investments or instruments denominated in a foreign currency.

**Credit risk** – Credit risk exists when there is a possibility that the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. As of December 31, 2024, the Plan had the following credit quality mix in its fixed income securities:

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (Mutual funds and money market funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trusts* – Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The CT can be redeemed daily, and there are no redemption restrictions or notice requirements.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5 – Tax Status**

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the form of the volume submitter plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### **Note 6 – Certified Investment Information**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, trustee of the plan until February 1, 2024, and Charles Schwab Trust Bank, the current trustee of the Plan from February 2, 2024, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net position available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net position available for benefits for the year ended December 31, 2024.
- Investments reflected on the supplemental schedule of assets (held at end of year).

### **Note 7 – Party-in-Interest Transactions**

Plan investments included shares of American Funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company was the trustee of the Plan and, therefore, transactions with this company qualified as exempt party-in-interest transactions. At December 31, 2024 there were no plan investments with parties-in-interest. All transactions with Charles Schwab Trust Bank qualify as exempt party-in-interest transactions.

### **Note 8 – Plan Termination**

Although it has not expressed any intention to do so, the Tribe has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, amounts allocated to participant's accounts become fully vested.

### **Note 9 – Reconciliation to Form 5500**

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net position available for benefits for either year.

### **Note 10 – Delinquent Participant Contributions**
