### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Boys and Girls Aid Society of Oregon Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. **Notes to Financial Statements**

---

**1. Description of Plan**

The following description of The Boys and Girls Aid Society of Oregon Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all eligible employees of The Boys & Girls Aid Society of Oregon, dba Boys & Girls Aid (the Agency) subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan, and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The custodians of the Plan are Teachers Insurance and Annuity Association of America (TIAA), and College Retirement Equities Fund (CREF) (collectively, the custodians). All participant account balances are held by TIAA and CREF.

**Eligibility** - All permissible employees of the Agency, as defined in accordance with the universal availability standards, are eligible to enroll and participate on their date of hire.

**Contributions** - Each year, participants may contribute up to 100 percent of their annual pre-tax compensation, as defined in the Plan, subject to statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Agency will match 100 percent of each participant's elective deferrals up to 3 percent of participant compensation, plus 50 percent of each participant's elective deferrals in excess of 3 percent but not in excess of 5 percent of the participant's compensation.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, allocations of the Agency's matching contributions, and Plan earnings or losses. Participants' accounts are charged with any distributions made to the participant and with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options** - Upon enrollment in the Plan, participants are responsible for directing the investment of their contributions, the Agency's contributions, and any earnings thereon into various annuity contracts and custodial accounts offered by the Plan.

**Vesting** - Participants are immediately vested in their contributions, the Agency's matching contributions, and actual earnings thereon.

**1. Description of Plan - Continued**

**Notes Receivable from Participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans are secured by the balance of the participant's vested account. In accordance with the Plan provisions, the rate of interest on participant loans approximates current market rates and is 8 percent as of December 31, 2024, with maturity dates through November 2028. The term of the loan may not exceed five years unless the proceeds of such loan are to be used to acquire any dwelling unit, which within a reasonable time is to be used as the principal residence of the participant. Principal and interest is paid ratably through payroll deductions.

**Plan Expenses** - Substantially all of the expenses of maintaining the Plan are paid by the Agency, and are excluded from these financial statements. Investment related expenses are included in net increase in fair value of investments.

**Participant Rollovers** - Participants are allowed to transfer or roll over funds into the Plan from another qualified plan.

**Payment of Benefits** - On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested account, or in periodic installments. For termination of service for other reasons, a participant may receive the balance of their contribution and actual earnings thereon either in a lump sum or in periodic installments.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** - The preparation of financial statements, in conformity with GAAP, requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administration expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**2. Summary of Significant Accounting Policies - Continued**

**Investment Valuation and Income Recognition** - At December 31, 2024 and 2023, the Plan's investments in pooled separate accounts, shares of registered investment companies, and non-benefit responsive fixed annuity contracts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance companies. The net increase or decrease in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned and dividends are recorded as of the ex-dividend date.

**Payment of Benefits** - Benefits paid to participants are recorded when paid. At December 31, 2024 and 2023, there were no benefits processed and approved for payment, but not paid.

**Income Tax Status** - Effective January 1, 2019, the Plan adopted the volume submitter 403(b) plan document of TIAA, the sponsor of the volume submitter document. The Internal Revenue Service (IRS) has determined and informed the sponsor of the volume submitter document submitted by a letter dated August 7, 2017, that the volume submitter plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Subsequent Events** - The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**3. Certified Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF (the custodians of the Plan).

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies* - Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

*TIAA Real Estate pooled separate account* - The TIAA Real Estate Account, which is a pooled separate account, is a single account that invests primarily in real estate holdings. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. Participants redeeming units from the TIAA Real Estate Account may only do so once per calendar quarter. Units of the pooled separate account are valued using the NAV of units held by the Plan and are valued at the closing price reported on the active market on which the individual securities are traded or listed. As such, pursuant to ASU 2015-10, Plan management has presented this as a Level 1 investment in the fair value hierarchy.

*TIAA Access pooled separate accounts* - Fair value of the TIAA Access pooled separate accounts is determined by reference to net asset value per unit as provided by TIAA. Net asset values per unit are derived from values of similar investments that have quoted prices in active markets. The net asset value is used as a practical expedient to estimate fair value, and is based on the fair value of the underlying investments less liabilities.

*TIAA Traditional Annuity* - Investments in TIAA Traditional Annuity non benefit-responsive fixed annuity contract are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value of the TIAA Traditional Annuity equals the accumulated cash contributions and interest credited to the contract, less any withdrawals.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Transactions with Parties-in-Interest**

The Plan invests in annuity contracts and custodial accounts that are sponsored or managed by the Plan's custodians. These investments and investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net increase or decrease in fair value of investments, as they are paid through revenue sharing, rather than direct payment.

Participants are permitted to borrow funds from their vested account balance as described in *Note 1*. Notes receivable from participants and the related interest earned are described in *Note 2*.

The Agency is the Plan sponsor and pays for administrative expenses on behalf of the Plan, including accounting, legal, and consulting fees on behalf of the Plan.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA provisions. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**7. Risks and Uncertainties**

The Plan invests in a variety of investments. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible changes in the values of investment securities will occur in the near-term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.



