## **INDEPENDENT AUDITOR'S REPORT**

To the Trustees and Participants  
The Towbes Group Salary Savings Plan  
Santa Barbara, California

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of The Towbes Group Salary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Towbes Group Salary Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Empower Trust Company, LLC as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by Empower Trust Company, LLC agrees to, or is derived from, in all material respects, the information prepared and certified by Empower Trust Company, LLC that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Towbes Group Salary Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. ## NOTES TO FINANCIAL STATEMENTS

### Note 1 - DESCRIPTION OF THE PLAN

The following description of The Towbes Group Salary Savings Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of The Towbes Group Inc. (“the Employer”) who have attained age 21 and are not excluded employees of unions, nonresidents, or interns. Seasonal or temporary employees must also complete one year of service. Employees who participate in the plan are also eligible for matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may contribute 100% of their annual pretax wages up to the amount as defined in the Plan. The Employer will contribute annually a 100% match of the employee’s contribution not to exceed 5% of the employee’s eligible salary. Additional amounts may be contributed at the option of the Employer’s board of directors.

#### Investments

Investments are held in participant-directed investment funds. The participants select the percentage of contributions to be allocated to each investment option. Participants’ contributions are withheld from their paychecks and remitted to the trustees. The participants’ accounts are credited with the actual earnings on the underlying investments and are charged for Plan withdrawals by the trustees. Earnings on investments include interest income, realized and unrealized gains and losses, and dividends from pooled separate accounts. The pooled separate accounts as reported by the trustees are included in the statements of net assets available for benefits at December 31, 2024 and 2023, at fair value.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and distributions, and an allocation of the Employer’s contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and earnings. Employer contributions and earnings are vested over a six-year period as follows: 20% after two years of service, an additional 20% for each year of service thereafter, with 100% vesting after six years of service.

## NOTES TO FINANCIAL STATEMENTS

### Note 1 - DESCRIPTION OF THE PLAN (continued)

#### Payment of Benefits

Benefits are recorded when paid. On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account, or annual installments over a time period designated by the participant.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$8,005 and \$28,083, respectively. These amounts are used to reduce future employer contributions. For the year ended December 31, 2024, forfeitures totaled \$25,122 and employer contributions were reduced by \$23,416 from forfeited non-vested accounts.

#### Death Benefits and Disability

Upon the death or disability of a participant before retirement or termination of employment, the current balance of the participant's individual account becomes fully vested and will be paid to his designated beneficiary in either a lump sum or installment payments, as chosen by the beneficiary.

#### Notes Receivable From Participants

Participants in the Plan may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loan transactions are treated as transfers between the investment fund and the loan fund. Monthly repayments are automatically deducted from the participant's wages. Loan terms range from one to five years, or greater than five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a fixed interest rate of 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### Note 2 - SUMMARY OF ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

### Note 2 - SUMMARY OF ACCOUNTING POLICIES (continued)

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract (stable fund), which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Subsequent Events

The Plan's Trustees have evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

### Note 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments (\$10,449,673 and \$10,250,900) and notes receivable from participants (\$132,941 and \$169,355) held at December 31, 2024 and 2023, respectively, and net appreciation in fair value of investments (\$792,212), dividend income (\$375,426), and interest income on notes receivable from participants (\$12,064) for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC.

### Note 4 - PLAN EXPENSES

Accounting and administrative expenses incurred in the administration of the plan are paid by the Employer and are not allocated to individual participant accounts.

### Note 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 5 - RISKS AND UNCERTAINTIES (continued)

The Plan investments in funds which invest in securities of foreign countries, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those securities of comparable U.S. companies.

### Note 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### Note 7 - TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter, however, the Plan's administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in accordance with the applicable requirements of the Internal Revenue Code.

The Plan evaluates uncertain tax positions, whereby the effect of the uncertainty would be recorded if the outcome was considered probable and reasonably estimable. As of December 31, 2024, the Plan had no uncertain tax positions requiring accrual.

The Plan files tax returns under U.S. federal jurisdiction. The Plan is no longer subject to U.S. federal tax examinations by tax authorities for years before 2021.

### Note 8 - PARTY-IN-INTEREST TRANSACTIONS

Empower Trust Company, LLC is a party-in-interest with respect to the Plan. The records of the Plan indicate no party-in-interest transactions which are prohibited by ERISA Section 406 and for which no statutory or administrative exemption exists.

#### Note 9 - STABLE FUND INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Trust Company, LLC totaling \$14,789 for 2024 and \$87,420 for 2023. Empower Trust Company, LLC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The issuer resets the crediting interest rate annually. The minimum guaranteed interest rate varies for each contract year and may be modified by the custodian prior to the renewal date of the contract upon occurrence of specific events as provided in the contract. The crediting interest rate is based upon many factors, including estimated future earnings rate (the rate at which investments mature) and future cash flows.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Empower Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### Note 10 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:
