## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
of Gastrointestinal Specialists of  
Georgia, Inc. 401(k) Profit Sharing Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Gastrointestinal Specialists of Georgia, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is

not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedules Required by ERISA***

The supplemental schedules, Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, and Schedule H, Line 4i – Schedule of Assets Held at Year End as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A--DESCRIPTION OF PLAN

The following brief description of the Gastrointestinal Specialists of Georgia, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document and subsequent amendments for more complete descriptions of the Plan's provisions.

*General:* The Plan is a defined contribution plan which provides retirement benefits for substantially all employees of Gastrointestinal Specialists of Georgia, Inc. (the Sponsor) and nine participating employees that are related to the Sponsor. Prior to January 1, 2025, the nine participating employees were 1099 independent contractors. As of January 1, 2025, these nine individuals became employees of the Sponsor and are no longer 1099 independent contractors. Effective January 1, 2025, the plan was amended as part of this employment restructuring. This amendment did not affect any of the plan specifications as described below. Matrix Trust Company serves as trustee for the Plan (the trustee). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

*Eligibility:* Employees of the Sponsor who have attained age 20.5 are eligible to participate in the Plan after completing one year of service, as defined in the Plan document.

*Contributions:* Each year, participants may elect to contribute to the Plan through payroll deductions, up to 100% of their compensation on a tax-deferred basis, subject to certain limitations as determined annually by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans.

The Plan provides for employer Qualified Automatic Contribution Arrangement safe harbor matching contributions for the benefit of all eligible employees of the employer equal to 100% of salary deferrals up to 1% of eligible participant compensation, plus 50% of salary deferrals between 1% and 6% of participant compensation. Matching contributions for salary deferrals greater than 6% are limited to 3.5% of compensation.

In addition, the Employer may make discretionary profit-sharing contributions for the benefit of participants with 500 hours of service. Discretionary profit-sharing contributions are allocated based on a group allocation formula. This contribution is determined by first dividing the participant population into "classification groups." Next, each classification group receives either a percentage of compensation or a dollar amount with a specified percentage of the contribution amount. Any portion of an employer contribution not yet allocated would be allocated based on total eligible compensation. The discretionary contribution for the year ended December 31, 2024, ranged from 3.28% to 9.83%.

*Participant Accounts:* Employee and employer contributions are allocated to participant-directed investments in mutual funds and collective trusts selected by the Sponsor, or individually managed brokerage accounts. Income, losses, and changes in market value of the mutual funds and brokerage accounts are reflected in daily market valuations of the funds.

*Vesting:* Participants are always 100% vested in their employee contributions. Participants vest in qualified safe harbor employer matching contributions after two years of service. Participants vest in employer discretionary contributions in accordance with the following schedule:

*Notes Receivable from Participants:* Participants may borrow from their investment account balances up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. All loans must be repaid within five years from the date the loan is made, except that a loan used to acquire a principal residence may have a term determined by the Plan Administrator in accordance with the provisions of the Plan, not to exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits:* On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the participant's interest in his or her account as a lump-sum distribution. A participant may be eligible to receive a distribution of his or her account in the case of financial hardship. Distribution, for this reason, is subject to approval by the Plan Administrator in accordance with the provisions of the Plan.

*Forfeitures:* Forfeitures are utilized to reduce employer contributions and pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts were approximately \$14,000 and \$15,100, respectively, and are included in investments in the Statements of Net Assets Available for Benefits. During the year ended December 31, 2024, forfeited non-vested accounts of approximately \$15,100 were used.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting:* The accompanying financial statements of the Plan are prepared on the accrual basis of accounting and have been prepared in accordance with Generally Accepted Accounting Principles in the United States of America (U.S. GAAP).

*Use of Estimates:* The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

*Investment Valuation and Income Recognition:* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year, as well as held at year end.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

*Benefit Payments:* Benefit payments are recorded when paid. There were no accounts for which benefits had been requested and approved for payment but not paid as of December 31, 2024.

*Administrative Expenses:* Administrative costs, primarily consisting of legal, accounting, and recordkeeping fees, can be paid from Plan assets to the extent not paid by the Plan sponsor.

NOTE C--INFORMATION CERTIFIED BY THE TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Matrix Trust Company and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

Certain participant self-directed brokerage accounts are held by investment companies. Some of the self-directed brokerage accounts are held by Matrix Trust Company and are certified as disclosed above. Investment information related to some of these accounts, including net appreciation in fair value of investments and dividends and interest, has not been certified as complete and accurate by the trustee.

**NOTE D--FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
  - Quoted prices for similar assets and liabilities in active markets;
  - Quoted prices for identical or similar assets and liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

- *Participant Directed Investments:* These investments consist of shares of various mutual funds. These amounts are valued based on quoted prices in an active market.
- *Participant Self-Directed Brokerage Accounts:* These assets consist principally of cash and cash equivalents, shares of mutual funds, exchange traded funds, and common stocks. All such assets are valued based on readily determinable market prices. Bonds are valued using observable market data and are categorized as Level 2 investments.

Also included in participant self-directed brokerage accounts is a real estate investment which is categorized as Level 3 investments. This investment is valued based on the nature of the portfolio and the percentage of ownership in the underlying investment asset. The valuation of this investment is supported by information received from the investee companies such as periodic statements and investor reports. At December 31, 2024 and 2023, the value of the real estate investment totaled \$874,030 and \$603,933, respectively, and is included in investments for participant self-directed brokerage accounts in the accompanying Statements of Net Assets Available for Benefits. \$270,097 of appreciation in value related to this real estate investment was recognized during year ended December 31, 2024 and is recorded in net appreciation in fair value of investments for participant self-directed brokerage and bank accounts in the accompanying Statement of Changes in Net Assets Available for Benefits.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. The valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The investment valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

**NOTE E--INCOME TAX STATUS**

The Plan Administrator obtained a determination letter, in which the Internal Revenue Service stated that the prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving such determination, but the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan Administrator has evaluated the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their account balances.

**NOTE G--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Truist Advisory Services. Matrix Trust Company is the trustee for the Plan. Transactions with the trustee qualify as party-in-interest transactions. Fees paid to Truist Advisory Services and Matrix Trust Company for the year ended December 31, 2024, were approximately \$45,700 and \$4,500, respectively. These fees are included as a part of administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits.

**NOTE H--RISKS AND UNCERTAINTIES**

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE I--SUBSEQUENT EVENTS**
