### 1. DESCRIPTION OF THE PLAN

The following description of the CTR Management, Inc. 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established by CTR Management, Inc. (the Company) effective January 1, 2000. Effective October 9, 2023, the Plan was amended to add a Roth provision. Effective January 1, 2024, the Plan implemented certain provisions of the SECURE 2.0 Act. Although the Plan is operating in compliance with this provision, the pre-approved plan document reflecting this change has not yet been adopted. The Plan intends to adopt the required amendment by December 31, 2026, the deadline prescribed under the SECURE 2.0 Act. The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 (ERISA) and was most recently amended effective March 18, 2025, to clarify the Roth provision wording with the Plan document.

#### **Eligibility**

All employees, with the exception of leased employees and independent contractors, are eligible to participate in the Plan after completion of 6 months of service and the attainment of age 21. Entry dates into the Plan are on the first day of the quarter following the date on which the eligibility requirements are met.

#### **Participant Contributions**

Participants may contribute up to 100% of their eligible compensation, as defined by the Plan, or a flat dollar amount, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for each of the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for both of the years ended December 31, 2024 and 2023. Effective October 9, 2023, participants may also contribute post-tax Roth elective contributions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants are also permitted to make rollover contributions from other qualified plans into the Plan.

### 1. DESCRIPTION OF THE PLAN – cont'd.

#### Company Contributions

The Company may make discretionary matching contributions to participants each plan year. For the years ended December 31, 2024 and 2023, the Company contributed each pay period up to 3% of a participant's salary deferred into the Plan not to exceed \$10,000 per Plan year. Discretionary matching contributions totaled \$290,517 and \$274,791 for the years ended December 31, 2024 and 2023, respectively. Additional discretionary non-elective profit sharing contributions may be made at the option of the Company's management. Participants must work a minimum of 500 hours during the Plan year and be employed on the last day of the year in order to be eligible for profit sharing contributions. Such contributions are allocated based on relative compensation for each participant. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary contributions to the Plan.

#### Participant Accounts

Each participant's account is participant-directed and credited with the participant's contributions, withdrawals and allocations of a) the Company's contributions, and b) Plan earnings. Allocations of earnings and losses are based on the proportion of each participant's account balance to the total of all account balances within the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in Company matching and profit sharing contributions plus earnings thereon based on years of service, as defined by the Plan agreement, according to the following schedule:

#### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regards to the intended use of the funds. The minimum note amount is \$1,000 and no more than two notes per participant may be outstanding at any time. Notes are collateralized by the participant's vested account balance. Note repayments are to be made on a per payroll basis with interest based on interest rates comparable to those offered by financial institutions at the time of loan issuance (prime plus 1%). Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence may be repaid within a reasonable amount of time, to be determined at the time the loan is made.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are treated as distributions based upon the terms of the Plan document.

#### Payment of Benefits

Upon termination of service, death, disability, normal retirement at age 65, or attainment of 59 ½, a participant or their beneficiary, in the event of death, may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Upon termination of services, participants with vested account balances of less than \$1,000 will automatically be cashed out. Prior to retirement, the Plan at any time. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, vested amounts contributed may be withdrawn for hardship purposes. Effective January 1, 2024, the Company adopted the SECURE Act provision to increase the amount to \$7,000 and is currently in the process of formally amending the Plan for this provision. Distributions are subject to the applicable provisions of the Plan. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

#### Forfeitures

Forfeitures of Company contributions may be applied to pay administrative expense or reduce future Company contributions. Forfeitures become available to the Plan in the year of forfeiture. There were \$24,584 and \$18,075 forfeited non-vested contributions available as of December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, \$13,045 and \$11,070, respectively, of forfeitures were used to pay administrative expenses or reduce Company contributions.

#### Plan Expenses

All direct expenses are paid with assets of the Plan, unless paid by the Company, at its discretion. During the years ended December 31, 2024 and 2023, the Company paid a portion of the direct expenses related to the Plan. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. Distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

#### Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions to the Plan would cease and all affected participants would become 100% vested in their accounts.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interest bearing cash:* Valued at amortized cost plus accrued interest, which approximates fair value.

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 9, 2025, the date the financial statements were available to be issued, and determined there were no material subsequent events that required disclosure, except as disclosed in Note 1.

### 3. INVESTMENTS

All investment data disclosed in the accompanying financial statements and supplemental schedules, including assets held as of December 31, 2024 and 2023 and interest and dividend income and net appreciation in the fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus, as authorized agent of Ascensus Trust Company, the Trustee of the Plan.

### 4. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are held by Ascensus and Vanguard, who are related to the directed Trustee for the Plan. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 5. INCOME TAX STATUS

The pre-approved plan document, which the Plan was designed, received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since the issuance of the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan did not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements.

The Plan is subject to routine audits by the IRS and the DOL; however, there are currently no audits for any periods in progress.

### 6. EXCESS CONTRIBUTIONS PAYABLE

During the year ended December 31, 2024 and 2023, the Plan failed to comply with certain non-discrimination rules. As a result of failing these tests, the Plan was required to refund the excess contributions to certain affected participants. As of December 31, 2024 and 2023, corrections were required to be made totaling \$47,568 and \$22,967, respectively, and are recorded as excess contributions payable in the accompanying statements of net assets available for benefits. The refund payments were made in April 2025 and March 2024, respectively.

### 8. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Plan Sponsor discovered that during the year ended December 31, 2023, \$719 of participant contributions were not remitted to the Plan within the required timeframe as stated by the DOL. As of December 31, 2024, management has corrected the late remittance related to the year ended December 31, 2023.

### 9. OPERATIONAL FAILURE

During the year ended December 31, 2024, the Company became aware of a certain operational failure with respect to the definition of compensation within the most recently amended plan document. Management is working with Ascensus, Vanguard and legal counsel to correct these matters in accordance with procedures under the IRS Employee Plans Compliance Resolution System to avoid any penalties to the Plan or Plan Sponsor and preserve the tax status of the Plan. No participants were adversely affected by this operational failure, and the Company does not expect that the correction of the operational failure will result in any material adjustments to the Plan’s financial statements.
