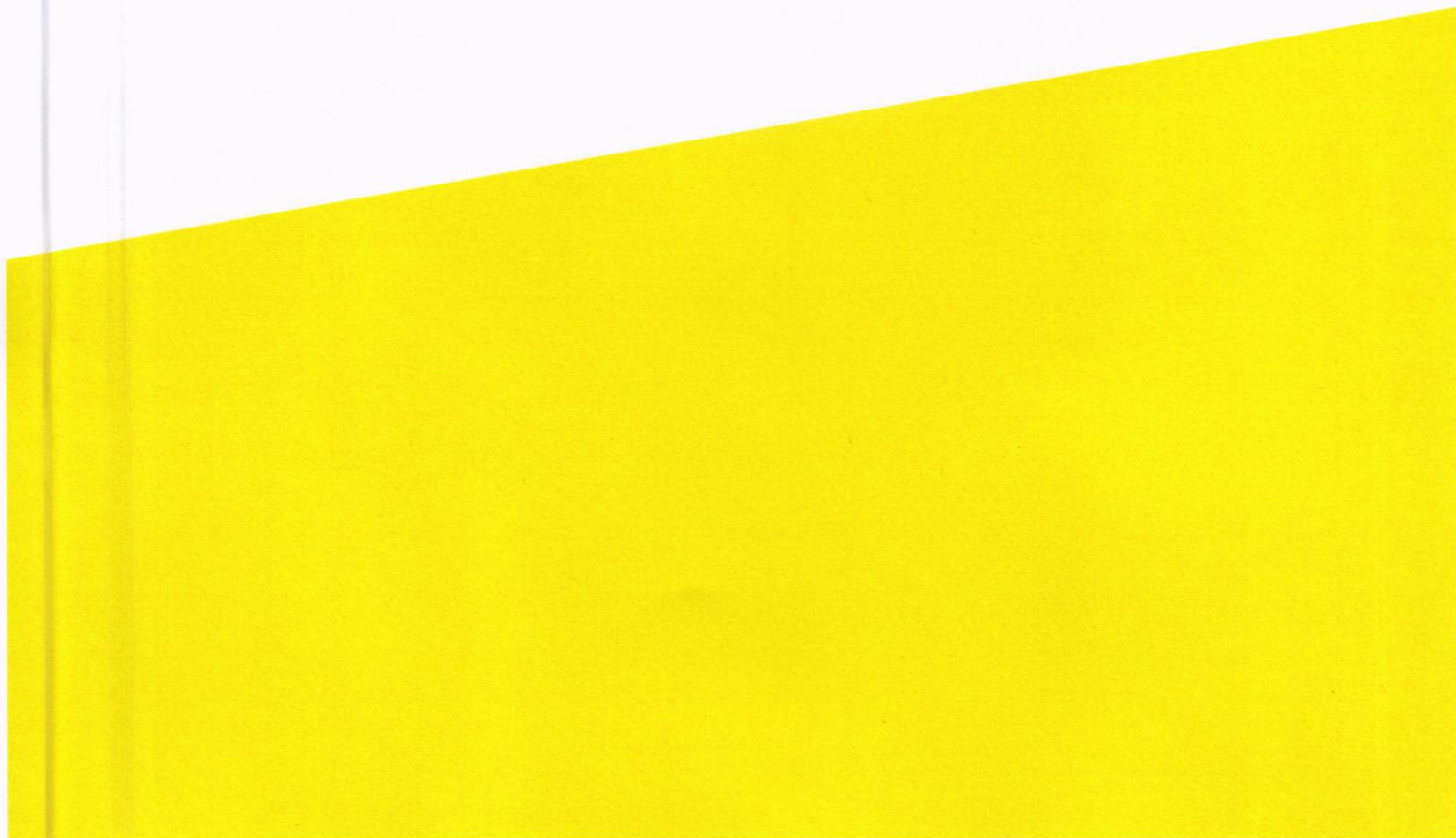

## Report of Independent Auditors

To the Participants and Plan Administrator of  
Docomo Pacific, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Docomo Pacific, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

December 31, 2024 and 2023

### **1. Description of the Plan**

The following description of the Docomo Pacific, Inc. 401(k) Profit Sharing Plan (the Plan) provides general information about the Plan's provisions. Docomo Pacific, Inc. (the Company) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

#### **General**

The Plan is a defined contribution plan covering essentially all employees of the Company who have completed three months of service as defined in the Plan. Eligible participants are automatically enrolled in the Plan once they have completed three months of service unless they affirmatively decline to participate.

For employees employed by the Company as of January 1, 1997, the effective date of the Plan, the service requirement was waived upon entering the Plan on this date. The Plan does not cover union employees and non-resident aliens. For eligibility purposes, the years of service with Guam Cablevision LLC, CNMI Cablevision LLC, and Guam Telecom LLC are counted. ASC Trust, LLC (ASC) is the trustee and recordkeeper for the Plan. The Company is responsible for the general administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Each year, participants may contribute up to the maximum amount of their annual compensation allowable under the provisions of the Internal Revenue Code (IRC). If automatically enrolled, a participant's deferral is set at 3% of eligible compensation and will be increased in 1% increments for each succeeding plan year of participation up to a maximum of 6% until changed by the participant. The Plan permits the participants to withdraw the automatic deferral within 90 days. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Company makes Enhanced Matching Contributions to the account of each eligible participant in an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 2% of the participant's eligible compensation, plus 50% of the participant's elective deferrals that exceed 2% but do not exceed 5% of the participant's eligible compensation. The Company may also elect to make matching contributions equal to a percentage of participants' deferrals. In addition, the Company may elect to make discretionary profit sharing contributions. No such amounts were contributed for the Plan year ended December 31, 2024. The Plan also permits rollover contributions from other qualified plans based on the Plan Administrator's discretion.

## Notes to Financial Statements, continued

### 1. Description of the Plan, continued

#### Contributions, continued

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants who are automatically enrolled have their contributions invested in the applicable lifecycle fund based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching and discretionary contributions, if applicable, and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary profit sharing contributions plus actual earnings thereon is based on years of service as follows:

A participant shall become fully vested at the time of death, permanent disability or attaining early retirement age of Plan termination.

##### **Forfeited Accounts**

Forfeitures occur when participants leave the Company and are not fully vested in the Plan. Forfeitures are first applied to pay plan expenses then applied to reduce the employer contributions for the remaining balance. Unallocated forfeiture balances as of December 31, 2024 and 2023 totaled \$34,064 and nil, respectively. For the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or pay administrative expenses.

##### **Participant Loans**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may have a term of five years except when the loan is used to purchase a principal residence, which will be 30 years. A participant may not have more than one personal loan and one primary residence loan outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest based on the U.S. prime interest rate prevailing at the time of the loan is granted, plus one percent. Principal and interest are paid through periodic payroll deductions. Loan transactions are recorded as a transfer from the investment funds to the corresponding participant's notes receivable. The balance of the loan will be due upon termination of employment unless directly rolled over to another employer's plan, otherwise the loan will be declared in default. A loan is deemed to be in default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the Participant missed the scheduled payment.

##### **Payment of Benefits**

Upon separation of service with the Company due to retirement, disability, death or termination, a participant may elect to receive either a lump-sum or elect a direct rollover to another qualified plan. A participant whose vested account balance is \$5,000 or less will automatically receive an immediate lump-sum distribution equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available loan options and available distributions prior to requesting hardship withdrawals.

##### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company and are excluded from the financial statements.

#### **1. Description of the Plan, continued**

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### **Contributions**

Participant contributions and the matching employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Loan maintenance fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### **2. Summary of Significant Accounting Policies, continued**

##### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **3. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by ASC.

##### **4. Fair Value Measurements**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 - Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

#### 4. Fair Value Measurements, continued

Following is a description of the valuation methodologies and inputs used for each general type of investment measured at fair value by the Plan:

*Common/collective trust funds:* The common /collective trust fund investments are valued at their fair value that is readily determinable, published and is the basis for current transactions. These funds are classified within level 1 of the valuation hierarchy.

*Registered Investment Companies (RIC):* RIC consist primarily of mutual fund investments. Mutual fund investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. #### **6. Tax Status**

The underlying prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the written form of the underlying prototype document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Party-in-Interest Transactions**

The Plan holds units of common/collective trust funds managed by ASC, the trustee and recordkeeper for the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

#### **8. Subsequent Events**

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued.
