Report of Independent Auditors

To the Administrator of Raytheon Company Disability Plan

Opinion

We have audited the accompanying financial statements of Raytheon Company Disability Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Notes to Financial Statements

As of December 31, 2024 and 2023

Note 1 - Plan Description

The following description of the Raytheon Company Disability Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a complete description of the Plan’s provisions.

The Raytheon Employees Disability Trust (the “Trust”) was established on January 1, 1982, as a funding vehicle for the Plan. For eligible employees of Raytheon Company (the “Company” or “Sponsor”) and certain of its affiliates, the Plan provides Long Term Disability (“LTD”) benefits, LTD Occupational benefits, Short Term Disability (“STD”) “Plus” benefits that supplement the Company-paid STD benefit amount, and STD Basic benefits for employees not eligible for the Company-paid STD Basic benefit. The Plan is a voluntary welfare plan covering exempt and nonexempt salaried and hourly employees of the Company and certain subsidiaries and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Company is a wholly-owned subsidiary of RTX Corporation (“RTX”). The Plan Administrator of the Plan (for purposes of Section 3(16) of ERISA) is RTX and the Plan is administered by RTX Corporation’s Pension Administration and Investment Committee (“PAIC”), which operates pursuant to a vote of the RTX Board of Directors.

The Plan is funded solely by employee contributions and earnings on the investments of the Trust. The ability of the Plan to pay current and future disability benefits is maintained by periodic actuarial reviews of potential future events and resulting increases or decreases, as necessary, in the level of employee contributions.

Effective January 1, 2024, the Raytheon Insured Disability Plan (“Insured Plan”) was merged into the Plan. The Insured Plan offered certain fully insured disability coverage that was fully funded with employee contributions. There were no assets associated with the Insured Plan.

Benefits and Eligibility

The Plan provides specified LTD benefits and certain STD benefits to eligible employees to be paid from the net assets of the Trust. The level of benefits is based principally on the date of the disability, on the base compensation rate of the employee in effect at the time of disability, and on the level of coverage elected by the participant.

Full-time employees of Raytheon Company, or a participating affiliate, will be eligible to participate in this Plan as determined in accordance with the Plan Document.

Contributions

Contributions are made by participating employees principally through payroll withholdings. As determined in accordance with the Plan Document, participants may be required to contribute a percentage of their base earnings up to certain maximums dictated by federal tax law. Contributions are recorded during the period in which the Company makes payroll deductions.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 5 for investment valuation and income recognition policy. Fair value is defined as the price that would be received for an asset or the exit price that would be paid to transfer a liability in the principal or most advantageous market in an orderly transaction between market participants on the measurement date.

Other Assets

Other assets on the Statements of Net Assets Available for Benefits includes cash held outside of the Trust which is required to administer claims funding.

Claims Payments

Claims payments to participants are recorded when paid to participants.

Fully Insured Premiums

Fully insured premiums are recorded when paid.

Administrative Expenses

All direct expenses of the Plan are paid by the Plan and are included in the Statement of Changes in Net Assets Available for Benefits under "Administrative and other expenses."

Benefit Obligation

The Plan's benefit obligations are comprised of amounts currently payable to participants for the LTD claims, STD Plus claims, and STD Basic claims in addition to other future obligations for current benefit coverage for LTD claims.

The Plan's obligation for LTD claims is estimated by an external actuary based on the Plan's prior experience. This obligation represents the present value of future benefit payments relating to estimated claims (reported and approved claims and claims incurred but not reported) as of year-end.

The obligation is determined by applying actuarial assumptions to adjust the claims to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements for recovery or death).

The significant actuarial assumptions used in the December 31, 2024 and 2023 estimates are as follows:

Discount rate	5.29% at December 31, 2024 5.05% at December 31, 2023
Mortality and recovery rates	Based on Society of Actuaries 2008 GLTD Termination rate table

Obligations incurred but not reported ("IBNR") were developed based on claims through May 31, 2025, which represents approximately all claims incurred in 2024.

The foregoing actuarial assumptions are based on the assumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the Plan's benefit obligation.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of benefit obligations and net assets available for benefits at the date of the financial statements, the changes in plan benefit obligations, the changes in net assets available for benefits during the reporting period, claims incurred but not reported, claims payable and, when applicable, the disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Note 3 - Fair Value Measurements

The accounting standard for fair value measurements provides a framework for measuring fair value and requires expanded disclosures regarding fair value measurements. Fair value is defined as the price that would be received for an asset or the exit price that would be paid to transfer a liability in the principal or most advantageous market in an orderly transaction between market participants on the measurement date. The accounting standard established a fair value hierarchy which requires an entity to maximize the use of observable inputs, where available. The following summarizes the three levels of inputs required:

- Level 1:** Unadjusted quoted prices in active markets for identical assets or liabilities.
- Level 2:** Observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or have been corroborated by observable market data for substantially the full term of the related assets or liabilities.
- Level 3:** Unobservable inputs supported by little or no market activity that are significant to the fair value of the assets or liabilities.

A financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. See Valuation Policy section for further information.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The significance of transfers between levels was evaluated based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

As of December 31, 2024 and 2023, the investments held directly by the Plan were all valued using Level 1 inputs.

Note 4 - Funding Policy

The disability benefits to be provided under the Plan are funded by participant contributions and earnings on the investments of the Trust.

Note 5 - Investments

Investment Policy

The PAIC regularly reviews the asset allocations and performance of the investments in the Trust.

Investment securities are exposed to various risks, such as interest rate, market, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Valuation Policy

The Plan's investments are stated at fair value. BNY (the "Trustee" and "Custodian"), a party-in-interest, values investments as follows:

Cash and cash equivalents are valued at amortized cost, which approximates fair value.

Investments in registered investment companies are valued at their last reported net asset value.

When current market quotations are not readily available or do not accurately reflect fair value, investments are valued in a manner that is intended to reflect their fair value.

Investment Income (Loss)

Dividends are recorded on the ex-dividend date and interest income is accrued as earned. All security transactions are recorded on the trade date. Gains or losses on sales of securities are based on average cost.

The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the change in unrealized appreciation (depreciation) on those investments.

Note 6 - Certain Transactions Involving Related Parties and Parties-in-Interest

BNY is the Trustee and Custodian of the Plan and is therefore a party-in-interest with respect to the Plan and incurs expenses in connection with these services to the Plan and the Trust. Certain investments within the Trust were advised by or affiliated with BNY and are therefore a party-in-interest with respect to the Plan.

During 2022, the Company failed to remit \$8,192,042 in employee contributions to the Plan within the time period described in the Department of Labor's (DOL's) Regulation 2510.3-102 due to an administrative error. Late remittance of contributions constitutes a nonexempt prohibited transaction under ERISA. All late contributions were remitted to the Plan by December 31, 2022. The Company also remitted lost earnings of \$59,655 to the Plan by December 31, 2022 consistent with the DOL's Voluntary Fiduciary Correction Program ("VFCP"). The Company submitted a VFCP filing with the DOL on August 25, 2025.

During 2022 and 2023, prior to the Insured Plan merging into the Plan, a total of \$6,304,197 of expenses related to the Insured Plan were inadvertently paid by the Plan due to an administrative error. The Insured Plan reimbursed the Plan for \$1,019,152 in 2022, \$3,622,106 in 2023, and the remainder in 2024. Because the Insured Plan was unfunded prior to the merger into the Plan, these reimbursements to the Plan were funded from Company general assets. Lost earnings of \$895,444 related to this error were remitted to the Plan in 2024, of which \$257,578, \$492,133 and \$145,733 were attributable to lost earnings in 2022, 2023, and 2024, respectively. The amount due from the Insured Plan as of December 31, 2023 is included in "Due from Raytheon Insured Disability Plan" on the Statement of Net Assets Available for Benefits, and the lost earnings due to the Plan as of December 31, 2023 is included in "Interest and dividend income" on the Statement of Net Assets Available for Benefits. The lost earnings attributable to 2024 are included in "Interest and dividend income" on the Statement of Changes in Net Assets Available for Benefits.

Certain STD Plus and LTD claims for the year ended December 31, 2022 were paid by the Company in 2022. The Plan reimbursed the Company for these claims by April 2024. These claims are included in the "Payable to Raytheon Company for claims payments" on the Statement of Net Assets Available for Benefits as of December 31, 2023.

The Plan also incurs certain administrative expenses paid to parties-in-interest.

All transactions, with the exception of the 2022 late remittance of employee contributions and the 2022 and 2023 inadvertent payment of expenses related to the Insured Plan mentioned above, either fall outside the scope of, or are exempt from, ERISA's prohibited transaction rules.

Note 7 – Termination Policy

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to participants, discontinue the Plan, or terminate the Plan at any time, without prejudice, subject to the provisions set forth in ERISA.

Should the Plan be terminated, and should the Trustee receive written notice of the Plan's termination, the Trustee shall distribute all assets then constituting the Trust, less any fees and expenses payable from the Trust, pursuant to the Company's instructions. Such assets shall be used, in accordance with the Company's instructions, to provide

benefits described in Section 501(c)(9) of the Internal Revenue Code (“Code”) to Plan participants and their beneficiaries (or used as provided in 26 C.F.R. Section 1.501(c)(9)-4(d)), except as otherwise provided in regulations of the Department of Labor promulgated under Section 403(d)(2) of ERISA. Until all assets of the Trust are distributed, the Trust shall continue, and the Trust Agreement shall remain in effect.

Note 8 - Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated August 27, 1982, that, assuming that the Trust’s operations are as stated in its application for tax exemption, the Trust is exempt from federal income tax under Code Section 501(a), other than the tax on unrelated business income of the Trust, if any. The Plan and Trust have been amended and restated since receiving the determination letter. The Plan Administrator and the Company’s benefits counsel believe that the current design and operation of the Plan and Trust are consistent with the Trust’s continued tax exemption.

The Plan adopted the provisions of uncertain tax positions that provide criteria for the recognition, measurement, presentation and disclosure of uncertain tax positions. The Plan may from time to time hold investments that give rise to certain tax liabilities. Based upon management’s assessment, the Plan has not recognized any tax liabilities as of December 31, 2024 and 2023. The Plan is subject to examinations by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes the Plan is no longer subject to federal tax examination for years prior to 2021.

Note 9 - Risks and Uncertainties

Contributions to the Plan are made and the actuarial present value of benefit obligations and claims incurred but not reported are reported based on certain assumptions pertaining to interest rates, inflation rates, number of employees, employee compensation and demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. The investments of the Plan are exposed to various risks, such as interest rate, market, and credit risks. See Note 5 for additional information with respect to investment risk.

Note 10 - Subsequent Events

The Plan has evaluated subsequent events and transactions subsequent to December 31, 2024 through the date the Plan’s financial statements were available to be issued, October 14, 2025.
