REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Psychemedics Corporation 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan

The following description of the Psychemedics Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a savings plan and trust, established November 1, 1997, restated most recently effective January 15, 2022, that is designed to meet certain requirements of the Internal Revenue Code (“IRC”). The Plan is a 401(k) defined contribution plan, which covers all eligible employees of Psychemedics Corporation (the “Company”) who have attained the age of 21. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Employees may elect to contribute up to 100% of their compensation into the Plan, subject to limitations established by the IRC. In addition, participants may contribute designated Roth (after-tax) contributions. Participants may commence salary deferrals on the first day of the quarter following their date of hire. Participants may modify salary deferral elections on the first day of any month. Participants are also permitted to rollover amounts to the Plan from other qualified defined benefit or defined contribution plans.

The Company may make a matching contribution in an amount determined by the Company each plan year based on a percentage of the employee’s pretax and after-tax contributions. Effective March 1, 2020, matching contributions were suspended. There were no discretionary employer matching contributions in 2024 or 2023.

Participants Accounts

Each participant’s account is credited as specified in the Plan with the participant’s contributions, Company matching contributions, and an allocation of the Plan earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investments of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting and Forfeitures

Participant contributions and the earnings thereon are 100% vested upon contribution to the Plan. Participants are 100% vested in employer matching contributions upon entering the Plan.

In the event of death, permanent disability, or retirement, a participant’s employer contribution account becomes fully vested.

The non-vested portion of Company contributions are forfeited as of a participant’s termination date and are used to reduce future employer contributions or used to pay Plan administrative expenses. Forfeited non-vested amounts were \$0 and \$923 at December 31, 2024 and 2023, respectively. The Company used \$0 in 2024 and 2023, respectively, to reduce plan administrative expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts the lesser of 50% of the value of their vested account balance, or \$50,000. The minimum loan amount is \$1,000. Loans are secured by the balance in the participants accounts. The maximum term of such loans is five years, except for a loan for the purchase of a primary residence. The Plan allows a participant to have one primary residence loan and one other loan outstanding at a time. The interest rate is determined by the plan administrator based on prevailing market conditions and is fixed over the life of the note. Interest rates range from 2.50% to 8.50% as of December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are stated at their unpaid principal balance plus any incurred but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account, partial withdrawals, or annual installments over a period of years selected by the participant that is less than the life expectancy of the participant or designated beneficiary.

Distributions may also be made for in-service distributions and hardship. An in-service distribution is allowed if an active participant has reached the age of 59 ½. Hardship withdrawals are allowed if certain criteria are met and all other forms of financial assistance have been exhausted. These include medical expenses, principal residence purchase, damage to principal residence, to prevent eviction, tuition fees for the next 12 months, and funeral expenses.

Administrative Expenses

Administrative and transactional costs related to the operation of the Plan are paid by the Plan. Certain administrative expenses are also paid by the Plan's sponsor. Expenses that are paid by the Plan's sponsor are excluded from these financial statements. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value investments.

Plan Sponsor Liquidity

While the Company incurred a net loss during 2024 and has positive working capital as of December 31, 2024, management does not believe there is substantial doubt about the Plan's ability to continue as a going concern. Management believes the plan administrator could continue performing the administrative functions of the Plan for at least the period of one year from the date of this report.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance plus any incurred but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

The Plan is required to return contributions received during the Plan year in excess of the IRC limits back to the contributor. This liability was \$0 and \$32,776 as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan evaluated all events and transactions that occurred after December 31, 2024 through October 14, 2025, the date these financial statements were available to be issued.

3. Fair Value Measurements

The Plan follows the guidance of Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurement," which defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts

The Plan's investments in the pooled separate accounts are stated at fair value and represent the number of participation units owned by the Plan. Quoted market prices of the underlying investments are used to value each fund and are based on the net asset value ("NAV") of the shares held at the end of the year. There are no unfunded commitments or redemption period, and the redemption frequency is daily.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

4. Certified Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company, a qualified institution, has certified as to the completeness and accuracy of all the investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, the Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected on the statements of changes in net assets available for benefits for the year ended December 31, 2024.

Additionally, Minnesota Life Insurance Company, a qualified institution, has certified as to the completeness and accuracy of all the investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reflected on the statements of changes in net assets available for benefits for the year ended December 31, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Tax Status

The Plan adopted The Standard Retirement Services, Inc. nonstandardized pre-approved plan which received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the written form of the pre-approved plan document is qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the opinion letter, the Plan's sponsor believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest Transactions

Certain Plan investments are pooled separate accounts managed by The Standard Insurance Company; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
