1. Description of Plan

The following description of the White Plains Hospital 403(b) Defined Contribution Retirement Program (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of White Plains Hospital (the “Hospital” or “Employer”). Employees are eligible to participate in the Plan immediately for purposes of making salary deferred contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute a portion of their annual compensation on a pre-tax or after-tax (Roth) basis up to the applicable dollar amount which is established annually by the Internal Revenue Service (“IRS”), as defined in the Plan.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 6% of their eligible compensation. Each year, the deferral percentage will increase by 1% until the participant reaches 10% of their eligible compensation.

Participants who have attained age 50 during the plan year are eligible to make catch-up contributions up to the statutorily permitted amount.

Participants may also rollover or transfer amounts representing distributions from other eligible retirement plans.

Participants direct the investment of their contributions into various investment options offered by the Plan.

The Hospital will make a non-elective contribution based on years of service. The contribution is a percentage of eligible compensation, up to the annual compensation limit of \$345,000 and \$330,000 for 2024 and 2023. Employees that are part of the Local 1199 Collective Bargaining Unit (including Local 1199 Tech Group Employees) and per diem employees are not eligible to receive Employer contributions. Participants must complete one year of service to receive an Employer contribution.

Effective January 1, 2023, the schedule for Employer contributions are as follows:

During 2021, effective for participants employed on or after April 10, 2021, the determination of a participant's years of service will be made as of the first day of the Plan year, the schedule for Employer contributions are as follows:

Other Income

Amounts recorded as other income consist of income earned in the Plan Expense Account and uncashed checks.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Hospital's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested at all times in their contributions. Full vesting in the Hospital's non-elective contribution occurs after completing three years of service.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$154,963 and \$14,805. The balances in the accounts are used to reduce future Employer contributions and pay for administrative expenses of the Plan. In 2024, forfeitures of \$563,153 were used to reduce Employer contributions and no amounts were used towards administrative expenses.

Payment of Benefits

Benefits are paid upon retirement (age 65), death, age 59 1/2 or other termination of employment. Upon retirement or termination of employment, a participant may elect to receive in cash or direct rollover a lump-sum amount equal to the vested value of the participant's account. If the account balance is more than \$1,000 but not more than \$5,000, and the participant has not attained age 62 or normal retirement age, the payment will be automatically rolled into a traditional individual retirement account ("IRA").

Expenses

Certain expenses of maintaining the Plan are paid by the Hospital and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate equal to 1% above the prime rate. Loans must be repaid within a period not to exceed 5 years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence, in which case the loan can be repaid over 15 years. Repayment of principal and interest is made by payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is valued at contract value since it is fully benefit-responsive. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The mutual funds and money funds held by the Plan are valued based on the daily closing price as reported by the funds. All of the funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price and are deemed to be actively traded. Personal choice retirement accounts are considered to be self-directed accounts and are valued based on the account's underlying investments held as of the end of the plan year. The personal choice retirement accounts consist of: mutual funds and money funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default upon the occurrence of a distributable event, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York (collectively "Empower"), qualified institutions.

5. Group Annuity Contract

Participants have the option to invest in a benefit-responsive investment contract with Empower. The Guaranteed Interest Account (the "GIA") is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets of the portion of the Empower general accounts that is used to determine the GIA's crediting rate compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset at least annually and no more frequently than quarterly for some contracts. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value.

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to GIA.

Certain events limit the ability of the Plan to transact at contract value. Such events include: premature termination of the contracts by the Plan, plant closings, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. Management does not believe any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of a plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The Hospital has adopted a restated volume submitter plan document effective January 1, 2020 which is intended to satisfy the IRS's final 403(b) regulations. The volume submitter plan document preparer received an opinion letter dated April 7, 2021 from the IRS. Although the Plan has been amended, the plan administrator believes that the Plan, is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code ("IRC").

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Party-In-Interest Transactions

Certain investments are managed by Empower. Empower is a custodian and trustee, and therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Fees paid to Empower amounted to \$596,701 for the year ended December 31, 2024.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

The Plan and Empower have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this arrangement and to use this credit to pay Plan expenses, the Employer created the Plan Expense Account ("PEA") under the Plan. The PEA is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record-keep the re-distribution of plan-generated fund revenue. The PEA balance was \$74,326 and \$147,201 at December 31, 2024 and 2023. In 2024, \$253,961 was used to pay administrative expenses.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


