Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, , and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of DCG Fulfillment 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a qualified defined-contribution plan established January 1, 2009, and amended effective July 7, 2022, by Dirt Cheap, Inc. (the “Employer”), under the provision of Section 401(k) of the Internal Revenue Code (IRC). The Plan provides for a qualified cash or deferred arrangement, as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer.

#### Administration

The Plan is administered by the Employer and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Capital Bank and Trust Company (the “custodian” or “trustee”) is responsible for the custody and management of the Plan’s assets. American Funds Service Company is the Plan’s third-party administrator. Empower Retirement, LLC is the Plan’s recordkeeper.

#### Eligibility

Any employee who has attained age 21, and has completed 12 months of service is eligible to participate in the Plan. Employees who are residents of Puerto Rico are not eligible. Participation in the Plan may begin after eligibility requirements are met.

#### Participant Contributions

Participants may elect to contribute, on a pretax basis, an after-tax basis (Roth 401(k)), or a combination of both, up to a maximum of 100% of eligible compensation, in an amount not in excess of the maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also rollover amounts representing distributions from other qualified benefit or contribution plans.

#### Employer Contributions

The Plan is a safe harbor 401(k) plan. The Employer matches 100% of a participant’s deferral contribution that does not exceed 3% of compensation, plus 50% of their deferral contribution between 3% and 5% of compensation.

#### Vesting

Participants are immediately vested in their contributions and Employer safe harbor contributions, plus actual earnings thereon.

### **NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution and Plan earnings, and charged with an allocation of administrative expenses to the extent that were not paid by the Employer. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Participants may direct participant and Employer contributions, as desired, in any of several investment options offered by the Plan. Participants may change their investment options any time throughout the year, via the internet website, or by using the automated telephone system offered by the custodian.

#### Notes from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to maximum of the lesser of 50% of their vested account balance, or \$50,000. The maximum note amount will be reduced by the participant's highest outstanding note balance in the previous 12 months even if amounts have been repaid. Participants are permitted to have no more than two (2) notes outstanding at one time. During December 31, 2024 and 2023, the notes are secured by the balance in the participant's account and bear interest ranging from 2.00% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Note terms are specified for each loan with maturities through November 2029. Note terms range from one to five years, except for notes related to the purchase of a primary residence, which may be longer. Principal and interest are paid ratably through payroll deductions.

#### Benefit Payments

The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, or termination of employment. In-service distributions are also available to those participants who are age 59 ½ or older. Participants who qualify for retirement of benefits and withdrawals will receive their benefits as a lump sum disbursement. Installment payments are permitted for required minimum distributions and death beneficiary disbursements. The Plan may make mandatory distributions who have terminated employment and whose vested balance does not exceed \$5,000.

#### Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with Internal Revenue Service (IRS) regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Forfeitures

A participant's accounts are forfeited if the Employer contribution portion has not been fully vested at the time of withdrawal or termination. These amounts may be utilized to reduce Employer contributions and/or pay administrative expenses. At December 31, 2024 and 2023, the balance in forfeited accounts totaled \$13,102 and \$5,309, respectively. During the Plan year ended December 31, 2024, no forfeitures were used to reduce Employer contributions or pay administrative expense.

#### Administrative Expenses

Most administrative expense for maintaining the Plan are paid by the Employer. Such expenses are excluded from these financial statements. Certain administrative fees are charged to the individual participant's account.

### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of Estimates

The preparation of the Plan's financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net available for plan benefits and changes therein and, when acceptable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for its investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### Notes from Participants

Notes from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

#### Payment of Benefits

Benefits are recorded when paid.

### NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN AND TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the trustee and custodian of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the supplemental Schedule of Assets (Held at End of Year), as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies:*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Cash and cash equivalents:*

Valued at the carrying value, which approximates fair value due to the short-term nature of such instruments.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by American Funds Service Company; therefore, these transactions qualify as exempt party-in-interest transactions permitted by the United States Department of Labor Rules and Regulations. The Employer and Plan Administrator are also parties-in-interest with respect to the Plan. Fees paid by the Plan to the recordkeeper amounted to \$4,622 for the year ended December 31, 2024. Notes from participants and the related interest income of \$26,418 are also considered related-party transactions.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**NOTE 7 – INCOME TAX STATUS**

The IRS has determined and informed American Fund Distributors, Inc. (AF) by a letter dated March 31, 2014 that the prototype non-standardized profit sharing with cash or deferred arrangement plan offered by AF, and adopted by the Plan, is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and Plan management believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

#### **NOTE 7 – INCOME TAX STATUS (Continued)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken on an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed such intent, the Employer, by action of its Plan Administrator, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease, all contributions would become 100% vested, and net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

#### **NOTE 9 – SUBSEQUENT EVENTS**

The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
