INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of *District Medical Group, Inc. Profit Sharing and 401(k) Plan & Trust* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. (1) Description of the Plan

The following description of the *District Medical Group, Inc. Profit Sharing and 401(k) Plan & Trust* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General** - The Plan is a defined contribution plan covering all employees of District Medical Group, Inc. (the "Company" or "Sponsor") who are age twenty-one or older excluding leased employees and residents of Puerto Rico. Participants are eligible for the Company's contributions if they are regularly scheduled to work at least 1,000 hours or actually work a 1,000 hours in a year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions** - Each year, participants may contribute up to 100% of annual compensation on a pre-tax or Roth basis, subject to Internal Revenue Service ("IRS") limitations. Effective January 1, 2021, participants are automatically enrolled at a 2% pre-tax deferral, to be increased 2% per year until it reaches 10%, if the employee does not opt out or elect a different deferral rate. For participants hired prior to January 1, 2021, the pre-tax deferral continues to increase at a rate of 1% per year until it reaches 10%, if the employee does not opt out or elect a different deferral rate. Participants may also contribute on an after-tax basis. Automatic enrollment occurs on the first pay date at least 30 days after the employee becomes eligible. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Each year, at its discretion, the Company may elect to make profit sharing contributions to participants hired prior to December 31, 1998 based on their employment category per the criteria stated below, and in addition the Company will also contribute an amount equal to 6% of these participants' compensation.

The Company may also elect to make a matching contribution up to 4% of eligible compensation for participants hired from January 1, 1999 to December 31, 2020 after being credited with a year of service. For the year ended December 31, 2024, the Company elected to match 100% of participant contributions up to 4% of the eligible participant's compensation. Additionally, the Company makes non-elective contributions to these employees based on vested service as follows.

Effective January 1, 2021, the Plan implemented a new employer match formula for new employees hired on or after January 1, 2021. The discretionary employer match is 2% in the first year of employment, 4% in the second year of employment, and 6% in the third year of employment and beyond.

Contributions are subject to certain limitations.

- C. Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution (discretionary matching contribution, discretionary profit-sharing contribution, and successor to money purchase contribution) and (b) Plan earnings and charged with an allocation of administrative and investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, common collective trusts, and self-directed brokerage accounts as investment options for participants.
- D. Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their account plus earnings thereon is based on years of continuous service. Participants hired on or prior to December 31, 1998 vested on a 3 year vesting schedule. Participants hired on or after January 1, 1999 vest 40% after 2 years of service and then 20% more each year until fully vested after 5 years of service. Upon death, disability or attaining retirement age while employed, a participant becomes 100% vested.
- E. Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate which is based on current interest charged by persons in the business of lending money or similar loans at the time the loan is made. The interest rates on notes receivable from participants at December 31, 2024 were 5.25% - 10.50%. Loan terms are 5 years or less. Principal and interest are paid ratably through semi-monthly payroll deductions. The Plan also implemented provisions of the CARES Act allowing borrowings up to a maximum equal to the lesser of \$100,000 or 100% of a participant's vested account balance in 2020.
- F. Payment of benefits** - Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account or annuity payments. Participants and beneficiaries whose employment terminates or who is entitled to commence payment while employed, may elect partial distributions from time to time. Participants may also elect to accelerate installment payments over the period specified by the participant enrollment or a participant may elect distribution in more than one form of payment.
- G. Forfeited accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$220,000 and \$92,000, respectively. These accounts will be used to reduce future employer contributions or plan expenses. For the year ended December 31, 2024, forfeitures totaling approximately \$177,000 were used to reduce employer contributions.

H. Investment and administrative expenses - Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan's investment and administrative expenses are paid by either the Plan or the Plan's Sponsor as provided by the Plan document.

(2) Summary of significant accounting policies

A summary of the Plan's significant accounting policies follows.

Basis of accounting - The accompanying financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) using the accrual method of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Management's use of estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Management is also required to make estimates associated with the disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition - The self-directed brokerage accounts primarily consist of common stocks, corporate and government obligations, unit investment trusts, mutual funds, and cash. Common stocks, corporate and government obligations, and unit investment trusts are stated at fair value, which is based on the closing price reported on the active market on which the investment is traded. Investments in shares of mutual funds are stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. Common collective trusts are valued based upon the quoted redemption value of units, or the equivalent of net asset value, which is a practical expedient for estimating fair value. The investments have no unfunded commitments as of December 31, 2024 and 2023 and can be redeemed daily with no redemption notice period or other redemption restrictions.

These methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties - The Plan provides for various investment fund options, which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued interest.

Payment of benefits - Benefits are recorded when paid.

Subsequent events - The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

(3) Fair value measurements

The fair value measurement framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or collaborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Accordingly, T. Rowe Price Trust Company, the trustee of the Plan, has certified that the following data as of December 31, 2024 and 2023 and for the year ended December 31, 2024 included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends and interest
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(5) Tax status

The Plan has adopted the T. Rowe Price Retirement Plan Services, Inc. Pre-Approved Defined Contribution Plan No. 15 (the "TRP Prototype Plan"). The TRP Prototype Plan received an opinion letter from the IRS dated August 19, 2020, stating that it is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Accordingly, the Sponsor believes that the Plan was qualified as of December 31, 2024 and 2023, and accordingly, no provision for income taxes is included in the accompanying financial statements.

(6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

(7) Party-in-interest transactions

Certain Plan investments are held in funds managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment advisory services and other services to parties-in-interest amounted to \$231,198 for the year ended December 31, 2024.
