Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Antolin 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**General**

The Plan provides benefits for the eligible employees of Antolin Interiors USA, Inc., Grupo Antolin Kentucky, Inc., Grupo Antolin North America, Inc., Grupo Antolin Michigan, Inc., Grupo Antolin Illinois, Inc., Grupo Antolin Missouri, LLC, Antolin Shelby, Inc., Antolin Alabama, LLC, Antolin St. Clair, LLC, and Antolin Nashville, LLC. (collectively the “Company” or “Employer”). Participation in the Plan is discretionary for all eligible employees who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

During August 2024, Antolin St. Clair, LLC, closed its facilities. During July 2023, Grupo Antolin Illinois, Inc. closed its facilities. The closures did not result in a partial plan termination.

Effective December 1, 2023, the Plan name was changed to Antolin 401(k) Plan from Grupo Antolin Retirement Savings Plan.

Principal Trust Company (“Principal”) is the Plan’s trustee and Principal Life Insurance Company provides recordkeeping services to the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offering and monitors investment performance.

The Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (the SECURE Act 2.0) was signed into law December 29, 2022. This law, among other things, includes several required and optional provisions that will impact employee benefit plans that go into effect at various times through 2027. The provisions that were required to be implemented during the year ended December 31, 2024 are; 1) pre-death RMDs are not required from Roth accounts, 2) surviving spouse can elect to be treated as deceased employee for purposes of RMD rules, 3) correction period for employee deferral failures is extended to 9 ½ months after the end of the Plan year in which the error was made. The optional provisions that could be implemented during the year ended December 31, 2024 are; 1) the ability to offer non-highly compensated employees an emergency savings account, 2) to increase the cash-out balance to \$7,000, 3) to allow distributions for domestic abuse victim, 4) to allow for emergency expense distribution of up to \$1,000 and 5) to allow auto portability of amounts in that were rolled into an IRA due to cash out rules to be rolled into a new employer’s plan.

The Plan did not elect any of the optional provisions of the SECURE Act 2.0 during the 2024 plan year. The Plan will be amended for any provisions implemented in accordance with applicable laws and IRS guidance.

**Contributions**

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Employer has elected a safe harbor matching contribution on behalf of each eligible participant equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation. Matching contributions are calculated based on elective deferral contributions and compensation for the plan year. The Employer may also make a discretionary profit-sharing contribution, to be determined annually. Compensation for the purposes of calculating the discretionary profit-sharing contribution excludes overtime pay. Union employees of Antolin St. Clair are not eligible for the matching contribution or the discretionary profit-sharing contribution.

During the year ended December 31, 2024, the Company made discretionary profit-sharing contributions totaling \$518,850.

Contributions are subject to certain IRS limits. Participants direct the investment of their contributions, including their employer contribution, into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with participant's contributions and Company's safe harbor matching contributions, as well as allocations of the Company's discretionary profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and safe harbor matching contributions plus earnings thereon. Vesting in all other contributions is based on years of service. Participants become 30% vested after one year of service. Vesting increases by 10% the following year and then increases 20% each year after up to 100% after five years of service. One year of service for purposes of vesting is determined by the total of employee's countable periods of service, without regard to hours of service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate. The term of such loans may not exceed 5 years, except in the case of a loan for the purchase of a principal residence, which may not exceed 10 years. Participants may only have one outstanding loan at a time, with a 60-day delay between loan repayment and approval of a new loan. Principal and interest is paid ratably through payroll deductions.

**Payment of Vested Benefits**

On termination of service due to death, disability or retirement, participants or their beneficiaries may elect to receive an amount equal to value of the vested interest in their accounts in a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination. Participants that have a vested account balance less than \$5,000, but greater than \$1,000, will have their vested balance rolled into an IRA. If the participant's vested balance is greater than \$5,000, they can elect to receive a lump-sum distribution, installments, or an annuity.

In-service distributions are allowed when a participant reaches age 59 ½. Rollover contributions may be withdrawn at any time. Certain withdrawals from a participant's account are allowed in the event of proven financial hardship. Hardship withdrawals are subject to specific statutory and regulatory requirements.

**Forfeitures**

Forfeitures that occur in a given plan year are eligible to be used in the following plan year only. Forfeitures are used to pay Plan expenses or reduce employer contributions. Any remaining forfeitures will be reallocated to participants. During the year ended December 31, 2024, forfeitures in the amount of \$42,758 were used to pay Plan expenses and \$55,205 were used to reduce employer contributions. No forfeitures were allocated to employees as all forfeitures for the current plan year were used. There were unallocated forfeitures of \$150,457 and \$115,012 at December 31, 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Contributions from the Company are recorded in the period in which the related participant contributions are due. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in administrative expenses in the statement of changes in net assets available for benefits. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

**Subsequent Events**

The plan sponsor has performed a review of events subsequent to December 31, 2024 through October 14, 2025, the date the financial statements were available to be issued.

Subsequent to year end, the Plan was amended to allow for a one-time signing bonus paid to Howell union members to be contributed to the Plan per the collective bargaining agreement.

**NOTE 3 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at the published closing prices as reported by the fund. These funds publish their NAV and transact at that price. The collective trust funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV of units of the fund, which is based on the estimated market value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. During the year ended December 31, 2024, there were direct fees of \$353,487 and transactions involving the investment of plan assets in investment funds maintained by Principal, a party-in-interest as defined in Section 3(14) of ERISA. Indirect fees paid by the Plan for investment management services are included in the net appreciation in the fair value of investments.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7 – TAX STATUS**

On June 30, 2020, the Internal Revenue Service stated that the pre-approved document adopted by the Plan, as then designed, qualified under IRC Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the Internal Revenue Service for the statutory period.

**NOTE 8 – DELINQUENT CONTRIBUTIONS**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company has remitted the majority of employee contributions to the Plan, contributions and loan repayments of \$436,407 were not remitted within the required time period for the year ended December 31, 2024. Those remittances relate to various payroll periods from 2023 and 2024. The Company has corrected delinquent employee contributions of \$381,285 from 2023. The Company is in the process of remitting any lost earnings on the delinquent employee contributions for payroll periods from 2024. Amounts have not been determined or recorded in the Plan's financial statements as of December 31, 2024.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
