### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of National Roofing Co., Inc. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

#### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Part IV, Line 4i – schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1) Summary of Significant Plan Provisions**

The following description of National Roofing Co., Inc. Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of National Roofing Company, Inc. (the “Employer”) who have completed twelve months of service, at least 1,000 hours and are age twenty-one or older. To be eligible to receive an allocation of Employer matching contributions, participants must be employed as of the last day of the Plan year and have at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer serves as the Plan administrator.

Contributions

Each year, participants may contribute annual pretax compensation, as defined by the Plan, as well as after-tax Roth contributions, limited to the annual statutory maximum as determined by the Internal Revenue Service. All participants who are eligible to make contributions and are at least age 50 by the end of the Plan year are eligible to make additional catch up contributions subject to annual limits as established by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans (rollover).

Each year, the Employer may, at its discretion, contribute an amount that will be allocated proportionate to the amount of the respective participant’s salary deferrals. There are no additional limits imposed on the matching contributions. Additionally, the Employer may make a discretionary profit sharing contribution to the Plan each year. For the years ended December 31, 2024 and 2023, no discretionary matching or profit sharing contributions were made to the Plan.

Participants direct the investment of all contributions in a variety of investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer’s contribution, and allocations of Plan earnings or losses. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Employer's contributions and related investment earnings are vested to individual participants based on years of service as follows:

Notes Receivable from Participants

The Plan does not permit notes receivable from participants.

Payments of Benefits

Benefits are payable in the event a participant retires, dies, becomes disabled or otherwise ceases to be an employee of the Employer. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Mandatory Cash-Out Provisions

If the amount of benefits in a participant's account is \$5,000 or less at the time of separation, the amount will be automatically distributed in the form of an individual retirement account. If the amount of benefits in a participant's account is less than \$1,000 and no payment instructions are provided, the amount will be distributed to the participant as a lump-sum payment. These distributions are processed without the consent of the participant.

Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used to pay Plan administrative expenses or reduce future Employer contributions. The balance in the Plan's forfeiture account was \$829 as of December 31, 2024 and 2023. In 2024 and 2023, there were no forfeitures used to offset Employer contributions or pay plan expenses.

**2) Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and Uncertainties

The Plan invests in a variety of investment funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. The Employer paid a majority of the Plan's expenses for the year ended December 31, 2024 and 2023, which are excluded from the financial statements. Fees paid by the Plan for investment related services are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through September 12, 2025, the date which the financial statements were available to be issued.

**3) Investments and Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

*Pooled Separate Accounts*—The net asset value of the pooled separate accounts (PSA) is based on unit values reported by the Plan trustee as determined by the investment manager based on the fair value of the underlying assets net of liabilities divided by the number of outstanding units of the PSA on its valuation date. Management has determined that the investments using NAV as a practical expedient do not have published prices and; therefore, the investments are not assigned a level in the fair value hierarchy.

*Guaranteed Interest Account*— Valued at fair value by John Hancock by discounting the related cash flows based on current yields on similar instruments with comparable durations considering the credit worthiness of the issuer (see Note 5). Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, John Hancock evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

**4) Information Prepared and Certified by the Trustee (Unaudited)**

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by John Hancock Life Insurance Company, a qualified institution, and certified as complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023.
- Investments reflected on the supplemental schedule of assets held at end of year.

**5) Guaranteed Interest Accounts**

This investment option is available under the group annuity contract issued by John Hancock. The investment option provides for a guarantee of principal and interest. Contributions and transfers allocated to this investment option will be credited interest at a guaranteed interest rate John Hancock declares for a set period of time. Interest rates for new allocations are subject to change daily, and each amount allocated to the guaranteed interest account will earn interest based on the interest rate in effect for the date that the amount is allocated to the guaranteed interest account. The guaranteed interest accounts are not considered fully-benefit-responsive, and are presented on the statements of net assets available for benefits at fair value.

**6) Plan Termination**

Although it has not expressed intent to do so, the Employer, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

**7) Tax Status**

The Plan is operating under a prototype document with a nonstandardized adoption agreement. The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the prototype plan as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype plan sponsor. The Plan was amended after the IRS issued the opinion letter to the Plan sponsor. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, no uncertain tax positions have been taken and none are expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8) Related-Party and Party-in-Interest Transactions**

Certain Plan assets are investments managed by John Hancock Life Insurance Company, the trustee of the Plan's investments. These transactions qualify as exempt party-in-interest transactions.

Administrative expenses include third-party administration, recordkeeping, investment advisory, and legal fees.

For the year ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses, such as third party administrative fees and distribution fees, amounted to \$32,510 and \$24,958, respectively.

## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of National Roofing Co., Inc. Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1) Summary of Significant Plan Provisions**

The following description of National Roofing Co., Inc. Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of National Roofing Company, Inc. (the “Employer”) who have completed twelve months of service, at least 1,000 hours and are age twenty-one or older. To be eligible to receive an allocation of Employer matching contributions, participants must be employed as of the last day of the Plan year and have at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer serves as the Plan administrator.

Contributions

Each year, participants may contribute annual pretax compensation, as defined by the Plan, as well as after-tax Roth contributions, limited to the annual statutory maximum as determined by the Internal Revenue Service. All participants who are eligible to make contributions and are at least age 50 by the end of the Plan year are eligible to make additional catch up contributions subject to annual limits as established by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans (rollover).

Each year, the Employer may, at its discretion, contribute an amount that will be allocated proportionate to the amount of the respective participant’s salary deferrals. There are no additional limits imposed on the matching contributions. Additionally, the Employer may make a discretionary profit sharing contribution to the Plan each year. For the years ended December 31, 2024 and 2023, no discretionary matching or profit sharing contributions were made to the Plan.

Participants direct the investment of all contributions in a variety of investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer’s contribution, and allocations of Plan earnings or losses. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Employer's contributions and related investment earnings are vested to individual participants based on years of service as follows:

Notes Receivable from Participants

The Plan does not permit notes receivable from participants.

Payments of Benefits

Benefits are payable in the event a participant retires, dies, becomes disabled or otherwise ceases to be an employee of the Employer. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Mandatory Cash-Out Provisions

If the amount of benefits in a participant's account is \$5,000 or less at the time of separation, the amount will be automatically distributed in the form of an individual retirement account. If the amount of benefits in a participant's account is less than \$1,000 and no payment instructions are provided, the amount will be distributed to the participant as a lump-sum payment. These distributions are processed without the consent of the participant.

Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used to pay Plan administrative expenses or reduce future Employer contributions. The balance in the Plan's forfeiture account was \$829 as of December 31, 2024 and 2023. In 2024 and 2023, there were no forfeitures used to offset Employer contributions or pay plan expenses.

**2) Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and Uncertainties

The Plan invests in a variety of investment funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. The Employer paid a majority of the Plan's expenses for the year ended December 31, 2024 and 2023, which are excluded from the financial statements. Fees paid by the Plan for investment related services are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through September 12, 2025, the date which the financial statements were available to be issued.

**3) Investments and Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

*Pooled Separate Accounts*—The net asset value of the pooled separate accounts (PSA) is based on unit values reported by the Plan trustee as determined by the investment manager based on the fair value of the underlying assets net of liabilities divided by the number of outstanding units of the PSA on its valuation date. Management has determined that the investments using NAV as a practical expedient do not have published prices and; therefore, the investments are not assigned a level in the fair value hierarchy.

*Guaranteed Interest Account*— Valued at fair value by John Hancock by discounting the related cash flows based on current yields on similar instruments with comparable durations considering the credit worthiness of the issuer (see Note 5). Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, John Hancock evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

**4) Information Prepared and Certified by the Trustee (Unaudited)**

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by John Hancock Life Insurance Company, a qualified institution, and certified as complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023.
- Investments reflected on the supplemental schedule of assets held at end of year.

**5) Guaranteed Interest Accounts**

This investment option is available under the group annuity contract issued by John Hancock. The investment option provides for a guarantee of principal and interest. Contributions and transfers allocated to this investment option will be credited interest at a guaranteed interest rate John Hancock declares for a set period of time. Interest rates for new allocations are subject to change daily, and each amount allocated to the guaranteed interest account will earn interest based on the interest rate in effect for the date that the amount is allocated to the guaranteed interest account. The guaranteed interest accounts are not considered fully-benefit-responsive, and are presented on the statements of net assets available for benefits at fair value.

**6) Plan Termination**

Although it has not expressed intent to do so, the Employer, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

**7) Tax Status**

The Plan is operating under a prototype document with a nonstandardized adoption agreement. The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the prototype plan as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype plan sponsor. The Plan was amended after the IRS issued the opinion letter to the Plan sponsor. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, no uncertain tax positions have been taken and none are expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8) Related-Party and Party-in-Interest Transactions**

Certain Plan assets are investments managed by John Hancock Life Insurance Company, the trustee of the Plan's investments. These transactions qualify as exempt party-in-interest transactions.

Administrative expenses include third-party administration, recordkeeping, investment advisory, and legal fees.

For the year ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses, such as third party administrative fees and distribution fees, amounted to \$32,510 and \$24,958, respectively.
