Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RusCorr, LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RusCorr, LLC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the financial statements referred to above other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE A--DESCRIPTION OF PLAN

The following description of the RusCorr, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is sponsored by RusCorr, LLC (the "Company") for employees that meet specific eligibility requirements, as defined in the Plan's provisions. Affiliated companies RusCorr II, LLC and CSC Atlanta, LLC are participating employers under the Plan for the benefit of their employees and are bound by all elections selected by the Company. The Plan, designated as a defined contribution plan, was originally established on September 1, 2003, and was restated effective September 1, 2020. The Plan was most recently amended and restated effective January 1, 2022. The Plan provides for contributions to be made under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). Non-leased employees are eligible to participate after completing one month of service. Employees are eligible to enter the Plan on the first day of the month following satisfaction of the eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 ("ERISA"). The Plan Administrator and Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of investment offerings, and monitoring investment performance.

Contributions

Eligible participants may elect to contribute Roth and pre-tax deferred compensation to the Plan by means of a salary deferral agreement up to the maximum limit permitted by law. Contributions are, thus, subject to limitations as provided in the Code and as described in the Plan's provisions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers) in accordance with Plan provisions.

Unless eligible employees affirmatively elect otherwise, their compensation will be reduced by 5%, the "Automatic Enrollment Rate". For each payroll period in which they are an active and eligible participant, a pre-tax deferral contribution at the automatic enrollment rate will be made on the participant's behalf into a default fund as designated by the Plan Trustees.

The Company may make discretionary matching contributions to the Plan in accordance with Plan provisions. Eligibility requirements for matching contributions are the same as general Plan eligibility requirements. Employees are eligible to receive the matching contributions on the first day of the month coinciding with or next following satisfaction of meeting the eligibility requirements.

The Company may make discretionary non-elective contribution to the Plan in accordance with the Plan provisions. Employees must complete at least 1,000 hours completed during the year and be employed at the end of the Plan year in order to be eligible to receive an allocation of the non-elective employer contribution.

Salary deferral contributions are funded proximate to the withholding date. Discretionary contributions, if any, are funded annually after the close of the Plan year and within statutory time frames.

Participant Accounts

Each participant's account is credited with the participant's contribution, if any, and allocations of (a) the Company's discretionary matching or profit-sharing contributions, if any, (b) Plan earnings or losses, (c) forfeitures of terminated participants' non-vested accounts, and (d) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant account balances or compensation, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan and may elect to change their investment options at any time. During any period in which there is no participant direction on file with the Plan as to the investment of a participant's account, 100% of that participant's account will be invested in the investment option designated from time to time by the Plan Trustees as the default investment. The Plan currently offers various registered investment companies, pooled separate accounts and a fixed annuity contract as investment options for participants.

Vesting

Participants are immediately vested in their contributions and discretionary matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions plus actual earnings thereon is based on years of credited service, as presented below. A participant is 100 percent vested after six years of credited service. Participants who attain the normal retirement age of 65 or who terminate employment due to death or disability become 100 percent vested in their account balances.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the participant's highest outstanding loan balance in the previous twelve months and the participants existing loan balance or 50 percent of their vested interest in the Plan, reduced by the participants existing loan balance. The loans are collateralized by the participant's account balance and bear interest at a reasonable rate commensurate with local prevailing rates as determined by the Plan Administrator. Loans are for a period not to exceed five years unless for the purchase of the participants principal residence, in which case a reasonable time for repayment will be determined. The interest rates applied to current loans outstanding are between 4.25 and 9.50 percent. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment due to death, disability, retirement or Plan termination, a participant is entitled to 100 percent of their account balance. For termination of employment for other reasons, a participant is entitled to 100 percent of the participant's contributions and the vested portion of the Company's contributions based upon the Plan's vesting provisions in a lump sum.

All distributions will be made as soon as administratively feasible. However, those account balances in excess of \$5,000, will be made as soon as administratively feasible following the date the Plan Administrator receives a written request for distribution. In-service and hardship withdrawals, subject to certain restrictions, are also permitted.

Mandatory distributions less than \$5,000 will be paid in a single lump-sum payment. The Plan will make the distribution as a direct rollover for any amounts greater than \$1,000. These distributions will be made if a participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or does not elect to receive the distribution directly.

Forfeited Accounts

Forfeited nonvested accounts may be used to reinstate any previously forfeited amounts of certain former participants who are rehired. The remaining forfeitures will first be used to pay the administrative expenses of the Plan, as directed by the employer, with the remaining amounts used to reduce future employer contributions.

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$380 and \$0, respectively. During the year ending December 31, 2024, the Plan used \$41,003 of the forfeited non-vested accounts to reduce matching contributions for the Plan year 2024 and \$5,600 to pay Plan expenses.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES-continued

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fixed annuity contract, which is at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Profit Sharing and 401(k) Oversight Committee determines the Plan's valuation policies utilizing information provided by the investment Custodians and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded. During the Plan year ended December 31, 2024, \$53,852 of notes receivable from participants were deemed distributed.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administering notes receivable and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of the fair value of investments.

Subsequent Events

Management of the Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Should an investment be re-characterized from one level to another level, Plan management would state the basis for the change. Under such circumstances the Plan would report the transfers in and transfers out at the beginning of the Plan quarter when change occurs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Registered investment companies' value mutual funds at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Shares of pooled separate accounts are valued at the NAV of units held by the pooled separate account. The NAV is the basis for current transactions, and the pooled separate account can be redeemed at NAV as of the measurement date. The NAV is used as a practical expedient to estimate fair value. Participant transactions (sales and purchases) may occur daily, and shares can be redeemed on a daily basis.

NOTE E--FIXED ANNUITY CONTRACT

At December 31, 2024 and 2023, the Plan invests in a single group annuity contract with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company as the issuer of the contract. In accordance with ASC Subtopic 820-10, this investment is presented in the financial statements at its contract value. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined-contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The value of the traditional investment contract at December 31, 2024 and 2023 is \$1,882,268 and \$1,717,562, respectively.

With traditional investment contracts, the Plan owns the contract itself. With synthetic investment contracts, the Plan owns the underlying assets of the synthetic investment contract. The group annuity contract is deemed to be a traditional investment contract.

The annuity contract pays a fixed rate of interest. The contract is not a portfolio of contracts with yields based on changes in the fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. The interest crediting rate was 2.55% and 1.90% at December 31, 2024 and 2023, respectively, and is updated semiannually with the next crediting rate update scheduled for December 2025.

By definition, a group annuity contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time. Interest is credited to the Guaranteed Interest Fund on a daily basis from the date deposits are accepted until paid, transferred or applied in full. Fees may be paid in one of the following three ways: (1) by being netted from the effective annual interest rate; (2) by being paid separately by the Plan Sponsor; or by being deducted from the Guaranteed Interest Fund. Benefit payments are deducted from the value of the Guaranteed Interest Fund to the extent that the Composite Value is sufficient to make such payments. Payments and transfers are made in full within 3 business days after the date payment or transfer has been requested. In the event that market conditions are such that it is determined that they will not allow for the orderly transfer or sale of financial instruments, up to an additional 30 days may be required to make such payment or transfers.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of a Plan's interest, if the Plan Sponsor wishes to terminate the Plan's interest, the value of the Plan's interest will be paid out in six installment payments. The first installment payment will be paid six months after the date of the notice to terminate the Plan's interest. Subsequent installment payments will be made on the same day of each year thereafter. In lieu of the six installment payment option, the record keeper may request payment be made on a date at least 90 days, but not more than 180 days from the date of the notice, subject to a potential Early Termination Charge and (2) termination of the contract, the Plan's contract shall be terminated on the date when both current deposits arrangements have been made between the record keeper and Plan Sponsor and there are no Guaranteed Interest Funds with a value greater than zero. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur.

NOTE F--RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Plan investments include pooled separate accounts, and a fixed annuity contract managed by the Custodians; and therefore, qualify as party-in-interest transactions. The Custodians performed administrative and recordkeeping services for the Plan which were paid for with Plan assets.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services by the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan. These amounts are not material to the financial statements.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE H--TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the prototype plan document, subsequently adopted by the Plan, as then designed, qualified under section 401(k) of the Code. The Plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself. However, the Plan Administrator and the Plan's legal counsel believe that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE I--RISKS AND UNCERTAINTIES

The Plan's assets are invested directly and indirectly in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. The Plan's assets are subject to changes in the value of those underlying investments, including the potential for bankruptcy of one or more of the companies in which they are invested.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The participants who have borrowed from the Plan are all employees of the Company throughout the United States, and their ability to repay the loans could be affected by the economic conditions in the industry in general, the economic conditions throughout the United States or the economic situation of the Company itself.

NOTE J--LATE REMITANCES

During the year ended December 31, 2023, participant contributions and loan repayments totaling \$491 were not remitted by the Company within the appropriate time period as prescribed by the Department of Labor (DOL) Regulations. These transactions constitute prohibited transactions as defined by ERISA. The Company has corrected these transactions in 2025, including depositing amounts representing lost earnings.
