Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Associated Builders and Contractors Northern California Chapter Benefit Trust Fund, which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Associated Builders and Contractors Northern California Chapter Benefit Trust Fund as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Associated Builders and Contractors Northern California Chapter Benefit Trust Fund Notes to Financial Statements

Note 1 – Description of Plan

The Associated Builders and Contractors (ABC) Northern California Chapter Benefit Trust Fund (the Plan) was established for participating member employers to provide medical, vision, dental, and life insurance coverage to employees not represented by collective bargaining units. Reference should be made to the Summary Plan Description for a more complete description of the Plan's provisions.

General – The Plan is a multiple employer welfare benefit plan that provides group health benefits and welfare to the employees and their dependents of the employers participating in the ABC Northern California Chapter Apprenticeship Program and to member contractor firms of the ABC Northern California Chapter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Hourly employees – Employers may elect a month-to-month coverage option for hourly construction trade employees. Under this option, employees are required to complete 130 hours per month for eligibility purposes. Employees are eligible for benefits on the first day of the second month following a month in which the employee worked at least the required number of hours. Coverage continues on a month-to-month basis as long as the participating employee works more than the required number of hours in a month. If an employee works more than the required hours in a month, the excess is held in reserve. Coverage ends at the end of a month in which the hours worked by a participant, plus reserve account hours and additional employer contributions, are insufficient to cover the participant for eligibility the following month.

Indentured apprentices – Indentured apprentices, for whom contributions are paid on an hourly basis, are eligible for benefits on the first day of the second month following completion of 115 hours of work. Coverage continues on a month-to-month basis as long as the participating employee is credited with at least 115 hours each month. If an employee works more than 115 hours in a month, the excess is held in reserve. This reserve is available for months in which the employee works less than 115 hours. Coverage ends at the end of a month in which the hours worked by a participant, plus reserve account hours and additional employer contributions, are insufficient to cover the participant for eligibility the following month.

All other employees – Employees other than hourly construction trade employees and indentured apprentices for whom contributions are paid on a monthly basis, and their dependents for which coverage is elected and paid, become eligible based on the eligibility requirements selected by the employer.

Contributions – The participating employers contribute to the Plan for all employees who are apprentices with the ABC Northern California Chapter Apprenticeship Program and those contractor members of ABC Northern California Chapter who elect to contribute to the Plan. The Trustees establish contribution amounts needed to pay premiums and plan expenses. Participating employers enroll in selective programs for their construction employees and office staff and contribute to the Plan based on the benefits elected and rates, which are set annually. Employer contributions received in excess of plan insurance premiums and other expenses are held for investment to pay premiums for all eligible participants during their coverage periods.

Associated Builders and Contractors Northern California Chapter Benefit Trust Fund Notes to Financial Statements

Benefits – The Plan provides group medical, life, vision, and dental insurance benefits and an employee assistance program. All benefits are fully insured.

Plan termination – The plan sponsor and participating employers intend to continue the Plan but reserve the right to terminate or change the Plan at any time. The plan sponsor and participating employers do not promise continuation of any benefits, nor do they promise any benefits at or during retirement. Benefits may also be terminated by the participating employer's failure to make contributions or by the termination or expiration of the participating employer's agreement adopting the Plan. Upon termination of the Plan, the Trustees will wind up the affairs of the Plan and any remaining funds will be used to continue payment of benefits to participants and their beneficiaries under the Plan.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements, in conformity with GAAP, requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, benefit obligations and changes therein, liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash – Cash is maintained in noninterest bearing accounts. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on its cash.

Investments valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized gains and losses on investments bought and sold as well as unrealized appreciation of those investments held during the year.

Employer contributions receivable – Receivables are presented in the statements of benefit obligations and net assets available for benefits, net of the allowance for credit losses and consist primarily of contributions due from employers for December hours worked. The Plan requires no collateral from the employers. The Plan administrator evaluates the need for an allowance for credit losses based upon factors surrounding the credit risk of specific members, historical trends, and other information. Receivables are written off in the year deemed uncollectible. The Plan's administrator believes that all receivables are collectible and that no allowance is necessary at December 31, 2024 and 2023.

Other receivables – Other receivables include accrued amounts related to late fees of employer contributions. The Plan’s administrator believes that all receivables are collectible and that no allowance is necessary at December 31, 2024 and 2023.

Prepaid insurance premiums – Prepaid insurance premiums represent amounts paid to insurance carriers for premiums related to periods subsequent to year end. At December 31, 2024 and 2023, prepaid amounts were approximately \$4,100,000 and \$3,400,000, respectively.

Accumulated eligibility credits – As described in Note 1, certain indentured apprentices and hourly employees meeting eligibility requirements can accumulate a reserve for coverage for months in which they work less than 115 hours. Estimated liability for accumulated eligibility credit is calculated as accumulated contributions made by employers on behalf of employees, less accumulated premiums for benefits coverage. As of December 31, 2024 and 2023, the estimated liability for accumulated eligibility credits was \$1,076,857 and \$854,819, respectively.

Insurance premiums – Insurance premiums represent amounts paid to insurance carriers for employees’ elected coverage. The premiums are recorded in the period in which the insurance coverage is earned.

Contributions – This Plan is a non-contributory plan. Contributions are determined by the Board of Trustees based on health insurance plans selected by the employees and premiums due to the insurance companies. Contributions are recorded in the year in which the related insurance coverage is earned.

Risks and uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of benefit obligations and net assets available for benefits.

Note 3 – Investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 – Concentrations

Contributions – Employers are to make monthly contributions to the Trust for each employee in an amount determined by the Board of Trustees. For the year ended December 31, 2024, approximately 12 percent of the contributions were from one participating employer. For the year ended December 31, 2023, 20 percent of the contributions were from one participating employer.

Cash – The Plan maintains its cash in bank deposit accounts that, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash.

Note 5 – Accumulated Eligibility Credits, Dollar Bank

As described in Note 1, indentured apprentices and other hourly construction trade employees meeting eligibility requirements are entitled to coverage assuming the participating employee is credited with a minimum of 115 and 130 hours per month, respectively. Management's estimate of the accumulated dollar bank reserve is based upon the number of banked hours multiplied by hourly rates that are an estimated average cost of providing benefits to eligible participants. As of December 31, 2024 and 2023, the estimated liability for accumulated eligibility credits was \$1,013,452 and \$854,819, respectively.

Note 6 – Contract with Administrator

The Plan has an agreement with a third-party administrator, Fringe Benefit Group, to provide administrative services to the Plan. The administrative fee is equal to 3.5 percent of the annual premium for participating employers. Third-party administrative fees for the year ended December 31, 2024, were \$331,963.

Note 7 – Tax Status

The trust funding the Plan has received an exemption letter from the Internal Revenue Service (IRS) dated October 12, 2001, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the Code) as a Voluntary Employee Beneficiary Association (VEBA). The Plan and trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related trust is tax exempt.

Although tax-exempt health and welfare benefit plans are not generally subject to taxation, certain activities of the Plan may be taxable. A VEBA may be subject to unrelated business income tax (UBIT) to the extent that assets exceed certain account limits for health and life benefits. Additionally, unrelated business taxable income (UBTI) of a tax-exempt entity is subject to taxation. For health and welfare benefit plans, UBTI may be generated by certain plan investment types. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Related-Party Transactions

The Plan has administrative services agreements with the ABC Northern California Chapter. As of December 31, 2024 and 2023, payables of approximately \$5,000 and \$27,000, respectively, to the ABC Northern California Chapter were included in accounts payable for administrative expenses. The administrative expenses to the ABC Northern California Chapter was \$57,472 for the year ended December 31, 2024 as included in other administrative expenses on the statement of changes in benefit obligations and net assets available for benefits.

Note 10 – Subsequent Events

Subsequent events are events or transactions that occur after the statement of benefit obligations and net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in its financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of benefit obligations and net assets available for benefits date, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of benefit obligations and net assets available for benefits but arose after the statement of benefit obligations and net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.
