## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of  
Docufree Corporation 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Docufree Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **1. DESCRIPTION OF THE PLAN**

The following description of Docufree Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the official Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Docufree Corporation (the Sponsor) who are at least 18 years old and have completed three months of service. An employee receives credit for one month of service for each month the employee completes one hour of service. Entry dates are monthly following the completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The trustee, who is a designated individual of the Sponsor, is responsible for oversight of the Plan. The trustee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to management.

**Plan Administration**

The Plan is administered by the Sponsor. The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Sponsor's Board of Directors. Transamerica Life Insurance Company (TLIC) is the custodian of the Plan and Retirement Plan Administrators, LLC is the recordkeeper of the Plan.

**Contributions**

Participants may contribute up to 100% of their annual compensation, as defined by the Plan, not to exceed the maximum allowed under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up contributions" to the Plan as allowed under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Sponsor makes a safe harbor matching contribution equal to 100% of the first 4% of eligible compensation that a participant contributes to the Plan. The Sponsor may also make a discretionary matching contribution equal to a discretionary percentage of a participant's compensation or a discretionary dollar amount to be determined by the Sponsor. The Sponsor did not make a discretionary matching contribution in 2024.

The Sponsor may also make a discretionary profit-sharing contribution to the Plan allocated to all employees eligible to participate in the Plan that are employed on the last day of the Plan year and have completed one year of service. The Sponsor did not make a discretionary profit-sharing contribution during 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as allocations and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Effective November 2017, all participants are 100% vested immediately in their contributions and Sponsor safe harbor matching contributions, Sponsor discretionary profit-sharing and Sponsor discretionary matching contributions.

**Forfeitures**

Upon termination of employment, participants forfeit their nonvested balances. The Plan will use forfeitures to reduce Sponsor contributions. At December 31, 2024 and 2023, there was a balance of \$7,373 and \$7,260, respectively, in the forfeitures account. In 2024, there were no forfeitures used to reduce Sponsor contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 2% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions amortized over the life of the loans. The loans must be repaid within five years unless used to purchase a primary residence in which case the term may be extended to 30 years.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or separation from service, a participant, or his or her beneficiary, may receive their vested balance in either a single lump-sum distribution, or a direct rollover into a qualified retirement plan or individual retirement account. If the vested account balance is greater than \$5,000, then in addition to either a lump sum or direct rollover, the participant may choose to receive monthly installments or defer receiving payments until age 72. Terminated participants with a vested balance less than \$5,000 that have not elected payment will be automatically cashed out.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and

changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value except for the fully benefit-responsive investment contract which is stated at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value of a financial investment is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds held in the pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued and has determined that there were no subsequent events that require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

### **3. INFORMATION CERTIFIED BY CERTIFYING ENTITY**

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TLIC.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023.

*Pooled separate accounts:* Amounts allocated to variable investment accounts within TLIC pooled separate accounts are credited to a participant's account in the form of accumulation units. Accumulation units are valued at the net asset value (NAV) of the shares of the underlying investment adjusted for any dividends or distributions received by TLIC and the daily equivalent of any fee charged by TLIC pursuant to the contract. The pooled separate accounts' NAVs are not publicly quoted prices in an active market. The value of an accumulation unit of any investment account is determined at the close of each business day. Based on the contract provisions, the Plan could be subject to delays in redemption of assets held within TLIC based on the total amount of assets requested for liquidation. The delays could range from 30 days up to 12 months.

The Plan's investments at fair value represent investments in pooled separate accounts which are valued using NAV practical expedient. The Plan's investments at contract value represent investments in a fully benefit-responsive investment contract which is valued using contract value. The Plan does not hold any investments requiring categorization within the fair value hierarchy at December 31, 2024 and 2023.

## **5. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2016, the Plan entered into an investment contract with TLIC. Under this contract, TLIC maintains the contributions in a general account. The accounts are credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis and there is no set maturity. The effective credited interest rate is set semiannually and effective on the first day of the semiannual period. Contract charges may reduce this return.

Amounts allocated to the guaranteed investment account will earn interest at the higher of the rate guaranteed under the contract or the current rates established and declared by TLIC.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and thus require the Company to settle at an amount different than contract value paid either within 90 days or over time.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units of pooled separate accounts and a fully benefit-responsive investment contract managed by TLIC as of December 31, 2024 and 2023. Therefore, related transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. The Plan paid recordkeeping fees of \$13,114 to TLIC and Retirement Plan Administrators, LLC, a Plan service provider, during 2024. The Sponsor pays directly any other fees related to the Plan's operations.

## **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would continue to be 100% vested in their Sponsor contributions.

## **8. TAX STATUS**

The Plan operates under a nonstandardized prototype plan document sponsored by Retirement Plan Administrators, LLC. The underlying document has received an opinion letter dated November 30, 2020, stating that the form of the prototype plan is qualified under section 401(a) of the IRC and, therefore, is tax-exempt. In accordance with Revenue Procedures 2010-6 and 2005-16, the Plan administrator has determined that it is eligible to and has chosen to rely on the current Internal Revenue Service (IRS) opinion letter. Once qualified, the Plan is required to operate in conjunction with the IRC to maintain its qualified status. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management believes there are no uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
