Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Five Point 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF THE PLAN

Five Point 401(k) Plan (the “Plan”) is a defined contribution plan established to provide tax-deferred savings opportunities to eligible employees of Five Point Communities Management, Inc. (the “Company”).

The Company is a wholly owned subsidiary of Five Point Operating Company, LP, a Delaware limited partnership (“Op Co”). Op Co is a subsidiary of Five Point Holdings, LLC, a Delaware limited liability company.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan sponsor and Plan administrator. The Company has delegated the day-to-day administration of the Plan to an employee benefits committee.

Specific provisions of the Plan are contained in the Plan document, which governs the legal operations of the Plan.

A. Participation

Employees are eligible to participate in the Plan on the first day of the first pay period beginning on or after the date on which they are 18 years of age.

B. Benefits

Benefits under the Plan begin when a participant retires, becomes disabled, dies or ceases to be an employee, whichever applies. Normal retirement age is 65. Early retirement and hardship withdrawals are permitted. An employee who withdraws any amount of his or her contributions is not permitted to resume participation for 6 months. Company contributions and the related accumulated earnings may be withdrawn only upon one of the four above-listed occurrences.

C. Vesting

Participants hired before January 1, 2005 are immediately vested in all employee deferral contributions, Company matching contributions, rollovers and earnings thereon. For participants hired on or after January 1, 2005, Company matching contributions and related earnings are vested as follows:

D. Contributions

Participants may contribute to the Plan through salary reductions of an elected percentage of the participant’s compensation, as defined in the Plan, up to the statutory maximum as defined by the Internal Revenue Code (“IRC”).

D. Contributions (Continued)

The Company will match 50% of employee contributions of up to 6% of compensation, subject to certain IRC limitations. Company contributions are paid in cash. Company contributions may be suspended if it is deemed appropriate by the Company.

E. Rollovers

The Plan permits eligible rollover contributions from other qualified plans.

F. Participant Accounts

Participants select the investment funds in which their contributions are to be invested from the available funds of the Plan. Company contributions, when made, are invested proportionately in the same funds as the employee contributions. Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, rollover contributions, the Company's matching contributions and allocations of investment earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from his or her vested account.

G. Notes Receivable from Participants

Participants may borrow from their account a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. General purpose loans must be repaid within five years and primary residence loans must be repaid in fifteen years. Interest rates are determined from time to time by the Company pursuant to written procedures. The interest rate on loans outstanding as of December 31, 2024 range from 4.75% to 10.0%.

H. Administrative Expenses

Most expenses incurred in the administration of the Plan are borne by the Company. Investment expenses are netted against returns credited to participants' accounts.

I. Forfeitures

Forfeitures of participants' non-vested account balances shall be used to pay Plan expenses or offset future Company contributions. In 2024, forfeitures totaled \$171,454; \$0 in prior year forfeitures were used to pay plan expenses and \$0 used to offset contributions. Forfeitures available for future use as of December 31, 2024 totaled \$323,135, including earnings of \$6,770. In 2023, forfeitures totaled \$110,226; \$0 in prior year forfeitures were used to pay plan expenses and \$0 used to offset contributions. Forfeitures available for future use as of December 31, 2023 totaled \$144,911, including earnings of \$2,999.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

C. Investment Valuation and Income Recognition (Continued)

Level 1 investment consists of mutual funds that are valued at quoted market prices. Pooled separate accounts and collective trusts are valued at net asset value or its equivalent as a practical expedient to estimate the fair value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the pooled separate accounts or collective trusts held by the Plan at December 31, 2024 and 2023.

Net appreciation of investments includes realized and unrealized gains and losses on investments sold or held during the year.

D. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Plan has received a favorable tax determination letter dated February 8, 2017 from the Internal Revenue Service. The Plan has since been amended; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and Plan assets would be distributed based upon the participants' account balances at that time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held as of December 31, 2024 and 2023 and investment income for the years ended December 31, 2024 and 2023 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower and Empower Annuity Insurance Company, the trustees of the Plan.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments are funds issued by the trustees or their affiliates. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.

NOTE 7 - PLAN AMENDMENT

Effective October 22, 2023, the Plan approved Amendment No. 2 to update language covering collateral for loans, overall limitations on non-hardship withdrawals, conditions and limitations on hardship withdrawals, and forms of payments to participants or beneficiaries.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
