Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Employee Benefit Plan of Paso Del Norte Children's Development Center, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Employee Benefit Plan of Paso Del Norte Children's Development Center's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the Employee Benefit Plan of Paso Del Norte Children's Development Center (the "Plan") provides only general information. Interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan was originally adopted on May 1, 1999. The Plan is a defined contribution plan that covers substantially all employees of Paso Del Norte Children's Development Center (the "Center"). There is no minimum age or service requirement that must be met in order to participate. Employees are not eligible to participate in the Plan if they are non-resident aliens with no U.S. source income, are classified or treated as independent contractors, or are leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Center may or may not make a contribution. The amount of the contribution, if any, is determined at the discretion of the Board of Directors on a year to year basis. For the years ended December 31, 2024 and 2023, the Board approved a 1.5% contribution on the wages earned by each participant. Contributions are subject to certain Plan and Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and the employer's contribution, if any, as well as an allocation of the Plan's earnings and administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from that participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Center's contributions plus actual earnings thereon is according to a graduated schedule based on years of service. Participants who were hired on or after November 1, 2008 are fully vested in these contributions after six years of service. Participants who were hired before November 1, 2008 are fully vested in these contributions after five years of service.

1. DESCRIPTION OF THE PLAN (Continued)

Participant Loans - Loans are not permitted under this Plan.

Payment of Benefits - On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) shall have a nonforfeitable right to receive the full amount available for distribution from their account. Distributions are paid in lump-sum amounts or partial withdrawals.

Forfeitures - Forfeitures of the Center's contributions and earnings thereon resulting from participants leaving the Center prior to vesting are retained in a forfeiture account. Forfeitures may be applied first to the payment of plan administration expenses. Any remaining forfeitures will be re-allocated to plan participants. During 2024, no forfeitures were utilized to pay plan expenses; forfeitures of \$20,339 were re-allocated to plan participants. During 2023, no forfeitures were utilized to pay plan expenses and no forfeitures were re-allocated to plan participants. At December 31, 2024 and 2023, the forfeiture account totaled \$12,940 and \$20,339, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The Plan's investment held in the interest accumulation account at December 31, 2024 and 2023 is invested in a general account of Mutual of America Life Insurance Company and is valued at contract value, which is equal to fair value. The account is considered to be a cash equivalent and is not a fully benefit-responsive investment contract. Cash equivalents are excluded from the fair value hierarchy and disclosure requirement. The account earns interest at a guaranteed rate set annually that cannot be less than 0.15% or more than 3%. The interest rate for 2024 was 2.85% and 1.6% for 2023. There are no adjustments or charges that would affect the value of the account as a result of a withdrawal request. There are no reserves against the account value for credit risk.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Center. Expenses that are paid by the Center are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. For the years ended December 31, 2024 and 2023, the Plan paid \$2,113 and \$1,152, respectively, in administrative fees.

Risks and Uncertainties - The Plan provides for various investment options in any combination of investment securities based upon participant requests. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and investment income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company (the custodian of the Plan).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The pooled separate account consists solely of investments in mutual funds registered with the U.S. Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded. The funds must publish their daily net asset value and transact at that price.

5. TAX STATUS

Although the Plan has not requested determination from the Internal Revenue Service as to the Plan's tax-exempt status, the prototype plan from which the Plan was drafted has received a favorable determination from the IRS. The Plan administrator believes that the Plan is designed to operate in accordance with all applicable provisions of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan is qualified and that the related trust is exempt from taxation under the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. RELATED PARTY TRANSACTIONS

The Plan's investments are held by Mutual of America Life Insurance Company, as custodian; therefore, investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for administrative expenses were \$2,113 and \$1,152 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for the investment and account management services are a reduction of the return earned and are included in net appreciation in fair value of investments.

Personnel and facilities of the Center, which are used by the Plan for its accounting and other activities, have been provided at no charge to the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
