### ***Basis for Opinion***

As further discussed in Note 5 to the financial statements, the Plan Sponsor of the Plan approved a plan of liquidation on June 28, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Also as described in Note 5, pursuant to the Plan's termination the net assets of the Plan were fully distributed as of September 30, 2024. Our opinion is not modified with respect to these matters.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of Lakeland Surgical & Diagnostic Center (the Company) 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution Plan originally effective October 1, 2014. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective May 1, 2022. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: To become a participant, an employee must complete 3 months of service and attain the age of 21 and not be considered an excluded employee as defined in the Plan agreement. An employee will become a participant on the first day of the month immediately following or coincident with the date the employee satisfies the eligibility requirements. Special rules may apply if an employee is terminated and then rehired.

Contributions: The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code. Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax or Roth after-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company is required to make a qualified matching contribution to the Plan. For the period from January 1, 2024 to September 30, 2024 and December 31, 2023, the Company's matching contribution was 100% of participant deferrals up to 4% of the employee's compensation. The Company may, at its discretion, elect to make a qualified profit sharing contribution to the Plan. For the period from January 1, 2024 to September 30, 2024, the Company did not make a profit sharing contribution to the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution Plans or conduit IRA's. Participants direct the investments of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's matching and profit sharing contributions, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting: Participants are immediately vested in their salary deferral contributions, Company matching and profit sharing contributions, and rollover contributions plus actual earnings thereon.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. Per the Addendum to the Adoption Agreement, the interest rate charged is the Prime Rate + 1%. For the period January 1, 2024 to September 30, 2024, interest was charged on notes receivable from participants from 3.25% to 9.5%.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Benefit Payments: Upon termination of service, death, disability, or retirement, the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution or in substantially equal installment payments. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan also provides for in-service distributions for hardship purposes or after attainment of age 59 ½.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and contract administrator fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), as established by the Financial Accounting Standards Board ("FASB"), and in conformity with the financial reporting requirements of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective June 28, 2024 the Plan was terminated and Plan management determined that liquidation was imminent, therefore the basis of accounting was changed from the accrual basis of accounting for an ongoing plan as of December 31, 2023, to the liquidation basis of accounting as of September 30, 2024 and for the period from January 1, 2024 to September 30, 2024. Under the liquidation basis of accounting, assets are reported at estimated net realizable value and liabilities at estimated settlement amounts, including estimated liquidation costs, if reasonably determinable. There was no material impact to the Plan's net assets as a result of the application of the liquidation basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates. It is at least reasonably possible that a significant change may occur in the near term in the estimated fair value of the Plan's investments.

Investment Valuation and Income Recognition: The Plan's investments, are valued at fair value as further described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Administrative Expenses: The Company pays certain administrative expenses on behalf of the Plan.

Payments of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at September 30, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 to September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Stable Value Fund: The fair values of participation units in the stable value collective trust are based upon the net asset values unit as reported by the fund managers. The fund generally provides for daily redemptions by the Plan at reported net asset value per share with no advance notice requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PLAN TERMINATION**

On June 28, 2024, the Plan Sponsor executed a resolution to terminate the Lakeland Surgical & Diagnostic Center 401(k) Plan in connection with the dissolution of the Company. In accordance with the termination:

1. All participants became 100% vested in their account balances as of the termination date.
2. The final contributions to the Plan were made in May 2024.
3. The Plan began the process of distributing all assets to participants and beneficiaries, with final distributions completed in September 2024.
4. Participants were provided with detailed information regarding their distribution options, including the ability to roll over their account balances to an Individual Retirement Account (IRA) or another qualified retirement plan.
5. The Plan administrator will file a final Form 5500 with the Department of Labor.

The Plan was fully liquidated on September 30, 2024 following the completion of all required distributions and administrative processes. As of September 30, 2024, there are no remaining assets or obligations associated with the Plan.

**NOTE 6 - INCOME TAX STATUS**

The Internal Revenue Service issued an opinion letter dated October 6, 2020, indicating that the prototype adopted by the Plan, as then designated, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Transactions during the period with parties-in-interest include administrative services. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest, including LPL Financial Corporation. Certain investments are managed by Reliance Trust Company; therefore, these transactions qualify as party-in-interest transactions. Fees of \$10,560 were paid by the Plan to LPL Financial Corporation during the plan year for certain services related to the Plan. In addition, the Plan paid fees of \$18,250 to the recordkeeper for services during the plan year. These fees are reflected in the financial statements as a reduction of the return on the Plan's investments. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of Lakeland Surgical & Diagnostic Center (the Company) 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution Plan originally effective October 1, 2014. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective May 1, 2022. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: To become a participant, an employee must complete 3 months of service and attain the age of 21 and not be considered an excluded employee as defined in the Plan agreement. An employee will become a participant on the first day of the month immediately following or coincident with the date the employee satisfies the eligibility requirements. Special rules may apply if an employee is terminated and then rehired.

Contributions: The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code. Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax or Roth after-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company is required to make a qualified matching contribution to the Plan. For the period from January 1, 2024 to September 30, 2024 and December 31, 2023, the Company's matching contribution was 100% of participant deferrals up to 4% of the employee's compensation. The Company may, at its discretion, elect to make a qualified profit sharing contribution to the Plan. For the period from January 1, 2024 to September 30, 2024, the Company did not make a profit sharing contribution to the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution Plans or conduit IRA's. Participants direct the investments of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's matching and profit sharing contributions, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting: Participants are immediately vested in their salary deferral contributions, Company matching and profit sharing contributions, and rollover contributions plus actual earnings thereon.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. Per the Addendum to the Adoption Agreement, the interest rate charged is the Prime Rate + 1%. For the period January 1, 2024 to September 30, 2024, interest was charged on notes receivable from participants from 3.25% to 9.5%.

Benefit Payments: Upon termination of service, death, disability, or retirement, the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution or in substantially equal installment payments. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan also provides for in-service distributions for hardship purposes or after attainment of age 59 ½.

Basis of Accounting: The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), as established by the Financial Accounting Standards Board ("FASB"), and in conformity with the financial reporting requirements of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective June 28, 2024 the Plan was terminated and Plan management determined that liquidation was imminent, therefore the basis of accounting was changed from the accrual basis of accounting for an ongoing plan as of December 31, 2023, to the liquidation basis of accounting as of September 30, 2024 and for the period from January 1, 2024 to September 30, 2024. Under the liquidation basis of accounting, assets are reported at estimated net realizable value and liabilities at estimated settlement amounts, including estimated liquidation costs, if reasonably determinable. There was no material impact to the Plan's net assets as a result of the application of the liquidation basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates. It is at least reasonably possible that a significant change may occur in the near term in the estimated fair value of the Plan's investments.

Investment Valuation and Income Recognition: The Plan's investments, are valued at fair value as further described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Administrative Expenses: The Company pays certain administrative expenses on behalf of the Plan.

Payments of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest, including LPL Financial Corporation. Certain investments are managed by Reliance Trust Company; therefore, these transactions qualify as party-in-interest transactions. Fees of \$10,560 were paid by the Plan to LPL Financial Corporation during the plan year for certain services related to the Plan. In addition, the Plan paid fees of \$18,250 to the recordkeeper for services during the plan year. These fees are reflected in the financial statements as a reduction of the return on the Plan's investments. Notes receivable from participants also reflect party-in-interest transactions.
