### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Occunet, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of Plan**

The following description of the Occunet, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan, established February 1, 2016, is a defined contribution plan available to qualifying employees of Occunet, LLC and related employers: FairRx, LLC and DealOn LLC (collectively, the “Company” or “Plan Sponsor”). Effective March 1, 2024, Fairly Consulting Group, LLC is no longer eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

*SECURE 2.0 Act*

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included the Setting Every Community Up Retirement Act (“SECURE”) 2.0 Act. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2033. Since the provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance prior to the deadline, December 31, 2026. Effective January 1, 2023, the age requirement for minimum distributions was raised to 73 from 72 for any participant who turns 72 on or after January 1, 2023. Certain provisions became effective for 2024, including changes to long-term part-time eligibility. These changes had no material impact on the Plan’s 2024 financial statements.

*Change in Third Party Administrator*

Effective March 1, 2024, the Plan’s custodian changed from John Hancock Life Insurance Company to Delaware Charter Guarantee & Trust Company (d/b/a Principal Trust Company). Effective March 8, 2024, assets totaling \$14,629,530 were transferred to the new custodian.

*Plan Restatement*

In conjunction with the change in the Plan’s third party administrator, the Plan was restated as of March 1, 2024. The following provisions were adopted:

1. Upon meeting eligibility, all employees of the Company will be automatically enrolled at a deferral rate of 5%, unless otherwise requested by the employee.
2. The Plan now allows for a maximum of 2 loans to be outstanding to a participant at any given time.
3. Fairly Consulting Group, LLC is no longer eligible to participate in the Plan.

**Eligibility**

All employees, except those covered by a collective bargaining agreement, non-resident aliens, or leased employees, who have attained the age of 21 and completed 60 days and 1,000 hours of service are eligible to participate in the Plan. Employees join the Plan as an active participant on the first day of the next quarter following satisfaction of the eligibility requirements. Employees are automatically enrolled in the Plan at a pre-tax deferral rate of 5%, unless an affirmative election not to contribute is made by the employee on the first day of the next quarter following satisfaction of the eligibility requirements. The Plan does not provide for an escalation of the automatic deferral rate.

**Contributions**

*Participant Contributions*

Participants may elect to contribute between 1% and 100% of their eligible compensation, as defined by the Plan, subject to certain Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”). Participants have the option of designating a portion of their elective deferral contributions as after-tax (“Roth”) contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or benefit plans.

*Safe Harbor Matching Contributions*

The Company, makes safe harbor matching contributions for a percentage of a participant’s deferred salary contribution. During the Plan year ended December 31, 2024, safe harbor matching contributions were equal to 100% of the first 3% of participant participant deferrals, and 50% of the next 2% of participant deferrals, up to a maximum of 4% of a participant’s eligible compensation. For the year ended December 31, 2024, safe harbor matching contributions totaled \$665,657, net of forfeitures utilized.

*Employer Non-Elective Contributions*

The Company, at its discretion, may make non-elective contributions. During the Plan year ended December 31, 2024, the Company made no such non-elective contributions.

*Qualified Matching Contributions*

The Company, at its discretion, may make qualified matching contributions. During the Plan year ended December 31, 2024, the Company made no such qualified matching contributions.

Participant contributions and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Participant Accounts**

Each participant’s account is credited with the participant’s voluntary contributions and any Company contributions. Earnings are credited to each participant account based on the performance of the underlying investments. Participants may direct the investment of their account balances into various investment options offered by the Plan.

**Investment Options**

Participants direct both employee and employer contributions to be invested amongst various investment options as made available and determined by the plan administrator, which are more fully described in the Plan literature.

**1. Description of Plan (continued)****Vesting**

Participants are always vested in their rollover contributions, deferral contributions, safe harbor matching contributions, and any earnings thereon. Any Company contributions received vesting according to the table below. Any contributions and earnings forfeited due to vesting can be used to offset future Company contributions and reduce Plan administrative expenses.

**Participant Loans**

Prior to March 1, 2024, participants could take a maximum of 1 loan. Effective March 1, 2024, participants may take a maximum of 2 loans up to the lesser of: (a) one-half of the respective participant's vested account balance, or (b) \$50,000, reduced by their highest loan balance of the sum of all of the respective participant's loans from the Plan during the one year period ending on the day before the loan is funded. The 401(k) loan may not be less than \$1,000. Interest and principal payments will be credited to the borrower's account. The repayment period for participant loan cannot exceed five years unless the proceeds are used to acquire, construct, or rehabilitate a dwelling unit that is used for the participant's personal residence. In that case, the period of repayment can be extended up to 15 years. The notes bear interest at a rate equal to the Prime rate plus 1%.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive their vested benefit in either a lump-sum distribution or a direct rollover distribution. Participants who are still employed by the Company but have reached age 59 ½ may withdraw all or any part of their vested balance, subject to Plan provisions. Hardship withdrawals are permitted subject to Plan provisions and IRS requirements.

**Forfeited and Unallocated Accounts**

Forfeitures (the non-vested portion of a participant's account) are created when a participant's employment terminates before becoming fully vested under the Plan. Forfeitures will be used for the benefit of other participants of the Plan or be used to reduce employer contributions. During the year ended December 31, 2024, a total of \$92 was forfeited by participants. During the year ended December 31, 2024, the Plan utilized \$92 to reduce Company contributions.

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). The pooled separate accounts are stated at net asset value (“NAV”) as determined by the trustee at the end of the plan year. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, trustee, and insurance company. Refer to Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants represent loans and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Recently Adopted and New Accounting Principles**

In June 2016, the Financial Accounting Standards Board issued Accounting Standards Update (“ASU”) No. 2016-13, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, and subsequent amendments to the initial guidance, ASU 2019-10. This accounting standard changes the methodology for measuring credit losses on financial instruments and the timing of when such losses are recorded. ASU No. 2016-13 is effective for fiscal years, and interim periods within those years, beginning after December 15, 2022. The Plan adopted the provisions of ASU 2016-13 for the year ended December 31, 2023. The adoption of this standard did not have a material impact on the Plan's financial statements.

**Subsequent Events**

Subsequent events have been evaluated through the date of the report of independent auditors, which is the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

**3. Information Certified by the Plan's Trustee, Custodian, and Record-Keeper (unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the Period from January 1, 2024 to March 19, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the record-keeper of the Plan. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024, and net appreciation (depreciation) in fair value of investments and interest and dividends for the period from March 1, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company (d/b/a Principal Trust Company), the trustee of the Plan, the trustee, custodian, and record-keeper of the Plan.

**4. Fair Value Measurements**

The fair value hierarchy prioritizes the inputs used to measure fair value, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV (or "unit value") of the units held by the Plan at year-end based on information reported by the custodian. The NAV is used as a practical expedient to estimate fair value. The NAV of each of the separate accounts is calculated in a manner consistent with the U.S. GAAP for investment companies and is determinative of their fair value and represent the price at which the Plan would be able to initiate a transaction. Several of the separate accounts invest in publicly quoted mutual funds or actively managed stocks. Some of the separate accounts also invest in fixed income securities. The fair value of the underlying mutual funds or stocks and of the underlying securities, which is based on quoted prices of similar assets, is used to determine the NAV of the separate account which is not publicly traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Group Annuity Contract with Principal Life Insurance Company

The Plan has entered into a fully benefit-responsive investment contract (“FBRIC”) (the Principal Fixed Income Guaranteed Option) with Principal Life Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Investments in FBRICs are measured, presented, and disclosed at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### 6. Related-Party and Party in Interest Transactions

The Plan made payments to the record keeper, custodian, trustee, and other third party administrators totaling \$58,012 during the year ended December 31, 2024. The plan sponsor paid directly any other fees related to the Plan's operations.

### 7. Tax Status

Prior to March 1, 2024, the Plan used a prototype plan document sponsored by July Business Services, Inc. The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Effective March 1, 2024, the Plan adopted a volume submitter 401(k) and profit sharing plan with cash or deferral arrangement sponsored by Principal Life Insurance Company, which received a favorable opinion letter from the IRS dated June 30, 2020, stating that the Plan, as then designed, was acceptable under Section 401(a) of the IRC, and therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits taken by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and non-forfeitable.

**9. Risks and Uncertainties**

The Plan provides for various options in any combination of specified investments. The underlying investments may include stocks, bonds, fixed income securities, mutual funds and other investment securities. Such investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
