1. Description of the Plan

The following description of the Roze Room Hospice 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under the provisions of Section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

The Plan covers all eligible employees (except union and leased employees, and nonresident aliens) of L & A Care Corporation dba Roze Room Hospice, Roze Room Hospice of the Valley, Inc. dba Roze Room Hospice of the Valley, Global Management Solutions, Inc., Liberty Health Services, Inc. dba Roze Room Hospice of Ventura, Royz, Inc. dba Roze Room Hospice of San Gabriel Valley, and Vega Healthcare, Inc., dba Roze Room Hospice of South Bay (collectively known as the Company) who have reached age 21 and have one year (1,000 hours) of credited service. The Plan provides for dates of entry on January 1 and July 1 of each year.

Contributions

Participant contributions:

Each year, participants may contribute up to 100% of their annual pretax compensation or after-tax annual compensation as defined by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. Participants may not make annual contributions in excess of the government-imposed limit, which is \$23,000 for year ended December 31, 2024. The government-imposed limit is increased to \$30,500 for participants who reach age 50 by year-end. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, even if they are not yet eligible to make salary deferrals.

Employer safe harbor matching contributions:

Each Plan year, the Board of Directors may make a safe harbor matching contribution in an amount equal to 100% of the first 3% plus 50% of the next 2% of the participants' deferred compensation. During the year ended December 31, 2024, the employer matching contribution was \$338,838.

Employer discretionary profit sharing contributions:

Each Plan year, the Board of Directors may make a discretionary profit sharing contribution on behalf of participants who have completed one year of service and are employees on the last day of the Plan year. During the year ended December 31, 2024, there was no employer profit sharing contribution made to the Plan.

1. Description of the Plan (continued)

Investment options

Participants must direct their salary deferral contributions and their share of the Company's contributions into various investments as made available and determined by the Plan Administrator, which are more fully illustrated in the Plan's literature.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and Company safe harbor contribution plus actual earnings thereon. Vesting in the Company matching and discretionary profit sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant vests 20% after two years of credited service and by 20% for each year thereafter. Participants are 100% vested after six years of credited service. A participant is also fully vested upon death, total disability, or normal retirement.

Payment of benefits

Upon termination of service due to death, disability, retirement, or termination, a participant or the participant's beneficiary will receive the value of the vested account balance either in a lump-sum distribution or in equal installments over a period of not more than his or her life expectancy determined at the time of distribution. Hardship distributions are not allowed under the Plan. There is an automatic cash-out provision for participants with balances not exceeding \$5,000.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$67,644 and \$45,770, respectively. This balance may be reallocated back to participants, used to offset plan administrative expenses, or applied against employer contributions. During the year ended December 31, 2024, there were no forfeited amounts utilized to offset plan administrative expense. There were also no forfeited amounts reallocated back to participants or applied against employer contributions during the years ended December 31, 2024 and 2025.

2. Summary of accounting policies

A summary of the significant accounting policies followed by the Plan in the preparation of the accompanying financial statements is as follows:

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in conformity with generally accepted accounting principles in the United States of America.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and are charged directly to the participant's account.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in a variety of investment funds. Investments, in general, are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued. There were no subsequent events noted that would require adjustment to or disclosure in these financial statements.

3. Certified investments

Certified information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividend income, and administrative expenses for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company.

4. Fair value measurements

The framework for measuring fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level II – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair value measurements (continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Stable value fund*: Valued at the NAV of units held by the Plan at year-end, which is considered by plan management to be the best approximate fair value. The unit values of common collective trust funds with underlying equity investments are calculated based on the observable value of the underlying investments. Funds held in common collective trusts may generally be redeemed daily without restriction.

Although it has not expressed any intent to do so, the Company has the right under provisions of the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6. Related party transactions and party in interest transactions

Certain Plan investments are shares of mutual funds managed by American Funds and Capital Bank and Trust Company (CBTC). CBTC is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments, because they are paid through revenue sharing rather than direct payment. The Plan or the Company may make a payment for administrative expenses not covered by revenue sharing.

7. Tax status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
