Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN

The following description of the Silvercrest Properties 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a single-employer defined contribution 401(k) plan, adopted effective January 1, 2005, covering substantially all full-time employees who have one year of service and are age twenty-one or older. An employee enters the Plan the first day of the Plan year quarter coinciding with or next quarter following the date the eligibility requirements are met. The Plan excludes union employees, non-resident aliens, leased employees and reclassified employees.

SilverCrest Properties, LLC (the Employer) is the Plan Sponsor and Plan Administrator. SilverCrest Dining Services Corporation and SilverCare, LLC are participating employers. The Standard Insurance Company has been appointed the Plan's custodian. StanCorp Financial Group, Inc. provides recordkeeping services for the Plan. The Plan Document was restated effective January 1, 2022, to comply with IRS regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Investments are held in pooled separate accounts.

Contributions - Participants are allowed to make an elective pretax (traditional 401(k)) deferral contribution up to Internal Revenue Service (IRS) limits. Participants are also allowed to make after-tax (Roth 401(k)) deferral contributions up to IRS limits. In addition, participants who have attained the age of 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Employer may make matching discretionary contributions. During 2024, the Employer made matching contributions in an amount equal to 50% of each participant's eligible contributions up to 4% of compensation. Profit sharing contributions are not allowed by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) any discretionary match and (b) Plan earnings and increases or decreases in the value of investments, net of expenses. Allocations are based on account balances, participant earnings and losses, or specific participant transactions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits - On termination of service due to death, disability, retirement, or other reasons, participants may receive the value of the vested interest in their account in partial withdrawals or as a lump sum distribution.

Vesting - The participant's elective deferral contributions and earnings thereon are always 100% vested. For the Employer contributions and earnings thereon, vesting is based on years of service. A participant is 100% vested after elapsed time rules have been met for five years of service. Notwithstanding the above, a participant's account will be fully vested upon death, disability or reaching age 65.

Notes Receivable from Participants - Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Forfeitures - Forfeitures are used to pay Plan administrative expenses and reduce future employer matching contributions to the Plan. Forfeited non-vested accounts totaled \$4,844 and \$2,176 at December 31, 2024 and 2023. In 2024, administrative expenses of \$1,211 were paid out of forfeitures and \$37 of forfeitures were used to reduce employer matching contributions.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Employer contributions are allocated on the same basis as participant contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates that affect amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment (deemed distribution) is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Employer pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

4. INCOME TAX STATUS

The volume submitter plan document adopted by the Plan obtained its latest advisory letter dated June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the advisory letter, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts (PSA's) are comprised of mutual funds held in sub-accounts of an insurance company. The fair value of each pooled separate account is determined using the value per unit, which is based on the value of the underlying mutual fund shares which are actively traded. There are no redemption restrictions or unfunded commitments in the pooled separate accounts.

Because Net Asset Value (NAV) is used as a practical expedient, these investments are not categorized within the fair value hierarchy. The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the pooled separate accounts could result in a different fair value measurement at the reporting date.

6. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions and all of the assets will be distributed to the participants based upon the balances in their respective accounts.

7. **PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are shares of pooled separate accounts managed by the custodian and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid StanCorp Financial Group, Inc., the recordkeeper of the Plan, \$15,887 during 2024.

The Plan's sponsor, SilverCrest Properties, LLC, pays certain administrative expenses of the Plan.

Notes receivable from participants qualify as party-in-interest transactions.

8. **SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available for issue, and identified no further significant events or transactions to disclose.
