Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Creoal Consulting 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Plan assets were transferred to the control of the SMX 401(k) Plan on December 31, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The Summary Plan Description of the Creoyal Consulting 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) profit sharing plan, established January 1, 2011, covering all employees of Creoyal Consulting, LLC (the Employer) who have attained the age of twenty-one. There is no service requirement. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

The Financial Accounting Standards Board (The FASB) has consolidated all Generally Accepted Accounting Principles (GAAP) into one source, referred to as the FASB Accounting Standards Codification (FASB ASC). Accordingly, all references to GAAP included herein will appear as FASB ASC XXX-YY where XXX is a "topic" and YY is a paragraph.

Merger

The Plan was merged into the SMX 401(k) Plan effective December 31, 2024, and legal title and responsibility was transferred to the SMX 401(k) Plan effective December 31, 2024. Employees who were participants in the Plan became participants in the SMX 401(k) Plan effective December 31, 2024. Assets totaling \$18,620,753 from the Plan were transferred into the SMX 401(k) Plan on January 6, 2025.

Contributions

Participants may elect to contribute a portion of their annual compensation to the Plan. This elective contribution is limited to the lesser of compensation or \$23,000 and \$22,500 for the 2024 and 2023 plan years, respectively. Employees, age 50 and older, are eligible to make additional "catch up" contributions in amounts up to \$7,500 and \$7,500 for 2024 and 2023, respectively. The Company provides a discretionary matching contribution equal to a percentage of employee contributions up to 3% of eligible compensation for employees. In addition, the Employer may make a discretionary profit sharing contribution to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of matching contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their deferral contribution plus actual earnings thereon. Vesting in the Employer's contribution accounts is based on years of service. A participant is 100% vested after six years of credited service.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account and bear interest at a rate reasonable at the time of the loan. The loan interest rates vary from 5.25% to 10.5% at December 31, 2024 and 2023.

Forfeitures

Non-vested amounts will be forfeited by participants upon termination, and may be used to pay administrative expenses of the Plan or to reduce the discretionary Employer contributions.

Tax Status

The Plan is a prototype Plan that was adopted by the Employer. The Plan itself has not obtained a determination letter. However, the Plan administrator and Ascensus Trust Company believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Tax returns for 2022 and subsequent years remain subject to examination.

Investment Options

The Plan invests participant directed contributions in a variety of investment options, including Pooled Accounts. A Pooled Account is a mix of investments that pools participant contributions and invests in stocks, bonds, money market instruments or a combination of these investments.

The employer's contributions will be invested into the same funds as the elective contributions.

Payment of Benefits

Retirement benefits will be made as a lump sum payment. Payment of benefits normally begins at retirement age (as defined). Special provisions apply for death and disability benefits. Benefits are recorded when paid.

Administrative Expenses

Substantially all of the Plan's administrative expenses for 2024 and 2023 were assumed by the Plan.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Investment Valuation

The Plan's investments are stated at their fair market value as reported to the Plan by Ascensus Trust Company.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023 and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information which was certified includes investments of \$0 and \$13,162,549 at December 31, 2024 and 2023, respectively, and related investment value increase of \$1,960,600 in 2024 and increase of \$1,946,417 in 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - INVESTMENTS (CONTINUED)

The Plan's investments are held by the custodian, Ascensus Trust Company. The following represents investments at December 31, 2024 and 2023 and also provides a detail listing of plan investments which exceed 5 percent of total plan assets. Certain of these investments may engage in limited derivative transactions, such as futures contracts and options. All investments are subject to market risk, the risk that future changes in market conditions may make an investment less valuable. Investments at December 31, 2024 and 2023 were as follows:

During 2024 and 2023, the Plan's investments (including investments bought, sold and held during the year) appreciated in value by \$1,960,600 and \$1,946,417, respectively.

NOTE 4 - FUTURE BENEFITS TO BE PAID

Included in net assets available for plan benefits at December 31, 2024 and 2023 were \$0 and \$1,379,537, respectively, of accounts of terminated participants.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

As discussed on Note 1, the Plan was merged into the SMX 401(k) Plan effective December 31, 2024, and legal title and responsibility was transferred to the SMX 401(k) Plan effective December 31, 2024. Employees who were participants in the Plan became participants in the SMX 401(k) plan effective December 31, 2024. There was no impact to vesting as a result of the merger.

NOTE 7 - FAIR VALUE MEASUREMENTS

The FASB established a single definition of fair value and a framework for measuring fair value that is intended to result in increased consistency and comparability in fair value measurements. It also expanded disclosures about fair value measurements and applies whenever other authoritative literature requires (or permits) certain assets or liabilities to be measured at fair value, but does not expand the use of fair value.

Items carried at fair value on a recurring basis consist of marketable debt and equity securities and derivative financial instruments which are valued primarily based on quoted prices in active or brokered markets for identical as well as similar assets and liabilities. Items carried at fair value on a non-recurring basis generally consist of assets held for sale, other than inventory. The Plan does not have long-lived assets.

The Fair Value Measurement Topic of the FASB Accounting Standards Codification defines fair value, establishes a consistent framework for measuring fair value and expands disclosure requirements for fair value measurements. The disclosures required under this Topic have been included in this note.

Fair Value Hierarchy

The Fair Value Measurements Topic of the FASB Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Company has the ability to access at the measurement date.

Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 inputs are unobservable inputs for the asset or liability.

Determination of Fair Value

Under the Fair Value Measurements Topic of the FASB Accounting Standards Codification, the Plan bases its fair value on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. It is the Plan's policy to maximize the use of observable inputs and minimize the use of unobservable inputs when developing fair value measurements, in accordance with the fair value hierarchy. Fair value measurements for assets and liabilities where there exists limited or no observable market data and, therefore, are based primarily upon management's own estimates, are often calculated based on current pricing policy, the economic and competitive environment, the characteristics of the asset or liability and other such factors. Therefore, the results cannot be determined with precision and may not be realized in an actual sale or immediate settlement of the asset or liability. Additionally, there may be inherent weaknesses in any calculation technique, and changes in the underlying assumptions used, including discount rates and estimates of future cash flows, that could significantly affect the results of current or future value.

The following is a description of valuation methodologies used for assets and liabilities recorded at fair value.

Mutual Funds: The value of these funds is provided by Ascensus Trust Company. Therefore, these investments are classified within Level 2 of the valuation hierarchy.

The NAV is an input other than a quoted price that is observable. Therefore, these investments are classified within Level 2 of the valuation hierarchy.

Receivables and Participant Loans: The carrying amounts of these assets approximate fair value because of the short maturity of these instruments. Receivables and participant loans are classified within Level 2 of the valuation hierarchy.

Cash and cash equivalents, short-term financial instruments, and receivables

Investments in mutual funds, separate pooled accounts and guaranteed investment accounts

Investments in mutual funds, separate pooled accounts and guaranteed investment accounts are recorded at fair value on a recurring basis based on fair values provided by Ascensus Trust Company. There were no investments in separate pooled accounts and guaranteed investment accounts at December 31, 2024 and 2023.

Participant Loans

Participant loans are carried at amortized cost and are fully secured by participant account balances. Because there is no market for these types of loans, amortized cost approximates fair value.
