INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the RMD Management, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the RMD Management, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is designed to be a defined contribution plan covering employees of RMD Management, Inc. (the "Company") who are 18 years of age or older and have completed three months of service. Employees who do not wish to participate in the plan must elect not to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may elect under a salary reduction agreement, to contribute to the Plan up to 100% of their compensation, as defined by the Plan agreement, through payroll deductions subject to certain limitations under the Internal Revenue Code (IRC). Salary deferrals can be pre-tax 401(k) deferrals or Roth 401(k) deferrals. In addition, the Company may make a discretionary matching contribution equal to a uniform percentage of participant salary deferrals. Each year the Company will determine the amount of the discretionary percentage. The Company may also make a discretionary profit sharing contribution to participant accounts. Participants direct the investment of all contributions made on their behalf.

Eligible employees are automatically enrolled in the Plan at a 3% pre-tax deferral rate unless they elect otherwise. Effective October 1, 2024, the Plan was amended to increase the automatic enrollment deferral rate to 5%. The Plan also provides for automatic annual increases of 1% each year, up to a maximum deferral rate of 10% of compensation. Employees may change their deferral percentage or opt out of the Plan at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, (a) the Company's contributions, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the balance in the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in matching and discretionary contributions to participant accounts plus the earnings thereon is based on years of credited service. A participant is 20% vested after one year of credited service and an additional 20% vests each year until the participant is 100% vested after five years of credited service.

1. DESCRIPTION OF THE PLAN - *Continued*

Distribution of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive his or her contribution and the vested portion of the employer's contribution in a lump sum or annual installments over a reasonable period of time. For termination of service due to other reasons, participants with vested benefits less than \$5,000 will receive a lump sum distribution. Under certain circumstances, participants may withdraw their account balances prior to the occurrence of these events.

Forfeitures

Forfeitures of non-vested Company contributions may be used to pay any administrative expenses and to reduce future Company contributions. For the year ended December 31, 2024, \$1,936 of participant accounts were forfeited and accumulated in cash to be used to reduce future Company contributions or administrative expenses. As of December 31, 2024 and 2023, there was \$16,317 and \$14,381, respectively, of accumulated forfeitures that had not yet been applied to reduce Company contributions.

Administrative Expenses

The Plan's governing document allows administrative expenses to be paid by either the Plan or the sponsor. During the year ended December 31, 2024 all administrative expenses were paid by both the Plan and the Plan sponsor.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the Plan. In the event of Plan termination, participants would become 100% vested in their employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are presented at fair value, based on quoted market prices of the underlying securities within each fund as of December 31, 2024 and 2023. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Risks and Uncertainties

The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange rate, credit and overall market fluctuation. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair Value Measurements - *Continued*

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Tax Status

The Plan is a non-standardized defined contribution prototype plan sponsored by John Hancock. The prototype plan has received a letter from the Internal Revenue Service as to its qualified status. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not applied for a subsequent determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes have been made in the financial statements.

Subsequent Events

For the year-ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through the date of the independent auditors' report, which is the date the financial statements were available to be issued.
