### Note 1 - Plan Description

The following description of Corporate Coverage Company, Inc. Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Corporate Coverage Company, Inc. and affiliates (the "Company") who have completed two months of service and are age 18 or older. Leased employees and certain nonresident alien employees are not eligible for participation in the Plan. Eligible employees can enter the Plan on the first day of the month following the date that the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Upon eligibility, all participants, other than union employees who do not select a contribution percentage, are automatically enrolled in the Plan at a contribution rate of 6 percent of compensation. Unless a participant requests otherwise, deferral contributions will automatically increase at a rate of 1 percent of compensation annually to a maximum deferral percentage total of 10 percent. Participants who have reached age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may make discretionary matching and profit-sharing contributions. Participants must be actively employed on the last day of the plan year to be eligible for the profit-sharing contribution. During 2024, the Company provided discretionary matching contributions equal to 15 percent of the first 6 percent of eligible deferred compensation subject to IRS maximum eligible compensation limitations. The Company made no discretionary profit-sharing contributions in 2024.

The Company also made a nonelective fixed contribution to LPR Truck Drivers; RSF Truck Drivers; Midwest Paper Retriever Truck Drivers; Millennium Recycling, Inc. Truck Drivers; and Midwest Waste Solutions, Inc. Truck Drivers equal to 3 percent of eligible compensation in 2024. The Company also made a nonelective fixed contribution to the following employees of Equipment Services Plus, LLC: journeymen mechanics equal to 3 percent of eligible compensation, parts men and welders equal to 2 percent of eligible compensation, and porters equal to 1 percent of eligible compensation in 2024.

During 2024, the Company did not remit certain employee deferrals and participant notes receivable payment amounts to the Plan within the Department of Labor's required time frame. The late participant contributions were remitted to the Plan during 2024. The Company remitted associated lost earnings to the Plan in 2025.

During 2023, the Company did not remit certain employee deferrals and participant notes receivable payment amounts to the Plan within the Department of Labor's required time frame. The late participant contributions were remitted to the Plan during 2023. The Company remitted associated lost earnings to the Plan in 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Note 1 - Plan Description (Continued)**

***Vesting***

Participants are immediately 100 percent vested in their contributions and related earnings. Vesting in the portion of their accounts related to the Company's contributions plus related earnings is based on years of credited service. Participants become 20 percent vested after two years of credited service and an additional 20 percent each successive year through year six, at which time they are fully vested. Participants are also fully vested upon reaching the Plan's normal retirement age of 59½ or because of death or disability.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or delay payment until the year in which the participant attains the age of 70½. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Financial hardship withdrawals must comply with regulations and interpretations established by the Internal Revenue Service. In-service distributions may be made from a participant's vested account at any time after the attainment of age 59½.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. At December 31, 2024 and 2023, forfeited account balances totaled \$11,904 and \$27,097, respectively. These balances may be used to offset plan administration expenses and future employer contributions. During 2024, no forfeited amounts were used to offset employer contributions.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their account balances or \$50,000. Loan terms range from one to five years. Loans for the purchase of a principal residence can be paid over a reasonable period of time, which may exceed five years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through monthly payroll deductions.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Newport Trust Company, LLC and Ascensus, LLC or its affiliates. Ascensus, LLC and Newport Trust Company, LLC are the trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net realized and unrealized losses on investments include gains and losses on investments bought and sold, as well as held, during the year. See Note 4 for further discussion of fair value measurements.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based on the terms of the plan document.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Plan. Certain administrative fees related to the administration of the Plan were paid by the Company. These transactions qualify as party-in-interest transactions.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 7, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

In 2024, the Plan changed its trustee from Newport Trust Company, LLC to Ascensus Trust Company (collectively, the "Trustees"). The Trustees held the Plan's investments and participant notes receivable and executed all related transactions during the periods under audit. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Newport Trust Company, LLC and Ascensus, LLC on behalf of the Ascensus Trust Company.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Note 4 - Fair Value Measurements (Continued)**

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at closing quoted prices reported in active markets.

**Common/Collective Trust Fund**

The Invesco Stable Value fund is a common/collective trust fund investment and is valued at net asset value (NAV) per unit, as determined by the administrator of the trust. Such NAV is based on the value of the underlying assets and liabilities of the trust. There are no unfunded commitments or redemption restrictions related to this investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
