Independent Auditors' Report

To the Plan Administrator and Investment Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Seagate Development Group LLC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The Plan is a defined contribution plan covering eligible employees of Seagate Development Group, LLC and the participating employers, Earth Tech Enterprises Inc, Seagate Management Services Inc, Seagate Realty LLC, and Theory Design (collectively, the Company). The Plan covers all employees of the Company who have attained 21 years of age and have completed 250 hours of service during the first three months of employment or have completed one year of service, as defined. The Plan excludes non-resident aliens, collectively bargained employees, and leased employees. Once a participant satisfies the eligibility requirements, he or she may enter the Plan on the first day of the month coinciding with or following the attainment of eligibility.

The Plan was originally established on January 1, 2015 and was most recently amended via a restatement effective January 1, 2022.

The Plan Administrator and the Investment Committee are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. The Plan is subject to the provisions of the Internal Revenue Code of 1986 (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA).

Setting Every Community Up for Retirement Enhancement (SECURE) Act and SECURE 2.0 Act

The SECURE Act and the SECURE 2.0 Act had various provisions take effect during the year ended December 31, 2024. The most significant change required including long-term part-time (LTPT) employees who attained 500 or more hours of service in three consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. The Plan is required to be formally amended on or before December 31, 2025 for the SECURE Act and on or before December 31, 2026 for the SECURE 2.0 Act.

Contributions

Participants may contribute a portion of eligible compensation, as defined, as pre-tax and Roth contributions once eligible to enter the Plan. Participants that have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for safe harbor employer matching contributions for eligible participants equal to 100% of the first 4% of each participant's eligible compensation, as defined, contributed to the Plan on each payroll period. Safe harbor employer matching contributions for the year ended December 31, 2024 totaled \$411,918.

The Plan also provides for discretionary non-elective employer contributions for eligible participants who have completed one year of service, as defined. Each eligible participant must also remain employed on the last day of the plan year, unless terminated due to death or disability, and attain 1,000 hours of service during the plan year. No such discretionary non-elective employer contributions were made during the year ended December 31, 2024.

The Plan also previously provided for Qualified Automatic Contribution Arrangement (QACA) safe harbor employer matching contributions, which are no longer provided by the Plan; however, certain balances in the Plan remain from the QACA safe harbor employer matching contribution source.

Contributions and compensation are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, safe harbor employer matching contributions, discretionary non-elective employer contributions, and an allocation of the Plan's earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan, if any. The allocation of earnings and losses is based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan permits its participants to obtain loans against their account balances. A participant may borrow from his or her vested account a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 reduced by the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made, or 50% of his or her vested account. An employee may only have two loans outstanding at any point in time. A participant may not renegotiate the terms of a loan.

A participant loan must provide for level amortization with payments to be made not less frequently than quarterly. Loan repayments must be made through payroll withholding, ACH and/or coupon payment. Loan terms are limited to a maximum of five years with the exception of loans used to purchase a primary residence, which is limited to ten years or such longer period that is commensurate with the repayment period permitted by commercial lenders for similar loans. Notes receivable from participants are secured by the balances in the applicable participant accounts and bear interest at 1% above the prime interest rate (8.50% as of December 31, 2024).

A participant will be considered to be in default if any scheduled repayment with respect to such loan is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. If a participant defaults on a participant loan, the Plan may not offset the participant's account balance until the participant is otherwise entitled to an immediate distribution. For this purpose, a loan default is treated as an immediate distribution event. The participant may repay the outstanding balance of a defaulted loan (including accrued interest through the date of repayment) at any time. A participant loan becomes due and payable in full immediately upon a participant's termination of employment, at which point the participant may repay the entire outstanding balance of the loan (including any accrued interest) within a reasonable period following termination of employment. If the participant does not repay the entire outstanding loan balance, the participant's vested account balance will be reduced by the remaining outstanding balance of the loan. A participant may request a direct rollover of the loan note to another qualified plan which agrees to accept a direct rollover of the loan note. A participant may not engage in a direct rollover of a loan to the extent the participant has already received a deemed distribution with respect to such loan. As of December 31, 2024, the rate of interest on outstanding notes receivable from participants ranged from 8.50% to 9.50% with various maturities through December 2029.

All loans are subject to the applicable provisions of the Plan.

Vesting

Participants are immediately vested in his or her voluntary contributions and safe harbor employer matching contributions, plus actual earnings thereon. Each participant begins vesting in discretionary non-elective employer contributions after two years of credited service, as defined, and become fully vested after six years of credited service, as defined. Each participant vests in QACA safe harbor employer matching contributions based on years of continuous service and become fully vested after two years of credited service, as defined. If a participant is employed at the time of death, disability, or normal retirement age (65), the participant's account becomes fully vested.

Forfeitures

Forfeitures represent the nonvested portion of terminated participant account balances plus related earnings. Forfeitures will be applied for the plan year following the plan year in which forfeitures occur, first to pay plan expenses and then to reduce employer contributions. As of December 31, 2024 and 2023, there were no forfeitures held by the Plan. During the year ended December 31, 2024, no forfeitures were used to pay administrative expenses or reduce employer contributions.

Payment of Benefits

A participant's vested account may be distributed to the participant (or the participant's beneficiary in the event of the participant's death) at death, disability, or termination. No special distribution rules apply to disabled employees; however, a participant who terminates employment on account of becoming disabled may receive a distribution of his or her vested account balance in the same manner as a regular distribution upon termination. Distributions may be taken in the form of lump sum upon termination of employment; however, the Plan Administrator may permit a participant to take partial distributions or installment distributions solely to the extent necessary to satisfy the required minimum distribution rules. If a participant begins receiving a distribution of his or her benefits under the Plan and subsequently dies prior to receiving the full value of his or her vested account balance, the remaining benefit will continue to be paid to the participant's beneficiaries in accordance with the form of payment that has already commenced. If a participant dies before distributions begin, and there is a designated beneficiary, the participant or beneficiary may elect on an individual basis whether the 5-year rule, as defined, or the life expectancy method, as defined, of the Plan apply. If there is no designated beneficiary as of the date of the participant's death who remains a beneficiary as of September 30 of the year immediately following the year of the participant's death, the participant's entire interest will be distributed by December 31 of the calendar year containing the fifth anniversary of the participant's death. If a participant is not married at the time of death, any death benefit payable will be paid in a lump sum as soon as administratively feasible following the participant's death; however, the death benefit may be payable in a different form if prescribed by the participant's beneficiary designation, or the beneficiary, before a lump sum payment of the benefit is made, elects to receive the distribution in an alternative form of benefit. If a participant terminates service, the entire vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant. A participant who terminates employment with a vested account balance of \$5,000 or less will receive an involuntary cash-out distribution, subject to automatic rollover provisions if above \$1,000. Subject to legal requirements, distribution from the Plan will be made to a terminated participant without the participant's consent, regardless of the value of such participant's vested account balance, upon the attainment of normal retirement age (65). The Plan allows for in-service distributions of a participant's vested account balance after a participant attains age 59½. A participant who is eligible for a hardship withdrawal may elect to withdraw all or a portion of his or her deferral account, safe harbor employer matching account, and QACA safe harbor employer matching account. A participant may receive a distribution from his or her rollover contribution account at any time. Distribution shall be made to an eligible participant from his or her vested account as soon as reasonably practicable following the date the participant's application for distribution is received by the Plan Administrator, but in no event later than the participant's attainment of age 73.

All distributions are subject to the applicable provisions of the Plan.

Investment Elections

Each participant shall direct the investment of his or her account and shall select among various pooled separate accounts. Each participant has the ability to change his or her investment allocations at any time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator and the Investment Committee determine the Plan's valuation policies utilizing information provided by investment advisers and John Hancock Life Insurance Company (U.S.A.) (John Hancock), the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus any accrued, but unpaid interest. Interest is recorded on the accrual basis. As of December 31, 2024 and 2023, accrued but unpaid interest has been deemed insignificant to the Plan. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, notes receivable from participants are reduced and a benefit payment is recorded within the statement of changes of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the applicable participant's account and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

The Plan discloses the fair value of investments in accordance with FASB ASC Topic No. 820, *Fair Value Measurements* (ASC 820). The framework under ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means; or
- if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts – Pooled separate accounts are valued at net asset value (NAV). The NAV, as provided by John Hancock, is used as a practical expedient to estimate fair value based on the fair value of the underlying investments. This practical expedient is not used when it is determined to be probable that the Plan will sell the applicable investment for an amount different than the reported NAV. Transactions of investments or withdrawals may occur on a daily basis and there are no redemption restrictions on these accounts. There were no unfunded commitments as of December 31, 2024 and 2023.

4. Information Prepared and Certified by Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment and notes receivable from participants activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Tax Status

The Plan uses prototype non-standardized plan documents, sponsored by the third-party administrator, Retirement Planning Consulting Group, LLC. The IRS has determined, by an opinion letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. During the year ended December 31, 2024, participants were fully vested in all contribution sources held by the Plan and therefore, the Plan was not analyzed for a potential partial plan termination.

7. Party-in-Interest Transactions

Certain investments of the Plan are units of pooled separate accounts managed by John Hancock or its affiliates and qualify as party-in-interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by balances in participant accounts and constitute party-in-interest transaction.

8. Risk and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events for potential disclosure or recognition through October 14, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the SECURE 2.0 Act expanded LTPT provisions to include employees who attained 500 or more hours of service in two consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. Further, participants from ages 60 to 63 will be allowed to contribute catch-up contributions equal to 150% of the standard limit.


