INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
TZVECL Management of CO 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the TZVECL Management of CO 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section –

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the TZVECL Management of CO 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the TZVECL Management of CO 401(k) Plan (the Plan” provides only general information. Participants should refer to the Plan document restated effective January 1, 2022 for more complete information.

General

The Plan is a defined contribution plan covering all eligible employees of TZVECL Management of CO, LLC (the Company) with Guideline, Inc. as the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, a rollover contribution of \$467,588 was initially deposited into this Plan due to an enrollment error and was subsequently transferred to an affiliated plan once identified. No participant losses resulted from this transfer.

Eligibility

Employees who are not covered by a collective bargaining agreement (union employees), leased employees and non-resident aliens are eligible to participate on the first pay period after or coincident with or following reaching the age of 18.

Participant Accounts

Separate accounts are maintained for each participant and are credited with contributions made from salary deduction arrangements, voluntary contributions, the Company’s contribution, and plan earnings and/or losses. Participants are fully vested at all times and such accrued benefits shall at times be non-forfeitable.

Contributions

Each year participants may contribute up to the maximum amount allowable by law of their pretax annual compensation as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Annually, the Company will make a discretionary profit sharing contribution and match participants’ contributions. The Company did not make any discretionary profit sharing or match contributions to the Plan during 2024. The Company’s contributions are discretionary and may be changed by management each year.

The Plan also permits participants to transfer account balances from other qualified retirement plans as rollover contributions.

Vesting

Participants are immediately vested in their voluntary contributions and all discretionary employer contributions plus actual earnings thereon.

Notes Receivable from Participants

Upon application by a participant of the Plan, the trustees of the Plan will authorize a note receivable from a participant’s account. Participant loans are valued at cost. All loans are limited to the lesser of 50% of the vested account balance, the employee contribution account, or \$50,000, minus the highest outstanding balance of loans in the past 12 months, with a minimum of \$1,000, and bear interest at a fixed rate per annum equivalent to the prime interest rate plus 1% at the time of the loan. The maximum number of loans any participant can have at one time is limited to one. Every loan is secured by the participant’s account. Principal and interest are paid ratably through regular payroll deductions. There were no loans outstanding at December 31, 2024.

Hardship Withdrawals

Certain in-service distributions are allowed under the Plan, including the withdrawal of all or any portion of a participant's elective deferral account and vested Company account in the event of a hardship, as defined. Such a withdrawal may not exceed the amount required to meet the immediate financial need created by the hardship and is only available after the participant has obtained all available distributions, other than hardship distributions, and non-taxable loans available under the Plan. A participant is suspended from making any deferrals under the Plan for six months after the receipt of the hardship distribution.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant is entitled to receive the value of his or her account in a lump sum distribution. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,162 and \$452. This account may be used to reduce employer contributions or pay Plan expenses. For the year ended December 31, 2024 no forfeitures were used to reduce employer contributions or pay Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses are determined based on fair market value at the beginning of the year plus additions during the year at cost. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net unrealized appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment advisor fees are indirectly paid by the participants through a reduction of the participants' annual rate of return.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855-10 establishes general standards of accounting and disclosure of events that occur after the statement of net assets available for benefits date but before the date the financial statements are available to be issued. Subsequent events have been evaluated through October 13, 2025, the date that the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Benefit Trust Company (the custodian of the Plan), a qualified institution.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Investment advisor fees paid by the Plan were included as a reduction of the return earned on each fund. Administrative expenses related to the administration of the Plan were paid by the Company. These transactions qualify as party-in-interest transactions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated September 26, 2024 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

During 2024, the Company erroneously failed to timely remit certain employee deferrals to the Plan aggregating \$87. The Company will compute the lost earnings on these deferrals and will make a contribution for lost earnings to the Plan.

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the TZVECL Management of CO 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section –

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the TZVECL Management of CO 401(k) Plan (the Plan” provides only general information. Participants should refer to the Plan document restated effective January 1, 2022 for more complete information.

General

The Plan is a defined contribution plan covering all eligible employees of TZVECL Management of CO, LLC (the Company) with Guideline, Inc. as the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, a rollover contribution of \$467,588 was initially deposited into this Plan due to an enrollment error and was subsequently transferred to an affiliated plan once identified. No participant losses resulted from this transfer.

Eligibility

Employees who are not covered by a collective bargaining agreement (union employees), leased employees and non-resident aliens are eligible to participate on the first pay period after or coincident with or following reaching the age of 18.

Participant Accounts

Separate accounts are maintained for each participant and are credited with contributions made from salary deduction arrangements, voluntary contributions, the Company’s contribution, and plan earnings and/or losses. Participants are fully vested at all times and such accrued benefits shall at times be non-forfeitable.

Contributions

Each year participants may contribute up to the maximum amount allowable by law of their pretax annual compensation as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Annually, the Company will make a discretionary profit sharing contribution and match participants’ contributions. The Company did not make any discretionary profit sharing or match contributions to the Plan during 2024. The Company’s contributions are discretionary and may be changed by management each year.

The Plan also permits participants to transfer account balances from other qualified retirement plans as rollover contributions.

Vesting

Participants are immediately vested in their voluntary contributions and all discretionary employer contributions plus actual earnings thereon.

Notes Receivable from Participants

Upon application by a participant of the Plan, the trustees of the Plan will authorize a note receivable from a participant’s account. Participant loans are valued at cost. All loans are limited to the lesser of 50% of the vested account balance, the employee contribution account, or \$50,000, minus the highest outstanding balance of loans in the past 12 months, with a minimum of \$1,000, and bear interest at a fixed rate per annum equivalent to the prime interest rate plus 1% at the time of the loan. The maximum number of loans any participant can have at one time is limited to one. Every loan is secured by the participant’s account. Principal and interest are paid ratably through regular payroll deductions. There were no loans outstanding at December 31, 2024.

Hardship Withdrawals

Certain in-service distributions are allowed under the Plan, including the withdrawal of all or any portion of a participant's elective deferral account and vested Company account in the event of a hardship, as defined. Such a withdrawal may not exceed the amount required to meet the immediate financial need created by the hardship and is only available after the participant has obtained all available distributions, other than hardship distributions, and non-taxable loans available under the Plan. A participant is suspended from making any deferrals under the Plan for six months after the receipt of the hardship distribution.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant is entitled to receive the value of his or her account in a lump sum distribution. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,162 and \$452. This account may be used to reduce employer contributions or pay Plan expenses. For the year ended December 31, 2024 no forfeitures were used to reduce employer contributions or pay Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses are determined based on fair market value at the beginning of the year plus additions during the year at cost. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net unrealized appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment advisor fees are indirectly paid by the participants through a reduction of the participants' annual rate of return.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855-10 establishes general standards of accounting and disclosure of events that occur after the statement of net assets available for benefits date but before the date the financial statements are available to be issued. Subsequent events have been evaluated through October 13, 2025, the date that the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Benefit Trust Company (the custodian of the Plan), a qualified institution.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Investment advisor fees paid by the Plan were included as a reduction of the return earned on each fund. Administrative expenses related to the administration of the Plan were paid by the Company. These transactions qualify as party-in-interest transactions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated September 26, 2024 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

During 2024, the Company erroneously failed to timely remit certain employee deferrals to the Plan aggregating \$87. The Company will compute the lost earnings on these deferrals and will make a contribution for lost earnings to the Plan.
