Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Motion Picture and Television Fund 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Motion Picture and Television Fund 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Motion Picture and Television Fund 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Motion Picture and Television Fund 403(b) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Motion Picture and Television Fund 403(b) Plan (the Plan) provides only general information. Plan participants and other interested parties should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all regularly scheduled employees of the Motion Picture and Television Fund (the Company). The Plan includes a deferred compensation arrangement as described in Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Charles Schwab Trust Bank (Schwab) is the Plan's custodian.

Plan administration – The assets of the Plan are held under a custodial agreement with Schwab. The custody agreement requires that Schwab holds, administers, and distributes the funds of the Plan pursuant to the custody agreement and in accordance with the provisions of the Plan. The Plan is administered by The Howard E. Nyhart Company, Inc. (Nyhart).

Eligibility – All employees are eligible to participate in the Plan for purposes of making salary deferral contributions to the Plan upon hire. Participants will become eligible for purposes of matching contributions and non-elective contributions on the date they first perform an hour of service as an eligible employee. Non-resident aliens are excluded from participation.

Contributions – Each year participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All eligible employees are automatically enrolled in the Plan at 3% of eligible compensation unless the participant elects otherwise.

The Plan provides an employer-matching contribution for all eligible employees. The Company will match 50% of an employee's contribution, up to 6% of the employee's eligible compensation. Contributions may not exceed the limits and maximum amounts deductible under the regulations of the IRC.

Participant accounts – Each participant's account is credited with the participant and employer contributions and an allocation of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately 100% vested in their contributions plus actual earnings thereon.

Participants vest in employer contributions based on the following years of service:

Investment options – Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan allows participants to direct their contributions and account balances among various investment options offered by the Plan through Schwab.

The Plan also offers a self-directed brokerage account option through Personal Choice Retirement Account (PCRA). The PCRA is designed for experienced investors who want more control over their investments. The PCRA investments include stocks, bonds, and a wider selection of mutual funds. Participants may invest in the PCRA by allocating contributions to the account as an investment option.

Administrative fee – Certain operating expenses may be paid by the Company or by the Plan at the Company's discretion and certain transactions are charged to the participants.

Payment of benefits – Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in his or her account. Upon financial hardship, a participant may receive all or a portion of the vested interest in his or her account, subject to certain restrictions. The Plan also permits death distributions to designated beneficiaries.

The Plan allows automatic rollover to an Individual Retirement Account (IRA) if the terminated participant's account balance exceeds \$1,000 but does not exceed \$5,000. Unless the terminated participant elects to roll over the account balance or to receive the distribution directly, the plan administrator can distribute the entire balance to an IRA designated by the plan administrator. Automatic distributions will be given to terminated participants with account balances of \$1,000 or less.

Withdrawals due to terminated participants are recorded on the date distributions are made. Benefits are recorded when paid.

Forfeited accounts – Forfeitures are created when participants terminate employment before being entitled to their full benefits under the Plan. The forfeited amounts may be used to restore forfeitures, reduce Company contributions, or reduce plan expenses. Forfeitures as of December 31, 2024 and 2023, were \$27,964 and \$8,390, respectively. No forfeitures were used for payment of administrative expenses or reducing Company contributions during the year ended December 31, 2024.

Basis of accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation and recognition – Investments are presented at fair value based on the quoted market prices of the underlying securities within each fund. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Other income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 (ASC 820) on fair value measurements established a hierarchy of ranking the quality and reliability of information used to determine fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; or inputs that are derived principally from or can be corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for the assets measured at fair value. There were no changes in the techniques used during the years ended December 31, 2024 and 2023.

Registered investment companies and money market accounts – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. Money market funds are managed to maintain a constant value of \$1 per share. Underlying investments are valued at amortized cost, which approximates fair value due to the short-term maturity of those investments.

The Plan also has a self-directed account option that allows participants to invest in all publicly traded stocks and mutual funds which are valued at quoted market prices at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Information Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab, the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments and cash reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Note 5 – Party-in-Interest Transactions

Certain plan investments are managed by Schwab. Schwab is the Plan's custodian; therefore, these transactions qualify as party-in-interest.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 – Tax Status

The plan document is a volume submitter plan that received a favorable opinion letter from the Internal Revenue Service on March 31, 2017, which stated that the Plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the advisory opinion, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC to maintain the tax exempt status for participants under Section 403(b).

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, including but not limited to changes in interest rates, market volatility, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of the investments, it is at least reasonably possible that values of investment securities could decline in the near term and that such declines could materially affect the amounts reported in the accompanying statements of net assets available for benefits and changes in net assets available for benefits.
