Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nebraska Medicine Retirement Plan-Base and Matching Contributions (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Nebraska Medicine Retirement Plan-Base and Matching Contributions (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined-contribution plan covering eligible employees of The Nebraska Medical Center (the Plan Sponsor). Employees of the Plan Sponsor become eligible to participate in the Plan upon completing one hour of service and must work at least 1,000 hours in the plan year and be employed on the last day of the year to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Retirement Committee (the Plan Administrator), which consists of certain officers and employees of the Plan Sponsor. Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the custodians and the record-keeper of the Plan (collectively, “Empower”).

Contributions

The Plan Sponsor contributes an amount equal to 75% of the amount deferred by the employee under a separate 403(b) benefit plan (Nebraska Medicine Retirement Plan – Employee Contributions). Participants receive employer contributions based on the following table:

The employer shall make an additional annual contribution for each eligible participant equal to 3% of the participant's eligible compensation (base contribution). For dual provider participants, the employer shall make annual contributions for each eligible participant equal to 9% of the participant's eligible compensation. Dual providers are defined as employees who 1) have earned one or more doctoral level degrees, 2) are performing billable clinical services for the Plan Sponsor, 3) are not in the personnel category of management or professional at the Plan Sponsor, and 4) are employed by the University of Nebraska Medical Center (or an affiliate thereof). Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a guaranteed investment contract, pooled separate accounts, and self-directed brokerage accounts as investment options for participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Contributions receivable are recorded as of period end for the amount of employer contributions due to participants as of the end of the period but which have not been deposited into the Plan.

Employee contributions are not allowed.

Participant Accounts

Each participant's account is credited with the Plan Sponsor's base and matching contribution and Plan earnings (losses) and charged with an allocation of administrative expenses. The Plan Sponsor's base contributions are allocated based on the eligible compensation of participants. The Plan Sponsor's matching contributions are based on years of service and on the elected salary deferral contribution of participants into the separate 403(b) plan (the Nebraska Medicine Retirement Plan-Employee Contributions). Plan earnings (losses) are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Empower.

Vesting

Vesting in the Plan Sponsor's discretionary matching contributions and base contributions credited to participant's accounts are based on years of continuous service. Employees are 20% vested after two years of credited service, and vesting increases 20% per year until an employee is 100% vested after six years of credited service. Dual providers are vested in the Plan based on their applicable date of hire. Dual providers hired prior to July 1, 2016 are grandfathered and immediately 100% vested. Dual providers hired after July 1, 2016 are 100% vested after three years of credited service.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive either a lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. Distribution payments between \$1,000 and \$5,000 are directly rolled over to an individual retirement account designated by the Plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefit payments are recorded when paid.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,350,820 and \$1,479,747, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. For the years ended December 31, 2024 and 2023, the Plan used \$1,481,026 and \$1,694,199, respectively, of forfeitures as a reduction of employer contributions receivable.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a guaranteed investment contract.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Other

Administrative expenses of the Plan are paid by either the Plan or the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 15, 2025, noting no items requiring disclosure.

3. Information Certified by Empower

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Empower, the custodian of the Plan (see Note 9), except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, except for applying the net asset value (NAV) practical expedient to 2024 and 2023 investment balances.

Mutual Funds: Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. Funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these accounts meet those requirements. Participants can redeem the accounts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

Self-Directed Brokerage Accounts: The self-directed brokerage accounts include investments in money market funds, mutual funds, and common stocks. The money market funds, mutual funds, and common stocks are valued at the closing price reported on the active market which the individual securities are traded.

Insurance Policies: Valued at the net cash surrender value, which approximates their fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive guaranteed investment contract (the Fund) with Empower, which is provided as a core investment option to the participants in the Plan. The Fund is an investment fund that invests primarily in corporate bonds, treasuries, commercial real estate mortgages, private securities, and short-term cash equivalents. The investment contract is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Crediting rates are a guaranteed rate determined every six months subject to a minimum crediting rate. For the years ending December 31, 2024 and 2023, the crediting rate was 2.70% and 2.55%, respectively.

6. Tax Status

The IRS has determined and informed the Plan Sponsor by letter dated September 22, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.

8. Related-Party Transactions

Certain Plan investments, including a pooled separate account, self-directed brokerage accounts, and a guaranteed investment contract, are managed by Empower. Empower is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.

9. Change in Custodian to Empower

During April 2022, Empower acquired certain Prudential entities who previously were the custodians and record-keeper of the Plan. In February 2024, Plan assets migrated from Prudential to Empower's record-keeping platform. The migration initiated a "black-out" period beginning January 31, 2024 and continued through February 6, 2024. During this period, funds could not be applied to the employee-selected funds with Empower or withdrawn from the Plan until the migration was complete. The Plan's investments options did not change during this period, however.
