SFCS Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SFCS Retirement Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (“Financial Statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“Investment Information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“Qualified Institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in the note titled “Information Prepared and Certified by Trustee” included in the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Responsibilities of Management for the Financial Statements

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of the SFCS (“Plan Sponsor”) Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan’s Board of Trustees oversees the governance of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

General

The Plan is a defined contribution plan that covers all full-time employees of the Plan Sponsor who have at least four months of service and are age twenty-one or older. Entry dates for new participants are on the first day of every month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participant: Upon completion of four months of service and being at least twenty-one years of age, employees are automatically enrolled in the Plan to make pre-tax contributions at 5% unless they change the percentage or affirmatively opt out. Plan participants can also elect to contribute up to 80% of their eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may designate their contributions as pre-tax deferrals or post-tax contributions. Contributions are based upon eligible compensation, which includes all compensation that is paid for or made available during the Plan year, excluding any compensation received (a) while being a member of an ineligible class of employees, (b) prior to the date of becoming a participant, and (c) various non-cash benefits and allowances outlined in the Plan document and adoption agreement. Contributions made by highly compensated employees may be restricted by limits set by law or by the Internal Revenue Service. Participants’ contributions are made through automatic payroll deductions every pay period. Pre-tax deferral contributions and related earnings are not taxable to the participant until they are withdrawn from the Plan. Post-tax contributions and related earnings are not taxed upon distribution from the Plan.

Plan sponsor: The Plan Sponsor may make annual discretionary matching contributions in an amount to be determined at Plan year end by the Plan Sponsor’s board of directors. These discretionary contributions will be allocated following the end of the Plan year to all participants eligible to share therein.

Rollover: Participants who were members of a former employer’s qualified plan may elect to make a rollover contribution from that plan to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings or losses. Additionally, administrative expenses for certain transactions are charged against participants’ accounts. Allocations are made based on participant earnings or account balances, as defined in the Plan document and adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

SFCS RETIREMENT SAVINGS PLAN

NOTES TO FINANCIAL STATEMENTS – (Continued)

1. DESCRIPTION OF PLAN – (Continued):

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of investment options.

Notes Receivable from Participants

Participants may borrow from their account up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The interest rate on the loan shall be a reasonable rate of interest based on the prevailing market rates. Principal and interest are paid ratably through regular payroll deductions. The notes are secured by the balance in the participant's account.

Vesting

Participants are immediately vested in their participant and rollover contributions. Vesting in the Plan sponsor's discretionary and matching contribution portions of their accounts plus actual earnings thereon is gradual based on years of continuous service. A participant is 100% vested after six years of service.

Forfeitures

Forfeitures from Plan sponsor matching contributions may be used to pay administrative expenses of the Plan or to fund Plan sponsor contributions. Forfeited non-vested accounts totaled \$20,525 and \$15,946 at December 31, 2024 and 2023, respectively. Forfeitures incurred during the year ended December 31, 2024 totaled \$59,155. During the year ended December 31, 2024, the Plan used \$36,632 and \$12,000 in forfeited amounts to fund Plan sponsor contributions and fees.

Payment of Benefits

The Plan is designed to provide participants with benefits at the time of retirement. However, if employment with the Plan sponsor is terminated, the balance of a participant's vested Plan accounts becomes distributable to them. Accounts with balances less than \$5,000 are required to be distributed to the participant in the form of a lump-sum cash payment, subject to tax withholding requirements. Alternatively, the participant may request a rollover distribution. For accounts above \$5,000, the participant may request a distribution or may remain in the Plan.

The normal retirement age for the Plan is 65. Participants may continue employment and participation in the Plan past the normal retirement age. Participants may take in-service distributions when they reach 59½ years of age and are fully vested or at normal retirement age regardless of vesting status.

If a participant dies before any or all their account balance has been distributed to them, their beneficiary will be entitled to receive all undistributed benefits. Participants automatically become 100% vested in their account balance upon their death.

Prior to terminating service or attaining normal retirement age, a participant under certain hardship conditions and with the approval of the Plan administrator, may elect to receive a distribution of their contributions and earnings thereon.

NOTES TO FINANCIAL STATEMENTS – (Continued)

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following accounting policies, which conform to accounting principles generally accepted in the United States of America (“U.S. GAAP”) have been used consistently in the preparation of the Plan’s financial statements.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to determine the fair value of investments. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants and Related Interest Income

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis on the face of the statements as interest income on notes receivable from participants. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred.

If a participant ceases to make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent notes receivable from participants remaining balance is recorded as benefits paid based on the terms of the Plan document.

Benefits Paid

Benefits are recorded when paid.

Administrative Expenses

Participant loan origination and annual loan maintenance fees are paid by the participant acquiring the loan. Investment expenses are included in net appreciation (depreciation) in fair value of investments. Any remaining expenses are paid by the Plan sponsor or paid with forfeitures from Plan sponsor matching contributions.

SFCS RETIREMENT SAVINGS PLAN

NOTES TO FINANCIAL STATEMENTS – (Continued)

3. FAIR VALUE MEASUREMENT:

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of their fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair value measurement accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are observable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs, because they generally provide the most reliable evidence of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies – Shares of registered investment companies are valued at quoted market prices on the last business day of the Plan year, which represent the fair value of shares held by the Plan.

Common Collective Trust – The Trustee manages the common collective trust, which is generally comprised of fixed income securities, benefit-responsive investment contracts issued by insurance companies, and money market funds. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it were probable that the Plan would sell the investments for different amounts. Participant transactions may occur daily. Plan sponsor-directed transactions could be subject to certain short-term restrictions, however the Plan’s current investment does not approach the limits for those restrictions. Additionally, the investments have no unfunded commitments as of both December 31, 2024 and 2023.

4. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Plan sponsor contributions.

5. INCOME TAX STATUS:

The Plan is an adoption of a prototype plan sponsored by the Trustee who received a favorable opinion letter from the IRS dated June 30, 2020. Although the Plan and adoption agreement have been amended since the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain income tax positions that more likely than not would not be sustained upon examination by the IRS. No such positions were identified as of both December 31, 2024 and 2023. The Plan is subject to routine audits by income tax authorities; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain administrative functions are performed by officers or employees of the Plan Sponsor. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Certain plan investments were managed by the recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
