To the Plan Administrator

December 31, 2024 and 2023

#### Note 1: Description of Plan

The following description of AW Industries Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by AW Industries, Inc. (the Company) as of September 1, 1985, and restated effective February 22, 2022, under a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Fidelity Management & Research Company. The Plan covers all employees of the Company, except leased employees, who have been employed three months. The Plan provides for employee voluntary contributions, employer matching and discretionary contributions, and participant-directed investments. The Plan qualifies under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible employees to contribute an amount not to exceed the lesser of 75% of their compensation or an amount which, when added to other additions (exclusive of earnings) to a participant's account in any Plan year, does not exceed the maximum limitation on annual additions to a participant's account under the applicable provision of the IRC. Participant contributions are made through payroll deductions. Each participant designates the percentage of his/her contributions which are to be invested in one or more fund options. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan provides for quarterly enrollment dates. The Plan has an automatic enrollment feature whereby an employee who meets the eligibility requirements of the Plan will have an initial percentage of their pay withheld, unless the employee elects to decline enrollment. Under the provisions of automatic enrollment an employee's contribution level will be 1% of salary. Participants may also contribute amounts representing distributions from other qualified plans.

Employer Contributions: The Plan provides for discretionary matching contributions on salary deferral contributions in an amount to be determined by the Company on an annual basis. The Company is generally not required to contribute to the Plan but may make discretionary matching and profit-sharing contributions based on the approval of the Company's board of directors. Company contributions are allocable to those participants who are employed on the last day of the Plan year or have terminated employment during the Plan year as a result of retirement, death or disability. For the years ended December 31, 2024 and 2023, the Company contributed \$215,047 and \$200,253, respectively.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of the Company contributions, Plan earnings and losses, and administrative expenses. Employer contributions are allocated to participants based on the participant's contributions for the year. Plan earnings and losses are allocated based on the account balances of the participants. Administrative expenses are allocated based on participant account balances or specific participant transactions. The benefit to which a participant is entitled is that which can be provided from the participant's vested account balance. All Plan assets as of December 31, 2024 and 2023, have been allocated to participant accounts, except for employer contributions receivable.

Vesting: Participants are immediately vested in all their contributions and investment earnings thereon. Participants are vested in employer contributions and investment earnings thereon based on years of service. A participant becomes 100% vested after six years of credited service. In the event of death, disability or retirement, a participant's interest is immediately fully vested in the employer contributions and related earnings under terms set forth in the Plan agreement.

**Note 1: Description of Plan (Continued)**

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest at prevailing rates for similar loans as determined by the Plan administrator. Repayments are generally made through payroll deductions. The Plan allows for a participant to have only one loan outstanding at any given time.

Payment of Benefits: Upon termination of employment due to death, disability or retirement, a participant will have Plan benefits to which he or she is entitled distributed as a lump-sum payment equal to the value of the participant's vested account balance or in installments over time. Distributions from a participant's account are generally required after the participant attains 73 years of age. In-service withdrawals of a participant's vested account balance are permitted after a participant has attained 59<sup>1/2</sup> years of age.

Forfeitures: The non-vested portion of a participant's account balance is generally forfeited upon termination of employment. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,075 and \$3,557, respectively. Forfeitures are generally utilized to reduce the Company contributions but can also be used to pay the Plan's administrative expenses.

**Note 2: Summary of Significant Accounting Policies**

The following is a description of the significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles (GAAP).

Use of Estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan committee is responsible for oversight of the Plan, determining appropriateness of the Plan's investment offerings and monitoring investment performance. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from participants are recorded in the period the employer withholds payroll deductions from Plan participants. Discretionary employer contributions from the employer are recorded in the period when the contribution is approved by the Company's management and collectability is reasonably assured.

The Plan has not established an allowance for credit losses at December 31, 2024 and 2023. Expected collection losses are determined from a review of historical collection experience, existing economic conditions and reasonable and supportable forecasts of future events affecting the Plan Sponsor. The Plan's fiduciaries believe the employer contributions receivable will be fully collected based on the ability of the Plan Sponsor to pay amounts when due.

Payment of Benefits: Benefits are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued. During the period from January 1, 2025 through October 14, 2025, the Plan did not have any material recognizable subsequent events.

**Note 3: Fair Value Measurements**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 3: Fair Value Measurements (Continued)**

Following is a description of the valuation methodologies used for Plan assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on quoted net asset values (NAV) of shares held by the Plan at year end. These funds are required to publish their daily NAV and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: Investments in common/collective trust are valued at net asset value, which is used as a practical expedient to estimate fair value. Net asset value is derived from the fair value of the underlying investments divided by the number of participation units outstanding. The fund objective is to seek safety of principal and consistency of returns while maintaining minimal volatility by utilizing a disciplined value investing process to build a high quality portfolio with broad diversification and an emphasis on risk management. The fund is redeemable on a daily basis without restriction, and there are no unfunded commitments or redemption notice periods related to the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities that are to be reported at fair value. The table below presents the assets measured at fair value on a recurring basis by level within the fair value hierarchy as of December 31, 2024 and 2023:

**Note 4: Information Certified by the Plan Custodian**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified by Fidelity Management Trust Company, the custodian of the Plan, except to compare such information to information included in the Plan's financial statements and supplemental schedule.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments in mutual funds, a common/collective trust, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the years ended December 31, 2024 and 2023, were derived from information certified as complete and accurate by the Plan's custodian.

**Note 5: Notes Receivable from Participants**

As of December 31, 2024 and 2023, 35 and 37 participants were, respectively, indebted to the Plan in each year in the total amount of \$185,788 and \$225,300, respectively, as the result of loans made to them by the Plan. The loans are evidenced by promissory notes bearing interest in the range of 5.25% - 10.50% per annum and are payable in installments, the latest of which is due in May 2029. The notes are fully secured by the participants' vested account balances.

**Note 6: Plan Termination**

The Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan, subject to applicable statutory provisions. In the event of termination, all Plan participants will become fully vested. The Company has not indicated any intention to terminate the Plan.

**Note 7: Parties-in-Interest**

The Plan offers various investment options, including investment products of Fidelity Investments, the recordkeeper of the Plan; therefore, these transactions qualify as party-in-interest transactions. In addition, certain officers and employees of the Plan's sponsor are administrators of the Plan and are participants in the Plan. During the years ended December 31, 2024 and 2023, the Plan paid administrative expenses of \$11,379 and \$4,350, respectively.

**Note 8: Administrative Expenses**

The Plan agreement provides that the Company, at its discretion, can agree to pay administrative expenses of the Plan. Expenses paid by the Company are excluded from these financial statements.

**Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 10: Income Tax Status**

The Internal Revenue Service (IRS) has ruled in a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA established by Fidelity Management & Research Company qualifies under applicable sections of the IRC. An employer who adopts this plan is generally considered to have a plan that is also qualified. The Plan administrator believes that the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. The Plan's federal tax returns are subject to examination by the IRS generally for a period of three years after the returns are filed.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Note 11: Reconciliation of Financial Statements to Form 5500**

The financial statements of the Plan for the years ended December 31, 2024 and 2023, did not differ from the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan).
