INDEPENDENT AUDITOR'S REPORT

To the Trustees, Plan Administrator and Participants of Genesco Sports Enterprises 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Genesco Sports Enterprises 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Genesco Sports Enterprises 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Genesco Sports Enterprises 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Genesco Sports Enterprises 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the Genesco Sports Enterprises 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Genesco Sports Enterprises, Inc. (the “Company”) and was established April 1, 2001, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

John Hancock Life Insurance Company (U.S.A.) (“John Hancock”) is the custodian of the Plan’s investment assets and executes investment transactions at the direction of Plan participants, receives contributions, investment income, pays administrative expenses, and makes distributions to participants. John Hancock Retirement Plan Services (the “Recordkeeper”) maintains participant account information. Through November 2024, the Plan used the services of Nova 401(k) Associates to perform annual compliance testing, prepare the Plan’s Form 5500, and assist the Plan administrator in day-to-day activities of the Plan. Effective November 2024, John Hancock performs these services. The rollover IRA custodian is NovaIRA, LLC. Merrill Lynch Wealth Management provides investment advisory services to the Plan and participants.

Basic clerical and enrollment functions of the Plan are performed by employees who are appointed by the board of directors of the Company. The Plan is administered by an individual from Company management (the “Plan Administrator”) which is appointed by the board of directors of the Company. Certain officers of the Company serve as trustees (the “Trustees”) of the Plan and are charged with oversight of the Trust fund. No owner or employee receives compensation for services.

Eligibility

All employees of the Company become eligible to participate in the Plan after reaching age 21 and three months of elapsed time service. Newly eligible employees may join the Plan on the first day of January, April, July, and October coinciding with or next following the satisfaction of eligibility requirements. The Plan excludes collectively bargained employees and employees who are nonresident aliens who receive no compensation from the Company which constitutes U.S. source income.

Contributions

Each year, participants may contribute to their combined pre-tax and/or Roth after-tax accounts up to 90% of their eligible compensation, as defined by the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. For the year ended December 31, 2024, the combined pre-tax deferral and Roth

contribution limit set by the Internal Revenue Service (the “IRS”) is \$23,000, and the catch-up contribution limit is \$7,500. Compensation earned prior to satisfying all eligibility requirements is excluded. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”), as defined.

The Company may contribute to the Plan, on behalf of each eligible participant, a discretionary matching contribution. For the year ended December 31, 2024, the Company elected to match 50% of employee deferrals up to 4% of a participant’s deferral determined on a payroll period basis. Discretionary profit-sharing amounts may be contributed as determined by the Company. The Company did not make a discretionary profit-sharing contribution for the 2024 plan year.

Contributions are subject to certain IRS limitations.

Investment Options

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The investment options include pooled separate accounts (through November 2024) and mutual funds (beginning in November 2024). If participants do not elect specific investments, their contributions are invested in the Plan’s qualified default investment alternative, a target date retirement series.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Company contribution portion of a participant’s account is based on years of continuous service as follows:

However, a participant becomes fully vested upon death or total and permanent disability.

Forfeited Accounts

Participants, whose employment terminates prior to being fully vested, forfeit the non-vested portions of their accounts. Forfeitures can be used either to pay the administrative expenses of the Plan or to reduce future Company contributions. As of December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$11, respectively. In 2024, Company contributions were reduced by \$29,555 from forfeited non-vested accounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan repayment period may not extend beyond five years, unless the loan is for the purchase of a principal residence for which the Plan Administrator may permit a longer repayment term. The Plan does not permit loan refinancing, and interest rates remain fixed throughout the duration of the loan. The loans are secured by the balance in the participant's account and bear interest at 2% over the prime rate.

No participant loans were outstanding as of December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

The normal retirement age is 65. The normal retirement date is the first day of the month coinciding with or next following the normal retirement age. On termination of service, death, or retirement, a participant may receive the value of the participant's vested interest in his or her account in cash only in a lump-sum amount, substantially equal installments, or partial withdrawals (\$1,000 minimum). Hardship distributions (as defined) are permitted from pre-tax elective deferral, Roth elective deferral, and rollover accounts. Upon attainment of age 59½, participants who have not separated from service and who have been a participant in the Plan for at least eight years may receive a distribution of all or any portion of his or her vested account balance, subject to certain account restrictions, including qualified distributions only from Roth elective deferral accounts. In-plan Roth rollover contributions are not permitted. Distributions under the CARES Act provisions are permitted.

The Plan provides for involuntary cash-outs if a terminated participant makes no affirmative election to receive or roll over his or her account balance of \$5,000 or less. Involuntary cash-out balances are automatically rolled over to an individual retirement account ("IRA") for the benefit of the participant.

Recent Legislative Changes to Plan Provisions

Changes to Plan provisions have been or may be made due to the enactment in recent years of various laws. Some of the changes are required by law and some become effective only if adopted by the Plan. Changes which may affect participants relate to required minimum distributions, disaster-related distributions, repayment of Coronavirus-related distributions, distribution of lifetime income investments, and participation of long-term, part-time employees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies employed in the preparation of the accompanying financial statements are as follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian, investment advisors, and Trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions and related earnings (losses) of \$10,088 and \$7,577, respectively, to the applicable participants prior to March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024, one benefit payment of \$102,992 was approved for payment and paid January 2025.

Administrative Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Recently Issued Accounting Pronouncements

Recently issued accounting standards that have been issued or proposed by the FASB or other standards-setting bodies which have not yet been adopted by the Plan are not expected to have a material impact on the Plan's financial position or results of activity.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - a. quoted prices for similar assets or liabilities in active markets;
 - b. quoted prices for identical or similar assets or liabilities in inactive markets;
 - c. inputs other than quoted prices that are observable for the asset or liability;
 - d. inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: A pooled fund invested in mutual funds or other marketable securities and is not registered with the Securities and Exchange Commission. The unit price generally will be different from the value of the underlying securities because the fund may also hold cash for liquidity purposes, and the fees imposed by the fund are deducted from the fund value rather than charged separately to investors. Pooled funds are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments.

4. CERTIFIED INVESTMENTS

Certain information related to cash, investments, and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash, investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and participant loan interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's asset custodian is John Hancock. Certain plan investments are units of pooled separate accounts managed by John Hancock. The Plan pays John Hancock contract administrator fees. These transactions are considered exempt under ERISA.

During 2024, the Plan made the following direct payments to related parties and parties-in-interest: \$25,807 to John Hancock for contract administration fees; \$1,275 to Nova 401(k) Associates for withdrawal fees paid from the accounts of specific participants; and \$23,024 to Merrill Lynch for investment advisory fees. These amounts are reported in the statement of changes in net assets available for benefits as administrative expenses.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer contribution accounts.

7. TAX STATUS

Effective November 22, 2024, the Plan is based on a non-standardized pre-approved profit sharing plan document developed for John Hancock Retirement Plan Services, LLC. The document received a favorable opinion letter from the IRS dated June 30, 2020, stating that the plan is acceptable under Section 401 of the Internal Revenue Code ("the Code"). Previously, the Plan was based on a non-standardized pre-approved profit sharing plan document developed for Nova 401(k) Associates, Inc.. The document received a favorable opinion letter from the IRS dated June 30, 2020, stating that the plan is acceptable under Section 401 of the Code. The Plan Administrator believes the Plan, as adopted and amended, is designed and is currently being operated in compliance with applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
